PUBLIC SPEAKS: Ruby Brogdon re: Someone keeps taking boards off boarded up house next door to her; Ida Ross Freeman re: Relaying that she would like to be a part of making changes in the City and hopeful that with the new Mayor these changes will come. Also advised of her remiss that the public was not permitted to be a part of the meeting Council had on Saturday; Patricia Kirk re: Reminding Council to pass the Tree Ordinance that the Law Department has been working on for over 2 years.
