1) Finance Committee

PUBLIC SPEAKS: John Swartz promoting cheerleaders for the city. Members of the Preservation Society talking about the homes that are going up and down in the city and the development of our city. He commended First Friday events and wants to let people know that there are wonderful things going on in our city not just corruption and destruction. He requests all people to become cheerleaders for Canton. Sylvia Allison from Grace Operation & Development Center association gathers people together and get them involved to help make Canton a better place to live and raise a family. The people in the neighborhood helped each other and organizations were involved when Nimisilla Creek flooded. She wants change in the community for crimes, jobs, fire stations and feels the parks are in despair and thinks that the Council Members should hear the people when they go out to vote. Patricia Howard from the Southwest Association of Neighbors, a group that has successfully closed down some nightclubs in the area that participated in bad conduct. They help to provide safety and added green areas to the southwest neighborhoods and are very excited about the new Federal Building and just hope that Building Code and the city have plans to continue to brighten up the surrounding area so that the agencies and people working at the new building will feel safe coming and going and have places to enjoy the City of Canton to create a positive note for all. Geraldine Allen of the Fairgrounds Residential Neighborhood Association thanked Sgt Fox for him explaining about how the people can help the police to do their jobs by getting accurate information to report. This group helped to get more patrol during the Ribs Burnoff event. They would like more information on Weed and Seed and think that bicycle patrol for police would make them more visible in the neighborhoods and reduce crime. Bev Jordan spoke as a representative for the City Folks for Cooks Pond and feels that NAVE should be a change agent for the people. She stated that the politicians should be hearing the groups and that support should go both ways more often than just at election time. Brenda Kimbrough from the

Cherry Ave Neighborhood Developmental Operations thanking all city officials for the clean up efforts and she is experiencing good things on her street. She gave thanks for First Friday activities and stated the good citizens of the city do enjoy these activities. Marci Zawacky of Harrison Hills Neighborhood Association thanking Charita Goshey for her article in the Repository regarding a "Grand Plan" for the city. She mentions that just because some of the industry is leaving we should not have a dismal city. She feels that as homes are demolished that the property should be divided between the adjoining property owners to make nicer lots and encourage more home buyers. Pat Kirk of the Downtown Central Neighborhood Association says her group has tried to come up with a plan for the city to help fight crimes and drugs while finding jobs. She thinks part of the problem is the neighbors not sharing the correct information with the police and wonders if there should be curfew for adults that are unruly not just teens. Ida Ross Freeman wants to see the city and the school board do more collaboration to benefit the children and would like to see more council and administration partnering with social services to help all constituents in need. Veronica Callahan as President of NAVE would like all Council Members and citizens of Canton to become mentors for the kids of our town. She thinks everyone should get behind the churches and the social services to help the people of the communities since we are all from different paths in life.

MISCELLANEOUS BUSINESS: Member Smith discussing the trick or treat event at the Southeast Community Center on Sunday, October 25, 2009 from 3 to 5 pm in conjunction with the Canton Negro Oldtimers Association. Anyone can set up their own candy booth and pass out to keep kids off the street and provide a safe place to gather treats. Member Griffin stating that the Canton Preservation Society is trying to gather and document the history of the quadrants of the city. They already have a library and librarian but could use help from anyone with knowledge. Member West stating that Member Griffin should get with Ken Ash regarding the area around Nimisilla Park because he knows all of the history of that section of town. President Schulman mentioning to all the NAVE sponsored candidates night on Monday, October 12, 2009 at 6:00 pm at the Canton Civic Center and stating that Council Members will be attending. Also thanked all members for coming tonight and voicing their concerns for the city. Mayor Healy thanking members of all neighborhood associations and NAVE for coming tonight and giving a "Hi Neighbor" to all. Thanks for sharing thoughts on what is going well and what is not so well. He is still available for neighborhood walk thru's and will continue to try to help with all issues that need addressed. He also mentioned that there is some partnering going on with the school board through the Community Development Department and on Wednesday evening there will be a college fair at the Civic Center announcing a further collaboration with the schools in our
