PUBLIC SPEAKS: Gary Bickel speaking on a neighboring home that is a rental property that is not maintained by the landlord and has large amounts of trash on the porch and throughout the yard from the renters that occupy the residence. Has contacted Code Enforcement, the Sanitation Dept, Health Dept, and Council Member Barton with concerns about the way this makes the entire neighborhood look. Wants to know if some type of standard of housing or living can be established in the city. Pastor Morgan inviting all to attend an Eve of Thanksgiving gathering at St. Paul's Episcopal Church on 11/25/09 at 7:30 p.m. Canton is one of the only cities creating a tradition of celebrating Thanksgiving as a non religious holiday just an American holiday.

MISCELLANEOUS BUSINESS: Member West asking that the Mayor provide all departments that receive in the public place a hand sanitizer to help prevent any further spreading of the flu. Member Smuckler requesting the Law Dept to set up a meeting to discuss the shortfalls of the Health Dept to finish out 2009. Member Barton thanking the Bickel's for coming down and discussing the problems of some of the landlords. He asked if Council has the right to revoke a certificate of occupancy from a landlord that is not maintaining their property and complying with code standards. Law Director Martuccio stating that any landlord licensing in an Ordinance must be worded very carefully to be able to correctly enforcement the issues. If a landlord has citations from Building Code or Health Dept these present better methods of enforcement. Member Cirelli asking for a possible time line on the professional landlord Ordinance because she has been discussing this since 2007. Director Ream met with Jason Reese and Angela Cavanaugh to discuss an International Property Maintenance Code that should be presented to Council very soon. President Schulman thanking Chief McKimm for follow up on neighborhood crime items that were discussed previously. Thanked Adam Herman for his addition of Council information to Canton Connection magazine. He talked about receiving the CCIC report but needing more information regarding how these grants are establishing jobs. Mayor Healy had asked that all Council Members review the report and get with him regarding any other information that they would like to see listed on the report. Member Casar stating that we are in tough economic times but that no Council Members should be sorry for the compensation they receive for serving the public in their positions. President Schulman also mentioning the number of hours put in as a Ward Council person and that hard work deserves a salary and benefits.
