1) Special Annexation Committee - 11<sup>th</sup> St Church of God

**MISCELLANEOUS BUSINESS:** Member Prater clarifying the Annexation Committee meeting for the 11<sup>th</sup> St Church of God because of some questions that they have had through the past three administrations and numerous Safety & Service Directors. Many Council Members and members of the current administration have seen the property and the meeting will be with Church officials to see what can be answered. Member Smuckler stating that he had been a part of this process with the Church since 2002 and thanked Member Prater for the explanation. Member Smith asking for prayers for a family in Ward 4 that had a deadly fire and lost one member earlier in the day. She also asked Deputy Director West about all of the vacant and abandon homes in the 4<sup>th</sup> Ward and throughout the city in regards to anything that could be done to help individuals with financing options since the banks are not loaning money to anyone at this time. Member Smith talking about a Stark State open house next Monday, February 8 at the Southeast Community Center and the new classes that will be held there. Deputy Director West letting Council Members know that the city can pursue land contract or leasing options for citizens to become new homeowners because HUD does not have restrictions on those financing types but that would need to be approved by Council to consider. Member Hawk states that any type of land contract or lease option of house financing must remain legal and all must be registered to

follow all procedures. Many people have been placed in bad deals in the past with loans that they are not qualified to have and may never be able to repay because of regulations not being followed. He let all persons know that Habitat for Humanity is still one of the better agencies to assist with financing for new homeowners and has the best percentage of repayment of home loans of all agencies that do that type of lending. Member West agrees that these financing possibilities need to be explored to help the citizens of the city but that any type of land contract does need to be registered with the County Recorder's office to even receive the tax credits that are being offered by the federal government as home buyers. Member Smuckler received a paper in the mail from a company that is willing to do a buy out of your mortgage and when he called the number, the person requested his Social Security number and bank account number to assist him in this matter. He stated these scams are what have the people so nervous about financing and mortgages in this time of crisis. Member Cirelli discussing Channels 11 and 15 that are broadcast from Timken High School and how the past Majority Leader had decided that the Council was not interested in assisting them with financial help to continue their broadcast. She stated that she had not been approached by the Leader and she was interested in helping the school and wanted to see if something could be done on their behalf to keep the channels on the air. Member Dougherty informing all that he has been contacted and will be holding discussions to pursue this issue.
