MISCELLANEOUS BUSINESS: Member West stating that a few weeks ago he spoke about the sky falling in Ward 2 and now there are more Police in the Gibbs School area which is a good thing but now the shootings are happening around Sandal PI NE so the gangs just appear to be moving around. He asked that some of the \$50,000.00 which is being allocated tonight for patrolling be used in the Northeast end. Member Prater thanking the Service Director for help in cleaning up some of the trash in Ward 5 but he has been told that the Sanitation Department is charging extra for larger loads and was wondering if people with smaller amounts of trash will be receiving a reduced invoice. Service Director Price was not aware of any price changes with large or small loads of garbage because the prices are set by Ordinance. He also discussed that he would like Council, the Administration, HUD, Community & Economic Development and Building Code staff to all be on the same page with the demolition process to get the most impact for our community. Member Cirelli apologized to the Mayor for not being able to attend the State of the City address but also mentioning that the gang bangers are still not in fear of the changes in policy. She was contacted by Channels 11 and 15 and they wanted to air the Mayor's speech but no one from his office had been in touch with the stations so he might want to consider that in the future. She expressed thanks to all for the numerous calls, emails, visits and prayers during her recent hospital stay. Mayor Healy welcomed Member Cirelli back and spoke of the job site ready programs at the Ford Plant and other locations. He was told last week of a grant from the Ohio Department of Development which awarded Canton with a half a million grant for job ready site and he was waiting to hear about more grants coming in. Law Director Martuccio explaining the demolition selection process. This must be done by due process of law and when a house is deemed structurally unsound, efforts must be made to contact the homeowner and allow them time to respond. The information about this house must be verified with the historic clearance office which also takes time so there are many legal guidelines that must be adhered to. Member Smuckler announced that the Fire Department retirement banquet would be held on May 20th for 8 retirees. This Saturday, May 8th, they will once again try to clean up at Nimisilla Park since the last two weeks there has been bad weather for this event. He thanked Tabitha Blackford for coming down because he knew that took a lot of courage to come before Council but knows that the Council Members and the Administration need to hear the message that is coming from the neighborhoods and it is past time to help the citizens be safe in their homes. Member Smuckler asked all Council Members to join him in support of a communication to move \$700,000.00 from an unappropriated fund to the safety forces and hire 8 additional Police Officers. Member Dougherty asking all Members to manage the meetings each week according to the Council Rules. He is pleased by the number of people that are coming to Council to speak but wants the meeting to stay on track and be fair and consistent to all.
