**PUBLIC SPEAKS (CITY BUSINESS)**: Vicki Mitchell is concerned with the difficulty of purchasing property on a lot beside her where a house has been demolished. She has contacted the county, the city and then the county again. She has maintained this area by cleaning it and mowing it since it has been vacant but can't seem to get any straight answers about a price or a procedure for acquiring the lot. Ms. Mitchell doesn't understand why the city doesn't want her money for the land and the county doesn't want the money from the increased property taxes. James Parker is upset by the proposed fee of \$250.00 per day for the itinerant retailers. He feels this is a violation of rights and stifles innovation. This is another form of taxation without representation and he really hopes that the people who pass out free meals on Sunday morning in the Kresge lot will be exempt from this law. Mr. Parker thinks that allowing all persons to participate and offer varieties will help to stimulate the economic recovery of the city. Dan Phillips was at Council to discuss the vendors license issue and fees back in 2006. He can't believe that 5 years later he is having this same discussion. The fee of \$250.00 per day is just impossible for most vendors because they don't usually make \$250.00 per day. Mr. Phillips has a mobile truck that he will keep in his own neighborhood and not charge \$7.00 to \$20.00 for lunch but he would like to know the SID boundaries so that he can stay out of them.

MISCELLANEOUS BUSINESS: Member West is encouraged by the number of people who spoke out about the traveling restaurants in the downtown area. He excluded himself from the vote because he occasionally comes downtown for special events as a vendor. Member Cirelli has had several people call her because they had tried to call the non-emergency phone number for the Police Department and it just rang and rang without an answer. One of them called 9-1-1 and was told there was a possible problem with AT & T. Could someone please check on this? She explained to President Schulman that his earlier comments about retailers being poachers offended her because her family used to sell fruit to make ends meet. She felt that he owed both the Honorable Body and the audience an apology. President Schulman stated that some of the vendors are looking for the best deal they can find and by coming into downtown they diminish the retailers that are committed to downtown. The business owners pay taxes, utilities and employee people on a regular basis not just for the day. There needs to be a fee for those that come in, get a bang for their buck, then leave. He never meant to offend her or anyone else but he feels it is important to support those that support the community. Member Cirelli asks Law Director Martuccio if there were any calculations provided to him to create this Ordinance. Law Director Martuccio states that there was not a mathematic analysis provided to come up with the figures for the fee amounts. Member Cirelli says some of these vendors are competing with restaurants in Belden Village area. She will also be looking up the number of restaurants that have come to the city for financial assistance then still gone out of business and left the city stuck with an unpaid loan. Member Smuckler, as the sponsor of the Ordinance, states it is not only about restaurants but any business that sets up to compete with other businesses but does not have any overhead or pay any taxes. The city cannot fund Police of Fire without any businesses paying taxes. We are opening up the door for anyone to set up shop wherever they want and this hurts the city. He will provide figures next week to discuss why these fees are essential to the city. Member Smith supports a young man that runs a T-shirt business and knows that he is not in a position to pay \$250.00 per day. She also wanted to apologize to Ms. Mitchell for all of the problems she has run into trying to purchase the property next to her. Member Cole feels this legislation if passed will outlaw any vendors coming into the city. He wants to review all figures to determine just where the amount for fees was decided upon. Member West asks the Law Director where we stand with the Tree Ordinance. Law Director Martuccio stated he was waiting on any other requests for amendments for the Tree Ordinance. Member West asked all Council Members to please get any requests regarding the Tree Ordinance to the Law Director so that this Ordinance can be completed. Member West also thanked Mr. Parker for coming and asked for an update on Jim Thorpe. Mayor Healy apologized to Vicki Mitchell for the city adding to her confusion. He feels that the city, county and state need to determine a simpler process for neighbors wishing to acquire property rather than leave the vacant lots unattended. Mayor Healy thanked Member Dougherty for another year of an outstanding Feed the Needy picnic. He attended the event and was again amazed by the number of citizens in attendance. Majority Leader Dougherty thanked the Mayor for his comments. This event was created by Council as a means to give back to the community. This was the 19<sup>th</sup> annual picnic. It takes the efforts of a lot of people to make this event happen. He expressed thanks to the Council office staff, Auditor's office, Law Department, Chief of Staff and his family and all others that participated. The day ran very smooth this year. There are many local businesses that help to make this a success such as WalMart who came out and did eye exams for anyone that wanted one, the Aultman WOW van, the city Health Department provides valuable information and the Health Commissioner was there for the entire day. Family Time Entertainment always donates their time for the day and assists in making the event a good time. Member Dougherty does appreciate the efforts by all.
