MISCELLANEOUS BUSINESS: Member Cirelli thanked the Safety Director and asked that he pass along to the Fire Chief her thanks that they got the correct 10 year lithium battery smoke detectors to pass out. When she became aware that they had more available she went to the Fire Station to get more to distribute and was able to enjoy a meal with the firefighters and was at the station to witness an alarm go off. She praised the firefighters for their professionalism and rapid response in this situation. The original grant for the smoke detectors was to provide these units for homeowners but Member Cirelli would now like to be able to provide these for renters also because all lives should be saved from fire. Since the city cannot guarantee that the landlords provide them in rental properties she feels that anyone should be able to obtain smoke detectors at city Fire Stations. Law Director Martuccio states that if the detectors are presented as a grant or a gift, the city can do anything that meets the minimum code requirements but Council would need to amend the Ordinance to mandate the higher level of detectors be the unit that was provided. Member Cirelli requests that an amendment be created to force this. Safety Director Ream says that landlords must have smoke detectors in every unit according to the IPMC but he will check the requirements for what level of units are required. Member Hawk thanked the Westbrook Park Neighborhood Association for their help in moving the art sculpture to 12th Street and invited all to view it. President Schulman wanted all persons who received the letter from "The Spirit" to know that he does not have a secret uzi and this type of literature just shows the 1st Amendment in action. While he is not bothered by the comments contained in the letter, he would like to know the true author. Member Hawk mentions that he has also seen the letter and feels the man or woman is a coward to not sign their name, after all, the forefathers signed their names to the Constitution that allows this person to state their opinion.
