OLD BUSINESS (PUBLIC SPEAKS): Reviewed Pending Issues from Public Speaks

PUBLIC SPEAKS (CITY BUSINESS): Toby Franks read a statement as a feral friend of AlleyCat Allies. The Humane Society does not keep records of the number of animals delivered to them by the Animal Control officer but Mr. Sedlacko's records indicate that 399 cats or kitten were captured in 2011. AlleyCat Allies believes that most of the cats were put to sleep and they are asking Council to suspend the contract with him. Jill Kirsch is from Cripple Creek Ferals & Friends which was started in 2011. She feels that for \$22,000.00 the same number of animals could have been captured, neutered and returned which is less than Mr. Sedlacko's salary. They run a successful program and the cats no longer cause problems in the neighborhoods they service. Their organization is run strictly on donations. Marcia Zawacky informs Councils that the ASPCA provides a lot of information on Google and includes a list of many of the organizations that they work with. She would like Council to do more research on the Trap, Neuter, Release programs. Mrs. Zawacky feels that society is taught to kill to solve a problem. Joy Wagner is the President of Peace for Cats, a non-profit organization that works toward a less costly method of controlling the feral cat population in a city. She is concerned that when Phil leaves out traps they are not tended to overnight and animals can be captured without food and left to the elements of weather. Ms. Wagner is also asking about the other wildlife that gets trapped. Are they killed, released, turned into an agency. Does anyone know that answer? She also is asking for Council to get an education on the alternative choices such as TNR. Marty Weisel is a board member for the Coalition for Animal Concerns and she works with an organization in Akron since Canton does not have a facility that participates in the neuter and spay programs. She would like to see a better use of taxpayers money by using the many willing volunteers to self trap because many cats are outdoors but are still pets. Ms. Weisel requests that the Animal Control officer be monitored and required to meet certain standards. Mackenzie Quartz is an 11 year old, 5th grader that feels some of the laws are unfair for animals. She has been a volunteer for a few years and says just because they can't talk doesn't mean that they don't have feelings so we need to be their voice. Dana Ray is from the People Care Pet Pantry which tries to help owners feed and care for all animals. She works with an organization that will spay a cat for \$25.00 just by walking in. She also feels that the city should strongly enforce the TNR program. Wayne Jamerson upset because the city placed a sticker on his vehicle last week for being parked in the grass. He has seen other cars sitting on grass, concrete, etc. and can't figure out why the city wants to bother people that are just trying to do the right thing. James Parker asking Council why they gave Resolutions to the outgoing Members at the end of the term and did not recognize Mayor Healy. He wanted to publicly honor all of Team Healy for their efforts and for making time to listen to him. Patricia Kirk has worked for the last six years on the Tree Ordinance and she wanted to remind all that while no preparation has been done so far, the Tree Academy classes will be held here in Canton beginning in March. She provided applications for the Mayor and Safety Director.
