He also thanked Member West for the naming of the Kresge lot and feels that whatever the new name is this space should be better maintained and given some attention. Jaime Jaime thanked all Members for the previous help with the deaf community issues. They have established a group now named Triad and hope to keep services here in Canton since Trillium will no longer provide them. Nicole Kelly thanked all and said that Triad will be trying to get back the contract for services and education of the deaf community. Jack Hawk thanked Member West and others for connecting them with Coming Together. There are only 2 weeks left to complete the RFP and he asks that both Council and the Mayor endorse Triad. He would like Canton to adopt a procedure to provide interpreters when needed for Council and other meetings, for first responders and any other services associated with the city to help the deaf and hearing impaired in the community. Triad now has an office with the support of Coming Together and a local hospital.

MISCELLANEOUS BUSINESS: Member Hawk reading a piece of literature that was left for all about water and drilling back in 1955 and the property mentioned is what is now the Sugarcreek Water Shed. Member Fisher thanked all 19 speakers especially Mr. Coleridge. He had originally heard him speak last year and feels he has a wealth of knowledge on many subjects. He has heard the peoples concerns about fracking and he will be voting no on the issue. Member Cirelli appreciates the gentleman that read the Resolution regarding the moratorium. She has attended several meetings and has only heard bad things all of which are now coming true. Water is the only thing that we can never make. She asks about the status of the Water Commission and states she will always be against hydrofracking. She requested that the downtown green space which is now the brown space be watered because it will always be the Kresge lot to her. Member Cirelli asks the Mayor if Canton is selling water to companies that are now fracking. Mayor Healy says that the Water Department has patched so many cracks in the system that they are saving up to 5 million gallons that was previously leaking in to the earth and that one or two wells may have been drilled with water from Canton aquifers. Member Cirelli points out about the Kresge information that was provided to all tonight shows just how important the Kresge name and family are as they still provide grants for the arts so she feels the renaming of this lot on July 4th may be harmful to Canton. Member West says yes the new name will be announced on July 4th and he will be applying

for some of the grants available to city from the Kresge family. Member Cirelli would like something done about all of the anitsemitic literature that has been received by several Council Members both at the office and at their homes. She thinks that most people are aware of who is sending this and they should be stopped. Member West announced the July 10th kick off of the Downtown Walk of Fame to promote walking and healthy lifestyles. He asks all Members and the community to come to the square at noon that day. He thanked Ed Balint and The Repository for the article on the contest of renaming the lot at 300 Market Avenue North. Over 300 names were submitted in an effort to ignite downtown and have fun with this. The Committee will continue to work on the block moving forward regardless of the name because all of downtown needs work. He also asked the Mayor why he would be denied \$700.00 worth of supplies for a summer youth program at Nimisilla Park from the Recreation Board. He was just looking for some basketballs, art and craft supplies, etc and was told this could not happen. Mayor Healy says the Rec Board is funded by a levy and is independent from both the administration and Council. Member Hawk announced an Annexation Committee meeting on July 16th at 6:00 P.M. Mayor Healy states that the city will receive a COPS grant in the amount of \$821,000.00. This is a grant that he thought we would not be receiving. There are a few stipulations in this grant that were not previously including relating to how the money is used for veterans and it will also now be spaced over a three year period. He also attended a Team NEO conference and Canton received an award for promoting new business. VXI Global has hired over 800 employees in there first year and is the largest new business in Ohio. President Schulman says the leasing of mineral rights will be discussed at the next meeting and the Water Commission report will be available soon. This is a very difficult issue and the balance of jobs vs the resources of water is something that must be thought through by all. The Service Director and the Water Superintendent should share their concerns about the aquifers and the water that gets flushed into the ground during the fracking process. Member West congratulates the Mayor and he went over to VXI Global last week and seen some people from Ward 2 employed there. Member Dougherty asked that the Mayor look real close at the COPS grant and how the dollars can be used towards veterans. He wonders if this money could be used for existing veterans on the police force and not only for new hires into the department. Mayor Healy says that this is for the department and not just new hires but civil services rules will also be in effect. Safety Director Ream will be working with the agency providing the grant because they have permitted exceptions in the past. Member Dougherty informs all that the Committee created for the naming of the Kresge lot will be kept intact to take this location to the next level. They would like to see about having a stage put there, adding a sprinkler system and placing a flag pole on the property. This area needs to be maintained in a much better
