PUBLIC SPEAKS (CITY BUSINESS): Pat Kirk would like to see the word permit substituted for the word license throughout the Tree Commission Ordinance. She does not feel that the city should be issuing a license because the companies should be previously licensed before trying to get on the contractor listing. Pete DiGiacomo has heard that there are some people that are being monitored or helped to prepare for the Civil Service test and will receive an additional 20 points for this monitoring program. He thanked Members Smith and West for an excellent Town Hall meeting on Saturday. There were a few men in attendance that were trying to speak to the younger men there about their life experience and trying to steer them away from being in a gang and to stop the shooting. If the city can help these men to help the younger men please do it. Mr. DiGiacomo also stated that someone has made a mistake when redoing Walnut Avenue and it is against the law to ride a bicycle into oncoming traffic. Bruce Nordman wants to thank all Members for passing the Resolution that if the Park levy passes, any additional money generated would go to the safety forces. On 9/9/13 Group 175 will announce the plan and mission they have to bring up the staff levels of Police and Fire. Bruce Brewer is speaking tonight as part of the Vassar Park Neighborhood Association. He is aware that the city is having meetings with the owner of Ridgewood Castle and feels that he and members of the Neighborhood Association should be in attendance at these meetings so that they are a part of the issues that are discussed and the time frame that the owner has to complete any changes. John Contrucci has a rental property by him with trees that are almost on to the roof of his house. He considered calling the owner but doesn't want to have a verbal battle and not accomplish anything. He just was unsure of who to contact or if he needed a lawyer. Phyllis Bond thanked Member West for coming to her neighborhood in the area of 16th and Struble NE but unfortunately the problems still continue. There is one house that is creating problems for the entire block. On Sunday night, there was another shooting and both cars and houses were hit. There are under age kids with guns that are drinking, screaming, swearing and parking all over the place. When the police are called, they cannot even get down the road with the vehicles from this house blocking everything off. She would like to start some type of organization to provide suggestions on how they can stop one house from causing so many difficulties for the local residents. Henry Preston thanked Members West and Smith on an outstanding Town Hall meeting on Saturday. He stated that during the last Council Meeting while Majority Leader Dougherty was the acting President, his behavior was unacceptable...
