**MISCELLANEOUS BUSINESS:** Member Hart is still finding a lot of potholes throughout the city. Does the Street Department have a method to identifying these and then issuing the work orders to get them filled? Service Director Bartos says that they are waiting on the hot mix of asphalt to continuing patching. Central Allied made hot mix for about 4 hours today and then went back to the cold mix. By the end of the week they should be producing hot mix regularly and the crews will be again working on Saturday if this is available. This is the peak of the pothole season and they are working diligently to try and keep up with all of the potholes in every Ward. Mayor Healy congratulated Member Mack on being one of the "20 under 40" recipients. He stated that tomorrow is the State of the City address and they will be swearing in the new class of Police and Fire. They now have a process to increase staff on both forces to cover for the retirees. This year they will hire a significant number to cover the offset. The Police and Fire Departments don't share with the administration when they have people that will be retiring but there is anticipation that there will be 3 to 5 retirees in each department. Member West asks why these departments do not have to communicate their intentions. Law Director Martuccio says because of the DROP program these people can retire with no change in benefits. These people can go into a retirement phase for 3 to 8 years with their pensions going into an annuities so many take advantage of this prpgram.
