OLD BUSINESS (PUBLIC SPEAKS): Reviewed Pending Issues from Public Speaks

PUBLIC SPEAKS (CITY BUSINESS): Jason Scaglione stated there has been a good job with getting so much stuff off the streets but there was another drug death at the Factory of Terror. He read another letter that he sent to the State Legislators requesting monies to have dedicated police officers to Ward 3 and other Wards so that they would be more effective and have a better relationship with the citizens of that community. He has received a response that the Safe Neighborhood Initiative has some funds available so he will provide the Safety Director the contact information to reach out for these funds. Health Commissioner Jim Adams briefed all on the Health Departments efforts regarding Ebola. The Health Department, area hospitals, EMS and other first responders are all in close contact and watching all the alerts to keep on top of the situation. It is best to fight fear with facts. He encourages all to get their flu shot as this is also the beginning of flu season. Charles Killens asked all Council Members to please tell the truth if you are called as a witness because he has provided the information regarding his home to the federal court. James Parker says there is some type of noise pollution downtown which sounds like a bad bearing on one of the buildings. He asks why all are so afraid of Ebola when rabies is 90% fatal and 20% of teenagers would test positive for a type of meningitis and no one mentions this. He recommended taking vitamins C and K to help with your immune system. Henry Preston had a piece of asphalt crumbling on his street. He called the Street Department and they came out, inspected it and repaired it. He is very pleased. He feels all Council Members need to stay on top of things in their Wards. Dan Moeglin received a letter today that from the Ohio Department of Natural Resources stating that the city was awarded \$500,000.00. This will be part of National Bike Route 40. Bike Trails have been shown to increase property values. This will run down Cleveland Avenue and around the Malone University area.

MISCELLANEOUS BUSINESS: Law Director Martuccio appreciated Jim Adams remembering all of the information regarding Mr. Killens home. While Mr. Killens has visited the Law Department a few times in the last couple of years, none of the paperwork that he has brought in is current. Mr. Martuccio will be happy to look into things and respond if he receives any current papers on this matter. Jim Adams spoke about a home of William McKinley's that was relocated in the 1930's and was later demolished because it was not being kept up to code. Any home can fall into this problem. Mayor Healy attended the first event held at the Onesto Hotel on Saturday. The ballroom was opened and there were 100's of people there. It was just beautiful. He thanked all Council Members for being on board with this project because it is a huge positive for the city. He also attended church with Chris Smith on Sunday morning and then celebrated Sunday evening with Brother Dave at Trinity Gospel Church. He has been the Pastor of Trinity Church for 50 years. There were thousands of people there to join in this celebration. Member Smuckler says for over a decade he has been a part of Canton's slime with letters being delivered to City Hall and his home labeled as "Kill Jews". He is embarrassed that the city knows who this is and they live in this community. This has gone beyond any First Amendments rights. The person sending them is a coward that will not come to Council or sign these letters. Member Smuckler asks Law Director Martuccio to go to the Northeastern Ohio Attorney General and get a written response as to whether this qualifies as a hate crime. He feels it is unfair for him and others, along with their families to go through this. Member Dougherty agrees that it is time for a written response to this matter. Member West applauds Member Smuckler for stepping up in this matter. He also has received this information and is requesting that the sender stop sending any form of communication in the form of a letter, email, etc. as he does not want to hear this hateful and hurtful talk. Member Hart asks if Ebola puts the city of Canton at a risk of loss since it could be very expensive if personnel has several days off. He asks what if any, the financial liability would be to the city. Law Director Martuccio thanked Commissioner Adams for continuing to keep everyone aware of the Ebola updates. If any employee contracts anything while on the clock is covered by Workers' Compensation. If it would be any other time, it would be covered by insurance. He also stated that he would follow up on Bill's request.
