### OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Jonathan Bailey spoke about the high price of vendor licenses. He lost 2 potential jobs doing ads, sales platforms, selling and advertising T-shirts because the clients thought the vendor fees were too high. He's going to do some research on the price of vendor licenses in the surrounding areas. He believes Canton has too many restrictions. Bruce Nordman believes that renters need a "bill of rights". He said that landlords are organized but there's no one to help the renters with their issues. They need to know which offices to call. He also believes there should be a nuisance inspector to do the leg work to catch all violations. John Laughlin said that the complaint driven inspections are useless because they only affect the exterior of a property. The only way that the interior is inspected is if the renter complains. He believes the renters won't complain because they're afraid of the retaliation by the landlords. He thinks that landlords who abide by the rules and laws should be rewarded some type of way. He suggested that if they pass their yearly inspections, they should be allowed to skip the next inspection. He thinks Canton needs to pass better laws.

MISCELLANEOUS BUSINESS: President Schulman commended Council Members that attended the meeting regarding landlord issues. He said that tenants deserve safe, livable housing and that landlords shouldn't be able to hide from the law we adopt. Member Smuckler stated that Public Speaks is where people come to vent at City Council for work that doesn't get done. He said there is allegedly 3 branches of government, but that the Judiciary branch trumps all. He saw something tonight at Council that he hadn't seen in 26 years. He thanked and commended the Law Dept. A gentleman was removed from the meeting and will be going to court. He was a bad landlord. Some landlords are bad and some are good. We know who they are, the problem was just getting someone to act. He agrees with the speaker who thought there should be a tenant's bill of rights. He commented that his relative was a bad landlord and now his house is up for sale. He also quoted Art Cirelli by saying that "the longer I stay here, the more enemies I will make". Member Morris echoed the congratulations to the Law Dept. but said we shouldn't get too happy. He also said that this Council does realize that there are 3 equal branches of government. He said that we are taking back the City and taking it into the right direction. He also informed the speaker that the "Bill of Rights" has been sponsored by Member West, Member Smith, and himself and is currently in the Law Dept. Member Hart spoke about the water leak on 12<sup>th</sup> Street, between McGregor and Fulton Rd. He said it was not at a lateral, but in the middle of the street. He wants to be sure that this is fixed before the work is completed so that we don't have to go back in. With regards to the landlord/tenant conversation, he thinks that we should be fair and equitable to everyone. With a rate increase, he knows that will be passed on to the tenants. Member Smith thanks Safety Director Perry for her quick actions tonight. Member Hawk congratulated everyone for the arrest of the landlord. He also thinks that people should be cited for high grass and weeds. He said that over \$250,000.00 each year is spent on cutting grass in the City. He believes these people should also be arrested.
