MISCELLANEOUS BUSINESS: Member Smuckler commended Members Mariol and Mack for helping to make Market Square a reality. He said it was rare that people show up to give the city a check for \$200,000.00. He heard from friends that there was no way that \$1.00 would be raised. He thinks Members Mariol and Mack should submit a Resolution naming some part of Market Square on behalf of the Rotary. Deputy Mayor Williams told Member Morris that he would like to ask Council, publicly, if he could submit legislation next week, to be voted upon, to actually accept the \$100,000.00 donation. They must do that legally to accept the donation. He would like to pass it on first reading. Member Hart thinks Member Mariol and Member Mack did a wonderful thing. He thinks it's great that people have a sense of community and respond to it whether they live in that particular community or not. He commended Member Dougherty for the Feed the Needy, President Schulman for giving to the Stark County Hunger Task Force, and he also mentioned how people came together to give \$300,000.00 to construct a handicapped ramp at Lathrop School when he taught there. He thinks this is what makes Canton and Stark County a great place to live because we have people who are willing to give. Member Hawk also commended Member Mariol and Mack for their diligence and hard work on the Market Square Project. They understand that it's going to be the life blood of the community when downtown is hooked up with the Hall of Fame and working in conjunction with them. They worked hard to get the donations. We are going to have a chance to make our city grow and expand. Member Mariol said that his generation is definitely moving back to the urban areas, wanting to live downtown. One thing that made him want to get on Council was that he saw some exciting things happening downtown. He commended Member West for fighting for downtown and getting people invested in downtown. He thinks the things that Member West has done has put downtown Canton on the same level as downtown Akron and Cleveland. He also commended the Administration. He also addressed Mr. Preston regarding the comments he made on Logan. He said that around the park on Logan, they're doing a dig out. The Street Superintendent Rorar has identified a base issue. Rather than just putting asphalt down, they are bringing up the road in the area. They're rebuilding the base and asphalting over it. It's taking a long time because Supt. Rorar is doing dig outs on a lot of roads throughout the city. When other high-traffic dig outs arise, he has to pull workers from the Logan area, which is a low traveled road, leading specifically to the park and send them to the other areas. Supt. Rorar is trying to permanently fix all of these roads. With regards to the chip and seal on Logan, it was done properly. When they sprayed the asphalt before they laid the top part, it probably got to the grass and that may be why Mr. Preston is seeing grass come up. He's certain that it was done properly.
