PUBLIC SPEAKS (CITY BUSINESS): Eugene A. Blakely, who works with the American Red Cross, spoke about maintaining smoke detectors. They usually only last about 10 years. After 10 years, the horn may work on them but the sensors don't. He passed out flyers with information about smoke detectors. He announced that he had a sign up sheet for free smoke detectors which would be given out in the Newton Zone on Thursday, November 26<sup>th</sup>. Patricia Kirk, President of Downtown Central Neighborhood Association, spoke about her concern for the Kresge Lot on Market Avenue. Her neighborhood association and the Can Do Association voluntarily adopted the lot through the City's Adopt-a-Sight Agreement in 2008. She would like the lot to be maintained as a greenspace because it meets the economic development of the City. Brenda Kimbrough also spoke about maintaining the greenspace on the Kresge Lot. She wanted Council to know that nature has a space and a place and that they should keep the area green and clean.

## **ANNOUNCEMENT OF COMMITTEE MEETINGS:**

MISCELLANEOUS BUSINESS: Member Hart told Deputy Mayor Williams that on Route 62, as you head up Route 77 South, there is a dead deer that has been there for quite a while. It's on the exit leading to the Hall of Fame. He noticed another two dead does while heading North, between the Tuscarawas and Route 62 exit. He wanted to know if it was the City's responsibility for cleaning that up or ODOT. Deputy Mayor Williams said he didn't know but he would find out. Member Griffin said there will be a special meeting of the Canton Board of Park Commissioners and the Canton Joint Recreation Department on Wednesday, December 2 at 5:30 p.m. to discuss the future of the proposed departmental merge and corresponding ballot issues. The meeting will be held in Council Chambers. Member West thanked Mr. Blakely for coming down and educating Council on smoke detectors. He also spoke to Ms. Kirk and Ms. Kimbrough and said that he will continue to fight for some greenspace at Market Square. Law Director Martuccio thanked Council for passing the Amendment to the Informal Resolution. This will give flexibility to ask the County Auditor to provide to valuations, 4 Mills and 5 Mills, because the Commission and the Joint Recreation Board are formulating alternative strategies. By the time there is a 3<sup>rd</sup> Reading, Council will know precisely where we're headed in terms of the Park Levy. He also thanked Member Hart for the Invocation prayer, he thought it summed him up. Law Director Martuccio then announced to various members in the Council Horseshoe that there would be a motion to go into Executive Session for the Claims Committee to discuss a pending claim again the city. Service Director Bartos said he attended a District 19 Public Works Integrating Committee meeting. He, Dan Moeglin and Tyler Converse received a recommendation of the Committee that the City of Canton should receive nearly \$7 million dollars in funds for various projects. He also thanked Dan Moeglin, who was responsible for \$6 million dollars of the funding. Although they're just recommendations, they usually hold and are solid. There will be matching funds for many of the projects and they will also have to look at Capital Funding and find creative ways to use it for the next couple of years. He also thanks Tyler Converse who was responsible for the Avondale Water Line Project Grant. The Grants would be received July 1, 2016.
