OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Marlene Chipko made a plea for help on behalf of Police Dispatch for relief from the overtime hours. She mentioned how the Repository came out about the high rate of pay, but didn't bother to address the long hours and decrease in staff. Last year alone dispatch handled approximately 100,000 calls for service and between 200,000 and 300,00 phone calls. Dispatchers must complete 18 weeks of intense training and endure a high level of stress on the job. She asked Council to give them the people they need and a schedule that makes sense, and the overtime problem will be solved. Patricia Kirk spoke about the open container application currently before Council. She feels it does not enhance the safety of the community. She asked Council to consider what's good for those who live here. She mentioned working with Law Director Martuccio and how the Tree Commission has proven to reduce crime, yet they have no funding. Brenda Kimbrough also spoke about the open container application. She is concerned about the example this will give to our children. While it may bring money to the city, the citizens will have to clean up afterwards. She feels people must be careful where they walk and what they touch. Her main concern are the children's groups. James Parker spoke against the transfer of a liquor license for the Hall of Fame Mart on Sherrick Road and Cherry Avenue SE. He stressed the need to clean up this area because it is not safe. He gave the example of Arthur Tyson who was the victim of an attack in that area, and urged Council to address the security concerns at the Hall of Fame Mart. He would also like to see better playgrounds and conditions for children to play. He demanded an executive order from either President Schulman or Majority Leader Morris that the Councilat-Large and Member Smith work on solutions to improve the safety conditions in this area. He concluded by saying that he has been working on this since 2011 and demands results, not excuses. Shirene Tapyrik spoke about the B-First Project she previously presented to Council which houses ten homeless families. She worked diligently on getting funding, and feels it has changed lives. She was recently invited to a neighborhood meeting in the Linwood Ave SW area where a new council member was also present. At this meeting she was ridiculed, mocked and mistreated. Upon leaving she was presented with a piece of paper which read, "welcome to the white citizens council," and was escorted out. She feels new council members should receive leadership training.
