MISCELLANEOUS BUSINESS: Law Director Martuccio announced that Lois DiGiacomo of Coming Together Stark County will be inviting Council to another event soon. He stated that there have been two convictions in Canton Municipal Court for failure to comply with requested repairs. Two people were found guilty and sentenced to community service, fines and suspended sentences provided they make the necessary repairs.
