PUBLIC SPEAKS (CITY BUSINESS): Jonathan Bailey questioned the amount being spent to keep the grass cut in the city. He urged Council and the Administration to try something different...perhaps using goats. He believes it will be cheaper and it will make people start cutting grass due to the embarrassment. Heath Dept. Supt. Jim Adams thanked Council Members individually for their support and Council-As-A-Whole for entrusting his department to spend appropriated funds wisely. He also thanked the community for their support. Supt. Adams listed 3 things that the Health Dept. plans to do in 2017: 1) Apply for Public Health Accreditation; 2) Continue operating in a lean and mean fashion; and 3) Expand their reach in the community. Pete DiGiacomo complimented the kids who skateboard at the 9th & Schroyer skate park for keeping it nice and clean. Henry Preston apologized to Members Morris and Fisher for what may have seemed like a complaint at the last council meeting. He believed Member Morris was disrespected by not getting a chance to discuss his amendment on the ordinance for giving monies to the Chamber of Commerce. He was happy Members Morris and Fisher voted against giving the money to the Chamber. He gave Member Morris credit for bringing the Shot Spotter program to the city, and mentioned that he's had to call police 3 times and each time they responded. He thinks the Police Dept. deserve the funding instead of the Chamber.
