PUBLIC SPEAKS (CITY BUSINESS): Pete DiGiacomo asked Council to put good thought into the AirBNB Ordinance and vote no. He stated that getting paid for grass cutting and tearing down vacant homes owned by people living out of town is already a problem, and this is much more involved. There are still flaws and cracks and if any of those happen, it can cause bad publicity for Hall of Fame week or the Firestone Open. Jonathan Lalewicz is concerned that the AirBNB's add another avenue to introduce rental units into neighborhoods. The residents of Market Heights are particularly concerned because they have successfully maintained their neighborhood, and rentals are something they are worried about. In Cleveland, they recently discovered a problem with enforcement of the AirBNB regulations. He asked Council to strongly consider the AirBNB issue and the affects it will have on the Canton neighborhoods. Andrew Reo also spoke about the AirBNB's in the residential neighborhoods. There is one on his street, and it's like having a hotel there with new renters regularly. He asked Council to consider the current zoning laws. AirBNB's are commercial and they should be moved out of the R-1 neighborhoods. President Schulman reminded Mr. Lalewicz and Mr. Reo that these Ordinances will be discussed on April 9, 2018.
