MISCELLANEOUS BUSINESS: Member Morris stated that since the recent paving of 30th Street, which cost about a million dollars, there are now cracks across both lanes big enough to put your finger into. He asked the Service Director to report back under Old Business. Service Director Highman indicated that 30th Street has been put on the crack and seal list and should be completed by next week. He will follow up with Engineering and report back. Member Smuckler spoke about the history of violent acts, such as the 60's shootings and the Holocaust. He stated that his first grandchild will be arriving soon, however he worries about his three daughters because of what's happening to their religious freedoms. He believes it is time for people to respect and care about one another, and not just during the holidays. He said that everyone has a right to be afraid, for themselves, for their children and for their grandchildren because if it can happen in other countries, it can happen here. President Pro Tem Smith asked for a moment of silence for our nation, our young people, and for employees of the City who have recently lost young family members.
