OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Vince Watts asked Council to reconsider their \$12 million plan for the Centennial Plaza Project. It will not create jobs, and he suggested investing in projects for kids such as a zoo or renovating Meyers Lake Park. He said this is the wrong project at the wrong time. Pete DiGiacomo thanked the Health Department for keeping the City looking nice, clean and healthy. He said they are the only department that does that. Ruth Busch wants to know what Canton plans to do to take back the City from the criminals. One of the problems she sees is the vacant homes that are so close to area schools. These homes have been on the demolition list for a long time. She encouraged Council Members to be active and recognizable in their wards. Rose Bocinec drives to work in Akron every day and she sees how badly the highways in Canton look compared to Akron. She would like to see her tax dollars going to improve these conditions. She implored Council to take notice and find solutions such as hiring unemployed people to pick up garbage and mow. Amy Smith feels that the money from Issue 13 is not being used for what was listed as the number one priority, and that is safety. Instead it is going toward the ambiguous Comprehensive Plan. She asked Council to make crime the first priority rather than another park overrun with criminals. John Laughlin feels that the Centennial Plaza Project is a good idea, but should not be the priority. Police protection and neighborhood improvement should be top priorities. He is not against the Centennial Plaza, but he takes issue with how the funds are being allocated. Jill Thomas is not satisfied with the direction in which the City is going with the Issue 13 funds. She asked Council to take into consideration the voters' intentions for a stronger, safer Canton and invest in safety, roads and jobs. She suggested more police patrol, reinstating the gang task force, job training and youth programs. Lori Swallen heard gun shots behind her house last Friday night. She has three children who are now afraid to go outside to play. She stated that 50% of properties in the City are rentals, and this is part of the problem because pride in home ownership decreases. She asked Council to do what they promised and increase police patrol in the neighborhoods. Linda Tuttle is concerned about the appropriation of Issue 13 funds. She and her husband head up the North Lehman Neighborhood Association. They have partnered with the City on a number of projects and they have seen the decline within the last ten years, gun shots at night, fighting in the streets. She asked Council to re-evaluate everything that is being done and make safety the number one priority. Sally Conley-Oyster said that on May 27 at 2:30 A.M. a man was standing on her front porch looking inside her home. She feels that rather than spending \$12 million on the Kresge block, that money could go a long way to prevent crime and improve the City's infrastructure. She encouraged Council to prioritize how these funds are spent. Kim Brown lives near where a recent violent event took place, and she has not seen any increase in police patrol. The money from Issue 13 should be going for increased police protection rather than developing a green space which will not help with safety or property values. This money should be going to such things as a youth director, a gang task force and mowing of vacant lots. She wants better for her City, family and children.
