MISCELLANEOUS BUSINESS: Member Smuckler asked the Finance Director about the red block in his presentation and what steps are being taken to get rid of it. Finance Director Crouse explained that the red block measures capital assets such as roads and bridges. Service Director Highman stated that it also encompasses all capital assets, buildings and water and sewer lines and is based in part on depreciated assets. He gave the example of cleaning and televising aging sewers. He intends to work with various auditor's offices to understand why it is showing as red. Finance Director Crouse stated that when the State Auditors come in, they will discuss how to improve the red score with them also. Member Smuckler asked that a written memo be sent to all Council Members once they get that information. He asked the Mayor if they will be hiring summer help this year. Mayor Bernabei stated that with the money they are receiving from the American Rescue Plan, they intend to hire 15 to 20 high school/college students for the Ambassador Program to help clean up the parks, neighborhoods and litter. They also plan to examine other hiring. Deputy Mayor Williams stated that they will look at additional programs for the summer, including one with young people and the Police Department. Member Smuckler asked Service Director Highman if they will be hiring companies to mow the high grass in the empty lots this year. Service Director Highman said yes, they will run the same program they have done for many years. This used to be a function of the Street Department, but it is now handled by the Code Department, who has enforcement capabilities. He believes they have done a good job in taking over that program. Safety Director Perry stated that the contractors have already been provided with their contracts for the year. Member Smuckler asked when this will begin. Service Director Highman stated that the first cut is usually sometime in May, the goal being to keep from doing four to five cuts of the same lot. Safety Director Perry stated that if a property is deemed to need immediate attention prior to May, they will take care of it. Member Smuckler expressed concern that people know what to do and how to do it, especially regarding the multi-lots owned by individuals who could care less and think that the City is a mowing service. Member Mariol congratulated Member Scaglione on the West Tusc Corridor and the Aultman Cancer Center. President Sherer asked Member Smith if she is accepting donations for the Easter Egg Hunt being held at Crenshaw Park on April 3rd from 2:00 to 5:00 PM. Member Smith said yes. She also confirmed that there is another food giveaway Saturday at the Coleman Center from 1:00 to 5:00 PM. President Sherer stated they will also be taking donations to other facilities such as the Babe Stearn Center and some retirement communities.
