MISCELLANEOUS BUSINESS: Member Smith thanked everyone who participated in the HBCU (Historically Black Colleges and Universities) event this weekend. She noticed that there was not a lot of participation from elected or city officials. She feels this event is the same as the Hall of Fame, and urged Council and the Administration to participate more fully in the future. She specifically mentioned the Centennial Plaza event with Marvin Sapp, which drew one of the largest crowds yet. She believes the Centennial Plaza should continue to be used in a diverse manner for all city events. Mayor Bernabei stated that he attended almost every HBCU event, as well as many members of his Cabinet. He felt it was a well executed and well attended weekend for Canton, and they have a great agenda going forward. He agreed that a large crowd attended the Marvin Sapp concert, as well as First Friday and the game itself. He urged everyone to participate in all such City events. He stated that this past Saturday was the 20th Anniversary of 9-1-1. A symbolic climb of the number of steps that the firefighters at the World Trade Centers walked took place at the McKinley Monument.
