PUBLIC SPEAKS (CITY BUSINESS): Kim Bell spoke about mental health issues. She feels that some of those issues are so severe that it takes more than just putting people in agencies or hospitals. She said that a lot of famous people had mental health issues. Court Administrator Kochera asked Council last week for funding for mental health issues, and she is concerned that Council questioned that. She told the Mayor that he is already established financially, so he should get out of the race and go golfing. She still feels that more of the money needs to be invested in the east end of the City, and suggested that they build hotels, restaurants and grocery stores in those areas. Rodney Dennis is a veteran of the United States Army, he served overseas and helped during Hurricane Katrina. He has a Bachelor's Degree in business from Akron University. He opened Levels Barber College in Canton and has given over \$81,000.00 in scholarship money. They have given out over six to seven thousand haircuts in six months, have helped people pay their rent and bills and gave out groceries. They are opening another barber shop at 300 Cleveland Ave and the first barber supply store in Canton. They offer education for anyone who has dropped out of high school or served time in prison and show people how to open their own businesses. He thanked the Council Members, the Mayor and Deputy Mayor for accepting him into the City.
