MISCELLANEOUS BUSINESS: Member Smith invited everyone to the Southeast Community Center on December 18 for their Christmas #2. If anyone would like to volunteer or offer support, please see her. They have adopted 13 families, eight of which were families from Skyline Terrace that lost their homes to fire and three of which were from Canton City Schools. Deputy Mayor Williams talked about the Canton Outside Canton group who sponsored a food give away last year in conjunction with Diane Robinson, CEO from Stark County Urban League, and fed well over 12,000 families. This Saturday at 11:00 AM at St. Paul's at 1800 East Tusc, they will again be feeding numerous families. He encouraged Council Members to volunteer. Mayor Bernabei announced that there will be an informational meeting this Thursday at Malone University. Deputy Mayor Williams explained that this meeting involves a proposed 15-unit senior housing development behind the Jewish Center. The meeting will take place at 6:00 PM within the Silk Auditorium. There will also be a link for those who want to zoom in. Mayor Bernabei explained that this is a zone change that will come before Council and the Planning Commission, which involves a tax credit. Member Smuckler spoke about the gun shots at Light Up Downtown last week. He said that this was caused by people who don't know how to use guns and have no business carrying them. Because of the undeserved perception of downtown that this caused, there was not much of a crowd the following day at First Friday.
