PUBLIC SPEAKS (CITY BUSINESS): Laura Simon attended the zoning meeting last week where they discussed spot zoning. She would like to see that continue. She compared the procedure to baking a recipe because you need the proper ingredients, that being the public and elected officials, and you need to follow the proper procedure and take the proper amount of time to develop the final decision. She would like for the public to be informed through annual reports of any changes in procedure, and encouraged elected officials not to "skip the time." Fire Chief Akbar Bennett spoke about the wage increase for the police cadets being higher than that offered to the firefighters. He feels that it is unfair and sends the message that firefighters are not as valued as police officers. He asked for equality by tabling any decision on this and allow for further discussion. Division Chief Steve Henderson distributed a salary survey comparing Canton with other area police and fire departments. He would like to get to a point where they are competitive and can keep their good people. Ida Ross Freeman is very upset that, after being told that Officer Huber would be on administrative leave, she found out that he is not. She feels that this is a way to keep Blacks in line through intimidation and not come forward with the truth. Jay Cousins spoke about the shooting of James Williams, who is his cousin. He said that James was merely performing a New Years' ritual that's done all over the country, and he believes that the police were totally wrong in the way they handled the entire situation. He said that the justice system is all injustice. The police are out slaughtering people of color, and now the officer that killed James has a desk job. That is not right.
