OKAY TO PREPARE LEGISLATION:

RE: City of Canton Demolition Assistance Program (DAP)

Dear Madam President and Honorable Members:

The City of Canton seeks to support the demolition of blighted commercial and residential properties associated with economic development activities and projects within the City of Canton. This program is specifically designed to assist property owners and developers with the demolition of blighted properties which are directly connected to future economic development activity on or around the site. This proposed program seeks to leverage the Canton Community Improvement Corporation (CCIC) as the primary manager of the program and is designed to provide reimbursement grants for the abatement and demolition of blighted commercial and/or residential properties.

Grants for residential demolitions will be up to 50% of the cost capping at \$15,000 and grants for commercial demolitions will be up to 50% of the cost capping at \$30,000. Eligible costs will be the complete abatement (if needed) and demolition of the property. Additionally, eligible projects must include detail outlining the economic benefits and economic activity which will occur at the site post demolition.

It is proposed that the DAP will be a City-wide program open to any and all entities with an eligible, associated economic development project. The program will be administered by the Canton Community Improvement Corporation

Therefore, I hereby request legislation which does the following:

- 1. Establishes the Demolition Assistance Program (DAP)
- 2. Authorizes the Mayor and/or Director of Public Service to enter agreement with and compensate the Canton Community Improvement Corporation to administer the DAP.
- 3. Authorizes the Auditor to draw warrants from the General Fund, Non-Income Tax portions in an amount not to exceed \$100,000.00
- 4. Amend Appropriation Ordinance No. 61/2024 with the following supplemental appropriations:

FROM: Unappropriated Balance of the 1001 General Operating Fund TO: 1001 200501 General Gov't Support Admin – Other

5. Declares this ordinance to be an emergency measure.

The City of Canton Building and Code Department is requesting permission for the Safety Director to enter into a contract with Butcher and Sons, for services up to \$52,300.00 for the demolition of 800 Walnut Ave NE, located in Ward 2. The Building Department pursued this location via normal department procedures at the request of J.R. Rinaldi and the Blight Removal Program. The testing, abatement and cleanout is underway therefore the reason for this communication. We are asking for first reading passage as demolition will be able to take place shortly after passage. All expenses related to this blighted property removal will be assessed to the property via our lien process with the Stark County Auditor.

Therefore, I hereby request legislation that does the following:

- 1. Authorizes the Mayor or Director of Public Safety, on behalf of the City of Canton, to enter into any and all contracts with Butcher and Son.
- 2. Authorizes the Auditor to draw warrants upon receipt of vouchers duly approved by the proper department authority.
- 3. Declares this ordinance to be an emergency measure.
