RE: Legislation Request - Perry Heights Area Water Main Replacement Project - Phase 2

Dear Madam President and Honorable Members:

The Water Department desires to replace failing water mains in the Perry Heights area. The proposed project will consist of the replacement of approximately 1.57 miles of water main to include the area north of Barrie Street NW, south of 4th Street NW, east of Oneida Avenue NW, and west of Mohawk Avenue NW. During design of this project, the Water Department became aware Perry Township planned a road resurfacing project for the same township roads where the water mains were to be replaced. To promote intergovernmental cooperation and efficient use of resources while minimizing disruption to the community, we have agreed to allow the township and the Water Department to coordinate the paving process pending Council and Trustee approval. The Water Department will be responsible for paving either the trench or the lane depending on the age and condition of the road. The township will fund the remaining cost of the paving. The current cost estimate for the township's portion is \$350,000.00. Arcadis Engineering Services USA, Inc. prepared plans and specifications, and we are ready to proceed with bidding the construction contracts. To help fund the project, the Water Department successfully secured \$1,500,000.00 from Ohio Public Works Commission in the form of a \$600,000.00 grant and a \$900,000.00 zero percent, ten-year term loan. The remaining waterline funding will be paid with water funds. The current cost estimate for the project construction in total is \$2,810,000.00.

Therefore, I hereby request legislation that does the following:

- 1. Authorizes the Mayor and/or Director of Public Service to advertise, receive bids, award and execute a construction contract for the Perry Heights Area Water Main Replacement Project Phase 2.
- 2. Authorizes the Mayor and/or Director of Public Service to execute a professional services contract for construction oversight services for this project.
- 3. Authorizes the Mayor and/or Director of Public Service to execute a cost-share agreement with Perry Township for street paving.

RE: Legislation Request – Abandonment of Northwest Water Treatment Plant Collector Well #3

Dear Madam President and Honorable Members:

The Water Department's collector well #3 at the Northwest Water Treatment Plant was taken out of service due to the age and deterioration of the well. Abandoning this well will eliminate any possible threats of contaminates or bacteria entering our raw water due to the lack of use of this well. Unlike a typical vertical well, this collector well consists of a 13' diameter, vertical, concrete caisson, with two tiers of multiple laterals that project anywhere from 78' up to 165' out from the center caisson. The upper tier and lower tier of laterals are separated by a clay layer which divides the aquifer into two separate zones. We are requesting the well be abandoned by sealing the laterals through use of concrete, which follows the Ohio Water Resources Council Regulations for sealing unused water wells. This method will be provided to the Ohio Department of Natural Resources and the Ohio EPA for their comments/approval.

The Water Department is also requesting to execute a release of easements for collector well #3, located at 4125 Salway Avenue NW.

At this point, the project specifications have been prepared, and the Water Department would like to bid this project, which has an estimated cost of \$ 160,000.00.

Therefore, I hereby request legislation that does the following:

- 1. Authorizes the Mayor and/or Director of Public Service to advertise, receive bids, award and enter into contract for the abandonment of collector well #3 at the Northwest Water Treatment Plant.
- 2. Authorizes the Mayor and/or Director of Public Service to execute the release of easements located at 4125 Salway Avenue NW.
