

I am respectfully requesting that Canton City Council prepare an ordinance authorizing the Mayor and/or Director of Public Service, on behalf of the City of Canton, to transfer permanent parcel numbers 206004 & 206005, located at 4th St NW and Bedford Ave NW, which are no longer needed for municipal purposes, to the Canton Community Improvement Corporation, as its designated agent for economic development purposes, for subsequent transfer to David A. DeChiara. This transfer will be pursuant to Ohio Revised Code Section 761.02 and 1724.10.



RE: Request for Legislation – Maple Ave. NE Sewer Replacement - GP 1374

Dear Madam President and Honorable Members:

As part of an overall strategy to improve Canton's infrastructure and comply with EPA requirements, the Engineering Department is working on a project to reconstruct failing sanitary sewers on Maple Ave. NE. The project limits are 12th St NE to 28th St. Some sewers on 15th St and 17th St may also be included as we work through the design process.

Utilizing the qualification-based selection process as required by the Ohio Revised Code, the Engineering Department has determined that Burgess & Niple, Ltd. as the most qualified engineering consultant to serve as the designer for this project. The design costs will be encumbered from funds that have already been appropriated. The estimated cost for design is \$200,000.00, and the estimated construction cost is \$3.5 million. The current estimated date of construction is 2026.

Therefore, I hereby request legislation that does the following:

- 1. Authorizes the Mayor and/or Director of Public Service enter into a professional services contract in an estimated amount of \$200,000.00 with Burgess & Niple, Ltd. for design of the Maple Ave. Sewer Replacement Project GP 1374.
- 2. Authorizes the Mayor and/or Director of Public Service to advertise, receive bids, award, and enter into one or more contracts for the Maple Ave. Sewer Replacement Project GP 1374.
- 3. Authorizes and directs the Auditor to pay any and all moral obligations for contract change orders that are otherwise approved by the Board of Control pursuant to Canton Codified Ordinance 105.14 within the established dollar amount thresholds for the above-named project.
- 4. Authorizes the Auditor to draw warrants upon receipt of vouchers duly approved by the proper departmental authority.
- 5. Declares this ordinance to be an emergency measure.
