NOTICE TO LEGISLATIVE AUTHORITIES Objections to Renewal of a Retail Liquor Permit

Dear Clerk of Legislative Authority:

All Class C and D retail permits to sell alcoholic beverages in your political subdivision will expire on **February 1, 2025**. In order to maintain permit privileges, every permit holder must file an online renewal application with the Division.

Ohio Revised Code Section 4303.271(B) provides the legislative authority with the right to object to the renewal of a retail permit and to request a hearing. The hearing may be held in the county seat of the county in which the permit premises is located if that request is made in writing. This will be your only opportunity to object to the renewal of a liquor permit premises which might be a problem in your community.

In order to register a valid objection with the Division of Liquor Control and request a hearing, the legislative authority must pass a resolution that specifies the problems at the liquor permit premises and the legal grounds for the objection as set forth in Ohio Revised Code Section 4303.292(A). We suggest that a separate resolution be passed for each permit premises. The Chief Legal Officer of your political subdivision must also submit a statement with the resolution that, in their opinion, the objection is based on substantial legal grounds within the meaning and intent of Ohio Revised Code Section 4303.292(A).

The resolution and Chief Legal Officer's statement must be sent by email (below) or mailed to the Division of Liquor Control, Attn: Legal Section, 6606 Tussing Road, P.O. Box 4005, Reynoldsburg, Ohio 43068-9005 and postmarked no later than <u>January 2, 2025</u>.

You may wish to contact the law enforcement agency for your jurisdiction to determine if it has any information which will aid in your decision whether or not to object and request a hearing. You can find retail permit holders within your jurisdiction by going to <u>com.ohio.gov/findapermitholder</u>. Select your city/township name where asked and "issued" under "class issue status." For more information on other ways to deal with problems establishments, including a copy of the text of this letter, go to <u>com.ohio.gov/govhelp</u>.

If you determine that there are no permit premises within your jurisdiction that you wish to object to, you do not need to take any further action. The renewal applications for those premises will be submitted by the permit holders and will be processed by the Division as appropriate.

Schulman, Roth & Associates Co., LPA is seeking relocate their headquarters within Downtown Canton to 213 Market Ave. N.

Schulman, Roth & Associates Co., LPA is seeking assistance with their relocation and proposed investment of nearly \$250,000 which will lead to the creation of two (2) fulltime jobs and retention of five (5). This would create an additional \$300,000 in new payroll. The City of Canton is proposing to support Schulman, Roth & Associates Co., LPA through a Job Incentive Agreement for a period of five (5) years and to grant back to Schulman, Roth & Associates Co., LPA, through non-income tax revenues, approximately \$40,000 in support over that term. This incentive will help to provide funds for Schulman, Roth & Associates Co., LPA's project and contribute to their growth within the City.

I hereby request legislation which does the following:

- 1. Authorizes the Mayor and/or Director of Public Service to enter a Job Creation, Retention and Net Profits Tax Incentive Agreement with Schulman, Roth & Associates Co., LPA pursuant to the City's incentive programs;



I am requesting legislation to authorize approval of a professional services agreement to continue a contract with Mr. Charles Corcoran, Architect, dba Oak Group LLC to serve as the City of Canton Chief Building Official.

Mr. Corcoran has served as our CBO since January, 2022. Previously, his contract was for 14-16 hours per week, with compensation not to exceed \$79,040 (\$95.00/hour.) With the passing of Mr. Rito Alveraz in December of 2023. Mr. Corcoran unofficially assumed the roles and duties of the Residential Building Official and the Residential Plans Examiner as outlined by State requirements for the City to keep the residential building department functioning.

We are requesting that his new contract reflect the additional duties and responsibilities. Mr. Corocoran shall continue to serve in the role of Chief Building Official as a contractor with a new rate of \$100/hr for a maximum of 832 hours per year, for a total cost not to exceed \$83,200.00 for the first year (2025) plus a 5% increase in years 2 and 3 of the contract.



Request for Legislation – Cleveland Avenue NW Resurfacing Project - GP 1283 RE:

Dear Madam President and Honorable Members:

As you know, Cleveland Avenue is one of the major north-south corridors running through Canton. The Engineering Department has secured a federal grant of \$2,916,778.00 to resurface Cleveland Ave. NW from 12th St NW to 55th St NW. The estimated project cost is \$4.6 million leaving our matching cost at approximately \$1.6 million. We intend to bid this project out in the spring of 2025. Funds will be appropriated in the 2025 budget.

Additionally, please let this communication serve as the report in compliance with Subsection 105.01(b)(5) of the Canton Codified Ordinances to inform Council that the City will not be entering into Project Labor Agreements (PLAs) for the above referenced projects as they will be funded in part with federal dollars. While ODOT and/or the Federal Highway Administration (FHWA) might consider allowing the use of PLAs for these projects, similar federally funded Canton projects, such as Walnut Ave., 12th St. Phases 1 and 2, Fulton Rd., Mahoning Rd. Phases 1 and 2, etc. have not experienced the types of issues that would enable us to justify the need for PLAs. For instance, in evaluating the justification for a PLA, items that ODOT and FHWA take into consideration include: past labor unrest, inability for contractors to meet critical completion timelines, and a history of problematic construction issues. The City has not experienced these issues on the aforementioned projects. Thus, the City has traditionally not used PLAs on these types of projects. In addition, if Canton would attempt to include PLAs on these projects, it could not include any local union preference, something that is a standard element of the City's typical PLAs. Furthermore, any proposed PLA would have to be approved by both ODOT and FHWA, which could be a cumbersome process and possibly jeopardize the City's federal funding and project timelines.

Therefore, I hereby request legislation that does the following:

- 1. Authorizes the Mayor and/or Director of Public Service to advertise, receive bids, award, and enter into one or more contracts for construction of Cleveland Ave NW Resurfacing Project - GP 1283.
- 2. Authorizes the Mayor and/or Director of Public Service to enter into one or more contracts for this project utilizing any procurement process authorized by law.



- 3. Authorizes and directs the Auditor to pay any and all moral obligations for contract change orders that are otherwise approved by the Board of Control pursuant to Canton Codified Ordinance 105.14 within the established dollar amount thresholds for the above-named project.
- 4. Authorizes the Auditor to draw warrants upon receipt of vouchers duly approved by the proper departmental authority.
- 5. Declares this ordinance to be an emergency measure.

Dear Madam President and Honorable Members:

Ordinance 68/2019 in part established the current *Personnel Guidelines for Hiring and Retaining Non-Bargaining Personnel Under the Mayor's Authority.* This in large part follows the policies that were established by Ordinance 100/2011 for the various appointing authorities throughout City government. Over the last several months, I have been working with the various elected officials and appointing authorities on an update to these rules to clarify multiple items and to create additional flexibility where needed. Additional goals are ensuring stability, predictability, and Council's fiscal oversight. To that end, attached is a proposed update to the policy. The major changes are as follows:

- 1. Create consistent rules for both fiduciary and classified employees.
- 2. Allow for additional movement within the salary grades where warranted while ensuring moves where unwarranted can be avoided.
- 3. Establish policies for lateral moves and transfers to lower salary grades.
- 4. Establish the relationship between fiduciary and classified positions in regards to salary policy.
- 5. Clarify the salary policies for casual and seasonal employees.
- 6. Establish when salary adjustments may be made tying them to the budgetary process to ensure both funding and transparency.

Again, it is my belief that the attached will provide multiple clarifications and updates that work for all parties while keeping in mind their various roles and perspectives.

Therefore, I hereby request legislation that does the following:

- 1. Establishes the attached as the *Personnel Guidelines for Recruiting, Hiring, and Retaining Non-Bargaining Personnel* within the City of Canton amending Ordinances 68/2019, 100/2011 and any other ordinances inconsistent with these updated policies.
- 2. Authorizes the Auditor to draw warrants upon receipt of vouchers duly approved by the proper appointing authority.
- 3. Declares this ordinance to be an emergency measure.
