PRESIDENT DENCZAK: Public Speaks, Open Forum—we have three speakers signed up. Gregory S. Whipkey. State your name and address please.

MR. WHIPKEY: Mr. President, ladies and gentlemen. My name is Scott Whipkey, I live at 1130 - 17th Street NW, Ward 7, Richard's ward. And my question is unexpected, I imagine, for most of us, but it doesn't have to do with what you think. It's been brought to my attention by my neighbors around, and they're wondering if this should be dealt with before it's too late or put on the back burner (WORDS HERE ARE NOT UNDERSTANDABLE).....the Civic Center. A few of my neighbors who have lived in the neighborhood for over 40 years were wondering what's going to happen to it. They seen the downfall with the maintenance and the upkeep. And I have heard it's going to be turned over to Kevin Monroe and he's in charge of the Street Department, Sewer, and that man's really got a handful. I don't know, I haven't talked to him or anything, but everybody was just kinda wondering how it's going to be maintained, whether it's going to be sold or not, and if the maintenance will be, you know, brought up, from like a lot of these people at the car show over the weekend, we thought, man, there's still leaves out front and a couple newspaper boxes tipped over. And they were just wondering basically about that. The dirty windows and the light bulbs on the signs out front, you know, over there where they advertise for whatever shows they have in there. The bulbs are burned out, and the darkness underneath the overpass. Other than that, that's about basically...and they were wondering why we don't have family shows such as like Sesame Street and the concerts they used to have back in the day. Basically, that's about it, I just wanted to see if there's going to be any response to that that I can take back home with me. Thank you very much.

SERVICE DIRECTOR MILLER: I'll be glad to respond. Right now is a difficult time of year for us to maintain the outside of the Civic Center because we've got most of the people that normally help with that, Traffic Engineering, Street Department, those type of folks out pushing snow and doing other items so it's really difficult to get out there and do those things. And as far as the inside, we have gone from 14 to 11, I believe we're down to 6 or 7 persons inside maintaining that structure. They're doing the best they can, but right now, again when you have shows back to back, again, it's difficult to keep things clean in-between. We're doing the best we can with the personnel we have left. We do take Street Department personnel over there when we don't have snow in the wintertime and help set up shows and take them down. As far as I know, Sesame Street has been there the last, every year for the last few years. As far as I know, it's expected to be there again this year. And as far as management structure is concerned, we are looking at a realignment of management so that we don't have to replace Bob Patt and Joe Burnosky's salary. Between the two of them, just salary alone, you're looking at probably about \$120,000 a year plus benefits. Kevin will be giving up the sewer maintenance and that will be going down under Tracy, if the plan goes to fruition. That's something we're still examining at this time. If you have any other questions, catch me outside afterwards, I'll be glad to answer them.
