MEMBER SMUCKLER: Mr. President, I move we adopt Ordinance 19; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance 19; are there any remarks under this ordinance?...

MEMBER CASAR: Mr. President, I'd like to ask the Safety Director a question if I may please.

PRESIDENT DENCZAK: Yes.

MEMBER CASAR: Safety Director Concatto, with the proposed increase, could you please give us a break down of what figures we're talking, from what amount for the half hour meters, hour meters...the whole break down, I'd appreciate it.

SAFETY DIRECTOR CONCATTO: Mr. President, Member Casar. We're looking at raising the meters, in general, from 25 cents an hour to 50 cents an hour. That would raise it...there's different increments that we need to get to 50 cents, but it basically doubles the fees. Does that answer your question?

MEMBER CASAR: That is going to be for hour meters or half hour meters or...what?

SAFETY DIRECTOR CONCATTO: It'll be for the one hour meters, and also for the two hour meters.

MEMBER CASAR: And the ones that are presently half hour, they're going to stay at?.....or what are they going to go to?...

SAFETY DIRECTOR CONCATTO: The half hour meters will go to a quarter.

MEMBER CASAR: They'll go to a quarter?

SAFETY DIRECTOR CONCATTO: Yes, sir.

MEMBER CASAR: Well my belief on raising the meters, in my opinion, it'll serve one good function and that'll be more money for the General Fund, which we all know we need. But I do not feel that this is the way we should be going because the reason that, with the meter situation downtown, is because as well know, for a lot of meetings we've had in the past for many, many years-it's the employees, city employees, county employees, office employees, store employees, restaurant employees who all use the meter spaces and they feed the meters all day long. If we increase that, yes, we'll gather some little cash for the General Fund, but that's not solving the problem, with the problem being no parking place when a citizen comes down to Canton, to the City of Canton, to go to the Health Department or Building Department, or the City Hall, to stop in at the jewelry store or whatever. In my opinion, by increasing this will not do anything to alleviate the problem we're having and that's employees feeding the meters so they can park for 8 hours a day. I feel that what we should do is that we should continue the same way we have and if the meters run out, we should mark the tires like we used to do in the old days, come back later, and if the car is still there, the vehicle, it should be towed. And as one member said, Member Hawk said, we should look into buying those boots where you put the boot on the tire and they don't get the car until they pay their \$30 or whatever. I just feel that we're just sugarcoating a problem by increasing the rates. We want to provide parking for the downtown stores and the downtown businesses and to do this, we have to make it friendly for, in other words, get the people that shouldn't on the streets off the streets-put them in parking garages, which we have too many of those already, and utilize those. And the employees, meaning the city, county workers, whatever, they should also put some type of restriction on their employees and watch they don't go out and feed those meters. That's my opinion and I cannot support this increase.

PRESIDENT DENCZAK: Any other remarks?...

MEMBER SMUCKLER: Mr. President, the key word I've used for downtown has been user friendly. Unfortunately we are not user friendly, especially when it comes to parking downtown. I, years ago, proposed to do away with the meters. I have proposed to do surface street parking. And what I'd like to see is a more comprehensive plan than just this plan to do something about the whole parking situation down here. We had a consultant come down to the Chamber, several weeks ago, talk to us about the simplest things of diagonal parking downtown on Market, surface lots, things that this Council has been talking, or at least this Councilman has been talking about for years. And I too, knowing that when you go to Belden Village, you don't have to put money in a meter, when you go to The Strip, you don't have to put money in the meter, and I, too, will not be supporting making it more user unfriendly than we have it already.

PRESIDENT DENCZAK: Any other remarks?..

SAFETY DIRECTOR CONCATTO: Mr. President, this increase in parking meter fees was not created out of some, of myself and the Mayor sitting in the office trying to find ways of making money for the City. This increase was made out of many meetings with the Special Improvement District and other people in the City to try to find a compromise for the difficult situation about parking meters. You have some businesses downtown Canton that don't

rely on parking meters, such as restaurants, during the lunch hour-they don't rely on the parking meters there, so they don't care if their employees park at that meter for two or three hours. We have some businesses downtown, like the jewelry stores and some other businesses, that rely on the parking meters. It is not a one shoe fits everyone. And I met for many, many hours, trying to come up with a plan. And I invite Members of Council, if this fails, and if they want to remove the parking meters, I don't care. If they want to be a part of the planning process, I invite them to be part of the planning process-because that's what this was; this was an effort, we were going to raise the meters because right now a person can parking on the street for 8 hours for \$2. We were going to offer our Millennium Parking Deck, an early day special for those employees for \$2 a day. It is our belief that a person coming downtown would prefer to pay up to 50 cents an hour rather than driving around the block time in and...time and time again to find a parking place. Again, this came from a series of discussions with people that were involved downtown with parking. If this Council does not want to raise the parking meters, so be it. If there is other plans, I'll be glad to be a part of it.

MEMBER HAWK: Mr. President, I'm downtown every day and the problem really is a lack of enforcement. We do have folks parking all day long. One of the histories I was told about a lady who had 65 parking tickets before we finally towed her vehicle. She then ransomed her vehicle out, paid all the fines and necessary costs, and was quite content with that fact. Now she has 6 parking tickets. Why these cars aren't towed when they have 3, and I believe, I was told that that's what we were permitted to do, why these cars aren't booted on the spot. And then we begin costing these scofflaws more money than it costs them to park in a lot. That's the only real way we have to eliminate some of the parking problems. We have to look at it from a two-fold thing–the increase in the parking fees will help reduce that. And I'm not opposed to it. But unless we begin a stricter enforcement, \$2 a day is still awfully cheap to park a car downtown. And I don't think that we'll see that big of a swing in the people who are feeding these meters continuously. We have to look to enforcement. If we need to purchase a boot to lock these things up, so be it. But I will support this measure in an attempt to bring it forward. But I also would like it to be hand in hand with a stricter enforcement program and that we do begin towing these vehicles and getting them out of the street. And that's one way we will clear parking for people who come downtown for short periods of time. Thank you.

## PRESIDENT DENCZAK: Any other remarks?...

MEMBER HART: Yeah, Mr. President, you know the situation is again a Catch 22, you know, you want to have user friendly parking, but at the same time it's not for those people that are using the downtown, using the stores for, it seems, the vast majority. It's user friendly for the employees that are working downtown and it's become cheaper for them just to use and take up the spaces that are needed by those people that are going to be visiting the downtown businesses. And, again, it's a good plan because hopefully it'll help alleviate and make parking a little more user friendly downtown. And until, you know, fines are increased to where it's not so financially feasible to have the meter feeders and to hear the stories of where employees will take turns going out all day and, you know, everybody's parking in that line–you know you're never going to have any type of convenient parking for anybody that's using downtown Canton for the short period of time to run into a courthouse, run into a jewelry store or anything else. It's the best thing to do for those residents that need user friendly parking.

PRESIDENT DENCZAK: Any other remarks?... If not, roll call vote please.

NO FURTHER REMARKS ROLL CALL: 6 YEAS, 5 NAYS – <u>DEFEATED</u>!! (SMUCKLER, CASAR, DOUGHERTY, DIAMOND & CARBENIA VOTED NO. BABCOCK, HAWK, ALTIERI, MALLONN, MASSEY & HART VOTED YES. MROCZKOWSKI ABSENT)

THE FOLLOWING SECTION 3 OF ORDINANCE NO. 246/2002 WAS POSTPONED TO2/24/2003:Section 3.2/24/2003:Subsection (b) to Section 151.08, Overtime and CompensatoryTime for Nonexempt and Exempt Employees, of the Codified Ordinances of the City of Canton be and thesame is hereby amended to read as follows:

(1) Professional, administrative, executive and other employees who are exempt from the Fair Labor Standards Act of 1938, as amended, shall be entitled to one compensatory hour for each full hour actually worked in excess of and contiguous with their regularly scheduled work day. No fractional portions of hours shall be used to compute compensatory time, except for off-duty compensatory time earned through an approved call-back, which shall be computed in quarter hours. Employees may not accrue more than 120 hours of unused compensatory time for overtime hours worked.

- (2) Compensatory time entitlements shall be approved by the appointing authority and shall be properly recorded as to when it was earned and when it was used on a biweekly basis when the payroll is submitted. The records on file in the Auditor's office shall be final.
- (3) Exempt employees may use accrued compensatory time with the approval of the appointing authority taking into account the scheduling needs of the department.
- (4) Upon termination of employment, employees with unused compensatory time shall be paid at their final regular rate for a maximum of 120 hours. Any accrued but unused hours in excess of 120 hours are forfeited upon termination of employment.

that there's no way to do this amount of ordinances in a short period of time between 6:30 and 7:00, so that's why I'm scheduling mine for March 3<sup>rd</sup> at 6 p.m.

PRESIDENT DENCZAK: I was just going to bring that up, Member Smuckler, that the length of the referrals is quite considerable here, and it's smart to start at 6:00 next Monday. Any other committees?

MEMBER BABCOCK: Mr. President, Public Safety & Thoroughfares will also meet next Monday at 6:00. Thank you.

PRESIDENT DENCZAK: Any other committees?

MEMBER ALTIERI BUCHER: (INAUDIBLE) SHE ANNOUNCES AN INTERGOVERNMENTAL & PUBLIC SERVICE COMMITTEE MEETING FOR MONDAY, MARCH 3<sup>RD</sup>.

## PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum. We have one person signed up to speak, Frank Thristino.

MR. THRISTINO: My name is Frank Thristino, address of 2436 - 30<sup>th</sup> Street, business. Mr. President, Members of Council and elected officials. Canton parks are assets to the community, providing green space and recreation needed for quality of life. Park Police provides patrol throughout all 59 parks in Canton. We stay aware of the conditions of the parks and the citizens who use them. I have patrolled the parks for 9 years and have almost 30 years' police experience in New York City and Canton, which I bring to the park system. Maintaining the quality of life we now enjoy in Canton's parks requires constant reinforcement of park rules and regulations. For instance, Ben Franklin said "watch the pennies and the dollars will take care of themselves." We perform proactive patrol within the parks. We're always vigilant, we're always inquiring. This is different from reactive patrol that only responds to the fact or an incident after it occurs. Park Police presence deters unruly and illegal behavior in the parks. This is a city-wide problem. Every ward is effected. Mr. Denczak, Ms. Babcock, Mr. Casar, Mr. Smuckler, you are all members-at-large and you are responsible for the whole city. Mr. Hawk, your ward has Monument, Waterworks, Westbrook. Ms. Altieri, you have Nimisilla, Cook, Rowland. Mr. Mallonn, your ward contains Garaux, Green Acres, Mini Park 2. Mr. Massey, you have Crenshaw, Ida, Jackson, Lee, McKinley, #3, #8, #9, #19, Westpark, which is Babcock Field, City Field, and Presley Field. Mr. Dougherty, your ward contains Harmon, Herbruck, Herbruck Annex, Bup Rearick and Warwick Field. Mr. Hart, you have the crown jewel, you have Stadium Park, you have Don Correl, you have Playground D, you have Weis Park. Ms. Diamond, you have Arboretum, Covered Bridge, Martindale, Northview, Roshong, Playground F. And Mr. Carbenia, you have Freddy Bors, Brian's Park , Maple Playground, Schreiber, Vassar and Carl Weiss. I ask you to override the veto tonight to maintain the quality of life presently enjoyed in the parks in Canton's park system and to keep the beautiful green space we have-keep it free from crime, free from illegal activity for Cantonians and all visitors alike. For now and for the future of Canton's residents. Thank you.

## MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We are now under Miscellaneous Business. Is there any Miscellaneous Business?...

MEMBER SMUCKLER: Mr. President, pursuant to Rule No. 43 in dealing with the Mayor's veto, I would like to reconsider Ordinance No. 15/2003; seconded.

PRESIDENT DENCZAK: Moved and seconded to reconsider Ordinance 15/2003; are there any remarks?... If not, roll call vote please.

## NO REMARKS

## ROLL CALL: 11 YEAS, 0 NAYS

PRESIDENT DENCZAK: Member Smuckler, Ordinance No. 15/2003 is before the body.

# **ORDINANCE NO. 15/2003** AN ORDINANCE AMENDING EXHIBIT A TO ORDINANCE NO. 236/2002; AND DECLARING THE SAME TO BE AN EMERGENCY

MEMBER SMUCKLER: Mr. President, I move that we adopt by overriding the Mayor's veto Ordinance No. 15-2003; seconded.

PRESIDENT DENCZAK: Council is attempting to override the Mayor's veto. The motion is to adopt Ordinance 15/2003; are there any remarks under this reconsideration of the ordinance?

MEMBER SMUCKLER: Mr. President, I believe that the issue isn't who the park policeman is and I'm glad to see that that's not the issue-the issue was, after speaking with Mr. Black of the Park Board, after speaking with the Patrolman assigned to the parks, and after understanding that the Police Chief solely controls who's in the parks and when they're not in the parks, I believe that it's not too much to ask to have one officer assigned to the park system under the auspices of the Park Board. Somewhere in our budget, and I will look like the rest of you will between now and when we pass the budget, that we should be able to continue to find the money that it costs to fund this officer. I will be voting to override the Mayor's veto.

MEMBER CASAR: Mr. President, I too have spoke with members of the Park Board. I live in the area, I'm very familiar with the parks and especially Monument and Stadium Park. I know people don't want to hear this, but I don't want to see us go back to where it was in the 70s...and the problem we had in the parks. And sure our newspaper reported it's not like it used to be. The reason it's not the way it used to be is because we have an officer, a dedicated officer that makes his rounds in the parks....that issues citations when necessary. My concern when this whole thing started, if we lose the officer that's been there doing a great job and we depend only on the City Police Department to patrol the parks when they have the time to get into the parks, that concerns me. Especially with the new chief coming on board, he may see, think that we don't need a Patrolman, and that is very, very, very serious because as long as there's someone available and visible, a policeman's visible, the problems will not be as apt to happen as if nobody was there. I know that Mr. Thristino does a good job, I'd like to see him continue to do the job. And getting to the budget, I spoke with the Park Department, I am a member of the Finance Committee, and the Park Department has slashed over 16%. I think they've done more than their share. And I do not want to see the Park have to take more cuts. We must provide safe parks for our citizens to enjoy; visitors when they come to Canton, they must be safe for them, especially in the Hall of Fame area, so we cannot cut any more from parks. And to take this away, this \$64,000, because the budget is slim-yes, it is. And yes we will work some way somehow to make sure that we have this money to get it to the parks and make sure that it's there so that we can continue to protect the citizens of Canton and the visitors of Canton. And make our parks and keep our parks a safe, wonderful environmental for families to go and enjoy.

MEMBER DIAMOND: Mr. President, thank you, we currently have a Canton Police officer, not who stops in the parks when he has free time, but we have a bid position for an officer to be assigned to the Park Department. That officer has a gun, he has arrest powers, he has a radio to communicate. He has everything that we need within that park system. There was a time when we had no one in the parks over the last several years, for a variety of reasons. And the Canton Police Department responded to calls there. Every department in this City has been asked to cut personnel, to cut spending. It doesn't make sense if you have an officer dedicated to the parks with arrest power, and it's my understanding that the Park Police officer is allowed to issue citations, park citations. But if there are arrests to be made under City ordinances or State ordinances, he has to call a Canton Police officer to come into the park to finalize that arrest. I also understand that the Park Police officer does not have a weapon currently. I think that's unsafe for our police officer. Somebody sees someone in a uniform, they usually assume that they have a weapon. I think that officer is in jeopardy because he does not have a weapon. So when you're in a budget crunch and you have an officer who can do all the things that are required, who's assigned to the Park Department, why would we pay an additional \$64,000 for somebody who can't do all of those duties, not that he's not capable, but because he's not commissioned. Why would we have a duplication of services when we are looking for every penny we can find in this City? And the Park Department may have cut their budget by 16%, but I know there are other departments, I know the Street Department has lost people; they've cut more than 16%. To get this City back on secure financial footing, we have to look, I would like to have as many Park Police officers as possible. We don't have the money for that now. What we need to look at, where to put the resources that we can afford to do the most effective job. If you have someone who doesn't have the arrest powers, nor the weapon needed for some of these arrests, then it's a duplication of services. You would go with the one person that can do those things. So I will not be supporting the \$64,000 to pay for a Park Police officer. Thank you.

MAYOR WATKINS: Mr. President, just as a matter of information, I heard the figure given here that the Park Department had cut their budget by 16%, that's not an accurate figure. The accurate figure is 2.33%.

MEMBER CASAR: Point of information. Last...we just received some figures, but the figures that I had received earlier, it was like 16%. They didn't fill a couple positions that are vacant–now I'm taking that into consideration also, that adds on to it. I don't know if you're doing that or not. If you take the two positions they did not fill along with the other cuts, it comes out to over 16%.

MAYOR WATKINS: But you're asking to fill both positions?

MEMBER CASAR: That are not filled at the present time. And I'm not saying they're going to be filled or not–I'm not privileged to the...I haven't spoke to the Park Department. But I'm saying as of now, they have cut over 16% out of a budget that is to the bone anyhow. That Park Department does more for the money that's appropriated than any other department we have in the City of Canton.

MEMBER ALTIERI BUCHER: Mr. President.....

PRESIDENT DENCZAK: The Mayor still has the floor.

MAYOR WATKINS: Nothing further.

MEMBER ALTIERI BUCHER: I recall of a couple months ago when no one here at this Council wanted to lay off any Police officers at all, and as a matter of fact, we didn't want to reduce that amount of force that was, after we divided the ordinance up on this. For this primary reason, we can't really afford to do this any longer. The issue of a gun, Mr. Greel, who was on the Park Police for many years, had no gun as well. And as a prevention measure,

whether someone has a gun or not a gun at this point, I think that we need as much prevention as we can get. Prevention you cannot put a figure on, you cannot put a dollar figure on this person. As a matter of fact, quite frankly, it may be priceless. Each day, people stick ADT signs out in the front yard and don't have the service, not knowing whether they're going to get robbed or not. But yet they're willing to pay to put the sign out there. As a matter of fact, we had a whole City willing to go on strike a week or two ago because of insurance, because of the prevention aspect of it, to prevent bigger problems or illnesses or sicknesses. As a matter of fact, a month ago, what was it?, Tuesday, February 4<sup>th</sup>, I went to Crime Prevention Week where they honored all these people here for preventing crime. And the City of Canton was involved in this and the Police Department. On the back pages, I went through here, I noticed my brother's name and his partner on the back. In 1992, they received this award–both of them were shot. One, my brother may have been fatally killed-he never had his gun drawn. Luckily he had a partner that showed up, but they both got shot. Without that partner, he would have been plugged five times by a man he didn't expect to have a gun 'cause he picked him up numerous times. So when we talk about prevention, I think that having these people in the park prevents far more than we can ever put any price tag on at all. We need to all think about this because every time you see a cruiser parked out front, in front of the Federal Building, this is prevention. They're parked there for a reason, so no one else parks there. But they're not...they're unmanned. So when we talk about prevention, we need to address it in the proper manner that we do not believe there is a price on this at all. Thank you.

MEMBER MALLONN: Mr. President, yes, as Chairman of the Parks and Recreation Committee, I would like to see Officer Thristino kept on board. I feel that he does an outstanding job not only for the City of Canton, but the Canton City Parks. If you speak to people who visit the parks, he's very friendly, user friendly. People that visit the parks respect him and he's not only patrolling Monument Park and Waterworks Park and Stadium Park, but he is visiting and patrolling every park that is in each Councilmember's ward. I think he is an asset to our Park Department as well as our Park System, and I would like to see him kept on board. Thank you.

PRESIDENT DENCZAK: Any other remarks?...

MEMBER HART: Mr. President, yeah, it was said I contain the crown jewel of the parks in our park system and you know I guess part of my frustration here is because, you know, the Park Police, unless we hire one Park Policeman for every park and have him there for every shift, it's going to be really impossible to properly, you know, secure the parks. I guess part of my frustration is Stadium Park, the gates there are left open all night, even though it states on the front, you know, that they should be locked up. I can still get complaints from residents that are right along Monument Road looking over at 2 and 3:00 in the morning seeing vehicles, you know, pulling in there. You know, I guess there's issues and, you know, my own opinion is and...is that, you know, there could be a better job done, you know, to keep that crown jewel and those residents that live around there and those residents that use the park a little bit safer. Because, again, unless we hire 50 or 60 or 180 more policemen to keep them there, our parks aren't going to be "totally safe." But yet Officer Thristino's done a nice job, our Park Policeman has done a nice job. I've been down there at the parks as I travel through the City, I see them patrolling all the parks, I see our zone cars that are coming through the parks. And I think we're going to give people that false sense of security if we're going to be running a police state, having, you know, armed Policemen running through our parks all the time. And we do, I think, more than an adequate job of keeping our residents safe now with Officer Thristino and our Canton City Patrolman that's there.

## PRESIDENT DENCZAK: Any other remarks?

SAFETY DIRECTOR CONCATTO: Mr. President, first of all, I do believe and correct me if I'm wrong, but this ordinance was introduced by the Finance Chairman, is that not correct?...not by the Administration, but by the

Finance Chairman. So Council is looking at an ordinance that has been introduced by the Finance Committee Chairman for which the, it failed and which the Mayor vetoed...

MEMBER SMUCKLER: No, point of order....point of information.

PRESIDENT DENCZAK: State your point of order.

MEMBER SMUCKLER: It was not...the Finance Chairman, Mr. Mroczkowski was not the sponsor of this ordinance.

PRESIDENT DENCZAK: No, Member Casar was.

SAFETY DIRECTOR CONCATTO: Thank you, I wasn't sure if it was the Finance Chairman or Member Casar. MEMBER DIAMOND: Point of order.

PRESIDENT DENCZAK: State your point of order.

MEMBER DIAMOND: What happened was the Finance Chairman withdrew the salary of the Park Police officer out of the budget. As it stands right now, there is not a salary for this officer. After that, Member Casar proposed an ordinance to have that salary put back into the budget.

MEMBER CASAR: Mr. President, a further point of order. The reason this wasn't taken care of when we passed the interim budget back in January, I was going to move to reconsider that ordinance that particular night because when we realized it was inadvertently...or the Finance Committee Chairman left it out. I happened to speak to Law Director Martuccio and he told me because it was an emergency, I could not reconsider it that night, or it would have been reconsidered and hopefully it would probably have been taken care of way back in January. That's why we're here tonight with that matter because being that it was an emergency clause, we couldn't reconsider it that night.

SAFETY DIRECTOR CONCATTO: Mr. President, the point I'm making is that the money being removed out of the budget of the Park Department for the Park Police officer was done by the Finance Committee–a committee who has been meeting monthly for the last year and a half to try to get a handle on the finances of this City. Secondly, the idea of that was the money that would be saved from taking that money out of the Park Police, would go to the Police Department so that we don't have to go any further–we've already lost 15 Police officers and 18 Firefighters in the last year. If 2004 does not improve, we're going to have to lay off more. The idea was to be able to keep more Police officers and take that money and put it into the Police budget. That was the, and regardless of whoever's in the parks, the Canton Police Department, since it's in the City still has responsibility for the parks.

MEMBER CASAR: Mr. President, I'd like to ask the Safety Director a question if I may.

PRESIDENT DENCZAK: You may.

MEMBER CASAR: Safety Director Concatto, when this was first brought up back in January, did you or did you not tell this Councilmember that if we eliminated the Park position, the patrolman, that the City Administration, and you, head of the safety forces, would put not one but two full-time City Police officers in the parks?

SAFETY DIRECTOR CONCATTO: Yes. That was before we lost our Police officers to the armed services. They were called up.

MEMBER CASAR: Take this a little further-then did you not tell this Councilman that if we indeed vote to keep the position as the Park Patrolman, we would lose a City Policeman from the parks?

SAFETY DIRECTOR CONCATTO: If the Park Police officer remains, the Park Police position in the Police Department is still a bid position. If we have to lose more Police officers, that's correct, we would probably choose—we still have the responsibility for the parks. Regardless of what we do, we still have to have black and whites in the parks. But that's something that we would have...yes, that's something we would have to consider if we go any further down below the 174 we're at now.

MEMBER CASAR: My final question. Today, February 24<sup>th</sup>, do we have a City Policeman that's assigned to the Canton City Park Department...parks?

SAFETY DIRECTOR CONCATTO: Officer Henderson by the bid in the last bid sheet I seen, which was a week ago, is still in that position.

MEMBER CASAR: And he is fulfilling that duty in the parks daily?

SAFETY DIRECTOR CONCATTO: I would assume that. I have not...I am not sure of what his responsibility is, but his responsibility is a Park Police officer.

MEMBER CASAR: I take your word on that, but I was under the impression–I was told that he bid off of the job and he was no longer fulfilling those obligations. And that is the reason why I hang my hat on what I said earlier, don't fix something that's...don't try and fix something that's not broken. This has been working good. The Park Patrolman we have–let's keep it as it is.

PRESIDENT DENCZAK: Any other remarks?... The question you are voting on now is override the Mayor's veto. Roll call vote please.

NO FURTHER REMARKS ROLL CALL: 8 YEAS, 3 NAYS (SMUCKLER, CASAR, BABCOCK, HAWK, ALTIERI, MALLONN, MASSEY & CARBENIA VOTED YES. DOUGHERTY, HART & DIAMOND VOTED NO)

PRESIDENT DENCZAK: The Mayor's veto has been overridden; the law goes into effect immediately as through the Mayor had signed it. We're still under Miscellaneous Business; is there any Miscellaneous Business?...

MEMBER SMUCKLER: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call please.

NO REMARKS PERMITTED ON THIS MOTION -- ROLL CALL VOTE: 11 YEAS, 0 NAYS

PRESIDENT DENCZAK: This meeting is adjourned. (SOUNDS GAVEL)
