#### **MINUTES OF THE MEETING OF APRIL 21, 2003**

The regular meeting of Canton City Council was held on Monday, April 21, 2003, at 7:30 P.M. in the Canton City Council Chamber. The meeting was called to order by President of Council Ray Denczak. The roll call was then taken (as follows) by Clerk of Council Debbie Vanckunas. The invocation was given by Councilmember Kathleen Altieri Bucher, followed by the Pledge of Allegiance led by President of Council Denczak.

PRESIDENT DENCZAK: With a quorum being present, the Chair calls this meeting of Canton City Council to order. Roll call please.

#### AGENDA CORRECTIONS & CHANGES

PRESIDENT DENCZAK: Members of Council, before we proceed, the Mayor handed me a letter from George Davis which I think will be very interesting to Councilmembers. The Chair will read that now. It's from George Davis, the Administrative Assistant. Dear Mayor, I just got the final information and thought you'd like to know for tonight's meeting with City Council. Kiko Auctioneer Jim Gill notified me that the City will get a check on Tuesday afternoon for \$79,197.44 after all expenses as net profit for the April 12<sup>th</sup>, 2003 city auction and scrap sale. I'm delighted with this. This follows nearly \$187,000 put into the General Fund from three auctions in 2002. Our next auction will be June 28, 2003. We plan to have four before the end of the year because of the over-abundance of impounded motor vehicles. A copy was sent to Mike Miller and Joe Concatto. Agenda Corrections & Changes, Members of Council—you are being asked to suspend Rule 22A to add the Second Reading of Ordinances 5 through & including #18. The Chair will recognize that motion now.

MEMBER SMUCKLER: Mr. President, I move to suspend Rule 22A and add Ordinances 5 through 18 back to the agenda; seconded.

PRESIDENT DENCZAK: Moved and seconded to suspend Rule 22A to add Ordinances 5 through & including #18 to the agenda; are there any remarks?... If not, roll call vote please.

## ROLL CALL: 10 YEAS, 0 NAYS

PRESIDENT DENCZAK: Rule 22A has been suspended and Ordinances 5 through and including #18 are a legal part of your agenda.

MEMBER SMUCKLER: Mr. President, I move that we suspend Rule 24B and add a resolution to the agenda from

Council-as-a-Whole regarding the passage of the County Sales Tax; seconded.

PRESIDENT DENCZAK: Moved and seconded to suspend Rule 24B to add Resolution #42 to the agenda from Council Committee-of-the-Whole in regards to support for the County sales tax. Are there any remarks?... If not, roll call vote please.

## NO REMARKS

## ROLL CALL: 10 YEAS, 0 NAYS

PRESIDENT DENCZAK: Rule 24B has been suspended and the Council Committee-of-the-Whole resolution is a legal part of your agenda.

## PUBLIC HEARINGS

PRESIDENT DENCZAK: We had a scheduled public hearing for 7:30. I'll back to that place on the agenda. We went a little bit out of turn. The scheduled public hearing for 7:30 is a request by the Aultman Health Foundation to rezone the southwest corner of Dartmouth and 6<sup>th</sup> Street SW from R-1a to PB-1 for the Aultman heliport temporary relocation project. The Planning Commission recommends approval. The Chair now opens the public hearing in regards to this matter. Is there anyone in the audience wishing to speak for or against this request to rezone, please....

MEMBER SMUCKLER: Mr. President, did you forget something?...the statement.

PRESIDENT DENCZAK: I thought you'd make that when it came time to adjourn, but go ahead, make it now.

MEMBER SMUCKLER: Before the public hearing begins, I would like to welcome all those who came to this evening's Council meeting regarding the Aultman heliport zone change. If you are prepared to speak during the public hearing, we invite you by all means to do so. But before you do, I would like to inform you that tonight's public hearing will be continued to the May 12<sup>th</sup> Council Meeting. My office complied with both State and Codified Ordinances by advertising a public hearing notice in The Repository. However, due to clerical error, we did not notify <u>ALL</u> property owners of the public hearing. Ohio Revised Code Section 713.12 states that failure of delivery of the public notice shall not invalidate the ordinance. In the sense of fairness and so that all parties have the opportunity to be heard, my office has re-notified all property owners of the May 12<sup>th</sup> hearing. Therefore you may speak at tonight's public hearing, or, if you choose, return to the May 12<sup>th</sup> public hearing. By waiting until the May 12<sup>th</sup> hearing, <u>ALL</u> persons will have an opportunity to hear your testimony. I sincerely apologize for any inconvenience. This was by Debbie Vanckunas, the Clerk of Council, but I thought in all fairness, even though most of the Council people are not here on a daily basis, by law I end up being Debbie's supervisor, and I have to sign off as supervisor. And I will take responsibility for the office staff. The office staff did not do this intentionally, it was a clerical error on the number of letters they should have sent out. And like was stated in here, in the sense of fairness, we will make sure that everyone was heard before any vote's taken. You will also notice that two Councilmembers are not here this evening, and we are hoping at the following meeting on May 12th, that we might have a full contingent here that would also help with for or against, whatever any vote may be or may not be taken at that evening. Thank you.

PRESIDENT DENCZAK: The Chair now opens the public hearing in regards to this rezoning. Is there anyone in the audience wishing to speak for or against this rezone, please come forward. ...Please come forward, state your name and address and your position on this issue.

MR. FRIEDL: Ed Friedl, I'm am employee of Aultman Hospital, 2600 - 6<sup>th</sup> Street SW. As City Council is aware, Aultman is planning a \$93 million expansion to our main campus here in Canton. This expansion includes the construction of a new patient care facility, which will enable the hospital to meet our current and future needs in our health care market. In order to break ground for this facility later this summer, we need to temporarily move our helipad from its existing location to one of our parking lots located at the intersection of 6<sup>th</sup> Street and Dartmouth Avenue. Upon completion of the new facility, the helipad will be located permanently on top of the roof of the new building. Metro Life Flight in partnership with Aultman Health Foundation, has been a lifesaving resource serving the City of Canton for more than 3 years. In addition, Metro Life Flight has been serving northeast Ohio for more than 21 years. Metro Life Flight has a nationally accredited program, having over 49,000 safe free flights, making it the number one life flight program in the world. The location of the temporary helipad has been approved by the Federal Aviation Administration, the Ohio Department of Transportation, and Metro Life Flight. This temporary helipad will be completely enclosed by a fence; it will have 24-hour surveillance through 3 security cameras. In addition, Aultman security personnel will be present at all take off and landings. Aultman Health Foundation respectfully asks Council to approve this rezoning request to allow our temporary helipad to be located there. Thank you.

PRESIDENT DENCZAK: Anyone else in the audience?...please come forward.

MS. MCALLISTER: The residents of the surrounding area of Aultman Hospital, we do recognize the importance of the emergency medical heliport, although we request the City of Canton not to attempt to go forward with the heliport site without a fully developed report, and to proceed very carefully after gathering all the information...

PRESIDENT DENCZAK: Ma'am, excuse me, please. Please give your name and address for the record.

MS. MCALLISTER: Oh, I'm sorry. My name's Diana McAllister, 2707 Maywood Place SW. Okay, we're asking...

PRESIDENT DENCZAK: One moment please. You're speaking now under the public hearing, and you also signed up to speak under Public Speaks?

MS. MCALLISTER: Correct.

PRESIDENT DENCZAK: Okay, go ahead.

MS. MCALLISTER: Okay?... We're asking that they proceed very carefully after gathering all the information needed so a good decision can be made with all parties involved. Furthermore, we would request the report to include, but not limit it to what the effects and impacts are, related to the noise, the safety of the persons, and the safety of the properties involved. Also to participate in the decision-making process as suggested by the FAA. Thank you.

PRESIDENT DENCZAK: Anyone else in the audience wishing to speak for or against this issue, please come forward.... Is there anyone else in the audience wishing to speak for or against this issue, please come forward.... Is there anyone in the audience wishing to speak for or against this issue, please come forward.... Apparently not; the Chair....oh, I'm sorry, this portion of the....the Chair will now recognize a motion, Member Smuckler. Are you going to adjourn this public hearing?...

MEMBER SMUCKLER: Mr. President, I move we continue this public hearing til May 12<sup>th</sup>...

PRESIDENT DENCZAK: Adjourn the public hearing to a specific date.

MEMBER SMUCKLER: Mr. President, question for the Law Department. Is it continue or adjourn?...

ASSISTANT LAW DIRECTOR TATARSKY: (INAUDIBLE–NOT SPEAKING INTO MICROPHONE)

MEMBER SMUCKLER: Mr. President, I move we recess this public hearing until May 12<sup>th</sup>, 2003 at 7:30 p.m.; seconded.

PRESIDENT DENCZAK: Moved and seconded that you...what was the motion again?

MEMBER SMUCKLER: Recess.

PRESIDENT DENCZAK: To recess; are there any remarks?... If not, by voice vote, all those in favor, signify by saying aye--those opposed, no.

MOTION APPROVED BY UNANIMOUS VOICE VOTE

PRESIDENT DENCZAK: The public hearing in regards to the zone change is recessed until May 12<sup>th</sup>, 2003 at 7:30 p.m. So be it.

## PUBLIC SPEAKS (ORDINANCES OR RESOLUTIONS FOR ADOPTION ONLY)

PRESIDENT DENCZAK: We have several speakers signed up for Public Speaks under Ordinances or Resolutions for Adoption. The first speaker is Judge John Haas.

JUDGE HAAS: Good evening. Judge John Haas, Stark County Common Pleas Court General Division. I'm speaking on behalf of the sales tax for Stark County.

PRESIDENT DENCZAK: State your address, Judge.

JUDGE HAAS: 140 - 22<sup>nd</sup> NW, Canton, Ohio. I thank you for the opportunity to speak on behalf of the sales tax. This is a tax that will raise one-quarter of one percent, that's \$1 on every \$400 of goods and services. It's for an 8-year period. Right now, Stark County is the only county in the State of Ohio without any piggy-back sales tax, and even if passed in the May primary, we will still be the lowest in the State in terms of money raised by such a tax. I think it goes without saying that, what you've probably heard and read, that the impact of the defeat of the sales tax has been great on the criminal justice system. I'm speaking on behalf of all the judges of Stark County, including the Canton Municipal Court Judges, who have been deprived of jail beds, who have seen the situation at the Stark County Jail where booking procedures have taken much longer than would have normally been the case. Basically, on behalf of the criminal justice system, what we are saying is that our hands are being tied. It is a situation that is not one that the judges are speaking out of threats or fear factors, we are saying our hands are being tied. We are being forced to release individuals who should otherwise be incarcerated...a situation none of us want. And I don't think the public wants. So we are strongly encouraging your consideration and we're really appreciative of the cooperation of the City of Canton with Stark County services. And thank you very much for giving me this time. Judge Stucki had a few remarks he wanted to make.

PRESIDENT DENCZAK: The next speaker is Judge Stucki.

JUDGE STUCKI: Thank you, I'm David Stucki and I'm a judge in the Stark County Family Court, 110 Central Plaza South in the City of Canton, Ohio. And one of the mistakes that I often see lawyers make in my courtroom is to keep talking even after they've already won. I'm not going to make that mistake tonight because you've already passed the resolution and for that I thank you. And I believe you've done the citizens of this City, as well as all the citizens of Stark County, a great service. But I am here to ask you to take the next step, and that is to help us. This is a tax that's going to pass because people in government and otherwise are getting involved and they're working-person to person-with their neighbors and the folks in your wards and the folks on your street, and the folks in your church, and all the places where you'll be meeting people in the next two weeks. I sit on a number of Statewide committees and I often ask the trivia question-there's one county in the State of Ohio that does not have a sales tax, which is it. And, you know, you hear them say, well, it must be I don't know, Noble County maybe or maybe Brown County or maybe, I don't know, Williams County....no, it's Stark County. The seventh largest county in the State of Ohio. And frankly, it's an embarrassment. And I thank the City of Canton and your leadership for getting behind this effort, because as our county seat, you're having a big hand in allowing us to be successful on this vote. And we need to get the City of Canton, as well as the entire county of Stark moving forward again and take the handcuffs off of the judges, because that's where they've been placed as a result of our inability to effectively do our jobs. It's not just the justice system. I venture to say that the County budget crisis effects all of us, in the work you do here in the City as well as personally, whatever it is that you may have to do. from transferring a car title to refinancing or something of that nature, you're going to be effected. So I'm here to thank you for what you've done here tonight, and that is to support the resolution, but I'm also here to challenge you to keep working with us as we head into the election and let's make sure that we get this passed this time. I thank you for your time this evening, and I look forward to having your help from here on out. Thank you.

MAYOR WATKINS: Mr. President...

PRESIDENT DENCZAK: Just one moment....Judge, we haven't passed the resolution yet, we put it on the agenda. Okay, Mayor.

MAYOR WATKINS: I just want to thank Judge Stucki and, both judges for being here. Judge Haas, thank you. This is just as important to the City of Canton as it is to the judges for a lot of reasons, not the least of which is the fact that the booking procedure that we have to go through now is a revolving door. Our officers sometimes have to sit out there for 3 and 4 and 5 hours at a time to book 1 or 2 people. And the end result is that we turn around and let them loose again because we have to, we have no space for them. This is not, this is almost criminal in and of itself. These people should be incarcerated. They should have a sure date to be tried, and if they are convicted, should be forced to serve their time. But for the time that we spend, it's costing us a fortune from the standpoint of the City coffers and just having the booking procedure take that long. And then only to have to turn them loose anyhow. Thank you for your support, we appreciate it.

And I want to commend him for making that statement because I feel that if we do, that would really go a long way in revitalizing the downtown. Thank you.

MAYOR WATKINS: Mr. President, thank you, Member Casar, I appreciate the commentary. And we are serious about it and we think there is some very serious interest on the part of some folks who have not only the wherewithal, but the reputation that could sustain and support such a facility. And I'd like to remind everybody here present, since Member Smuckler forgot to do it, Celebrity Cuisine is tomorrow night.
