MEMBER SMUCKLER: Mr. President, I move we adopt Ordinance #26; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #26. Are there any remarks under this ordinance?... Very well, roll call vote please.

NO REMARKS ROLL CALL: 12 YEAS, 0 NAYS

PRESIDENT DENCZAK: Ordinance #26 is adopted. #26 ADOPTED AS ORDINANCE NO. 237/2003

#27 (3RD RDG) ADOPTED AS ORDINANCE NO. 238/2003 AN ORDINANCE AUTHORIZING THE MAYOR AND/OR DIRECTOR OF PUBLIC SERVICE TO ENTER INTO CONTRACT WITH THE YWCA OF CANTON, INC. TO PROVIDE A GRANT IN AN AMOUNT NOT

TO EXCEED \$50,000.00 FOR REPLACEMENT OF THE ROOF ON THE GATEWAY HOUSING PROJECT FACILITY; AND DECLARING THE SAME TO BE AN **EMERGENCY**

PRESIDENT DENCZAK: Ordinance #27 is adopted. #27 ADOPTED AS ORDINANCE NO. 238/2003

#28 (3RD RDG) ADOPTED AS ORDINANCE NO. 239/2003 AN ORDINANCE AUTHORIZING THE MAYOR AND/OR DIRECTOR OF PUBLIC SERVICETO CONVEY CITY-OWNED REAL PROPERTY, NO LONGER NEEDED FOR MUNICIPAL PURPOSES, TO THE CANTON COMMUNITY IMPROVEMENT CORPORATION; AND DECLARING THE SAME TO BE AN EMERGENCY

MEMBER SMUCKLER: Mr. President, I move we adopt Ordinance #28; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #28. Are there any remarks under this ordinance?... Very well, roll call vote please.

ROLL CALL: 12 YEAS, 0 NAYS NO REMARKS

PRESIDENT DENCZAK: Ordinance #28 is adopted. #28 ADOPTED AS ORDINANCE NO. 239/2003

ANNOUNCEMENT OF COMMITTEE MEETINGS

PRESIDENT DENCZAK: Announcement of Committee Meetings please.

MEMBER MROCZKOWSKI: The Finance Committee will at 6:30 November 24th, City Council Caucus Room.

PRESIDENT DENCZAK: Any others? Personnel? You're not gonna meet?

MEMBER DIAMOND: I'm on -- finance and personnel?

PRESIDENT DENCZAK: Yeah.

MEMBER DIAMOND: Okay. I'll be right with him.

PRESIDENT DENCZAK: Okay. That's it?... (NO OTHER ANNOUNCEMENTS)

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum. We have three people signed up to speak this evening First speaker is Paul Kemp.

MR. KEMP: My name is Paul Kemp. I live at 227 Chicago Place NW in Canton. As you may or may not know, I was here last week about Chicago Place. Well, they started work on Chicago Place on Thursday of last week, and I want to thank you for doing it quickly, but it's too bad it took so long to get done. Well, it isn't done yet, but they're working on it. Thank you.

PRESIDENT DENCZAK: The next speaker is Al Sciddurlo.

MR. SCIDDURLO: Good evening. I got three minutes to say...

PRESIDENT DENCZAK: Wait. State your name and address.

MR. SCIDDURLO: Oh. My name is Ohofrio Sciddurlo. I live at 2113 Clearview, and the reason why I'm here tonight is about last week talking about the Wal Mart coming to Canton. And, what I heard about from Mr. Councilman Casar over there, he was very -- I was with him to open a Wal Mart on 62, because when I find out that the Wal Mart was coming on 62, me, myself, I was trying to open a place right across from this Wal Mart. The City shut me down. So, my question is, if you guys don't want no business on 62, why are you pushing the issue for Wal Mart to be on 62? The City shut me down on 62. I had a brand new place, carry-out and delivery. They threw in my face that I needed a handicap access, handicap entrance, handicap bathroom, handicap this, and the place was carry-out and delivery. A year and a half ago I lost \$32,000.00, if anybody in this room cares about that. I heard oh, your lawyer, he made a mistake, your architect made a mistake. He took, the City Building, to review three pages from my architect, eight weeks to deny me. I paid the fees with no problem. The only thing I didn't do right, I didn't get no permit, so I apologize to the City Building. I told them you explain it to me what I should do. They laughed in my face. And I even took the Director of Safety, Joe Concatto, to the place at that time to show him the place the way it was. Brand new place. I mean, everything was new, electric line, water line, gas line, everything new. Equipment, hood system. They shut me down. So what do you need a Wal Mart on 62? For what? Nobody wants business in that area. That area is a dump. It was a dump, it will be a dump, is gonna be a dump, because nobody wants business over there. You guys proved it to me a year and a half ago. I did everything that the Building Inspector told me to do. I hire an architect. It cost me \$3,000.00. How long does it take to review three pieces of paper? They let me wait eight weeks. I had to pay \$150.00 for nothing.

PRESIDENT DENCZAK: Sir, I'm sorry, but your three minutes are up. Bring your remarks to a close.

MR. SCIDDURLO: And, another thing. I'm still waiting for tomorrow.

PRESIDENT DENCZAK: Safety Director, can you enlighten this Council body as to what took place there?

SAFETY DIRECTOR CONCATTO: Mr. President, the pizza shop that Mr. -- that Al is talking about, one of the issues that was dominant in the building inspection was the hood. It was not a new hood, it was a used hood, and the hood -

the fire suppression hood - did not pass the inspection. Mr. Casto - Al - was notified of that. He did proceed with that work without permits, therefore, the electrical work that was installed was not installed -- we don't know -- we didn't know at that time how the electrical work was installed because it was installed and covered up after the permits were taken. This has been three or four years so I don't really have all the information. I did go out to the business. I did review it with the Building Department, and we continued to try to tell Al what the changes were that had to be made, and at some point he decided not to continue the business.

PRESIDENT DENCZAK: Okay. Thank you.

SAFETY DIRECTOR CONCATTO: If I may, Mr. President. One other thing. I have your check, Al. It was mailed to you October 30th, and you refused to sign for it.

MR. SCIDDURLO: Impossible.

SAFETY DIRECTOR CONCATTO: Well, it's right here.

MR. SCIDDURLO: What time did it -- I never received anything because if I receive something, I will sign.

SAFETY DIRECTOR CONCATTO: Al, I'm not gonna sit here and argue with you. I'm just saying I do have your check now. I'll be glad to give it to you after the meeting.

MR. SCIDDURLO: Okay. That's not a problem.

PRESIDENT DENCZAK: Take care of this matter after the meeting, alright?

MR. SCIDDURLO: I need some more time if I can?

PRESIDENT DENCZAK: No, unless Council allows it. I...

MR. SCIDDURLO: Greg Hawk?...

MEMBER HAWK: Two more minutes?...

PRESIDENT DENCZAK: Make a motion.

MEMBER HAWK: We'll give him two minutes to finish his speech; seconded.

PRESIDENT DENCZAK: Are there any remarks?... If not, by voice vote, all those in favor signify by saying aye. Those opposed no.

NO REMARKS

MOTION APPROVED BY UNANIMOUS VOICE VOTE

PRESIDENT DENCZAK: Sir, you have another two minutes.

MR. SCIDDURLO: Okay. How can it be that I approves—I think I still got it—from the Fire Marshal of Canton, Ohio, come in the place, inspect the hood and pass me with flying colors, yet could not pass from a Building inspector? That's my question. How can a Fire Marshal that inspects the hood and tell me that everything is perfect have to spend \$20,000.00 into a hood system, how can the Building Department tell me that the hood was used? It was not used, I still got the hood. The system inside, I bought it from Pits Fire from Massillon, brand new system that I got on file. I would like to find out why this Building inspector has got to tell me that the hood was used and they tell me that the hood was put together piece by piece. That tells me that this Building inspector needs to go back to school, because I still got the hood, it's all one piece. I still got the older system inside of this hood. I got it in my garage collected dust, brand new, with the receipt that I used Pits Fire. The answer from the Building inspector was, why don't you use Josh, and my answer was who the hell is Josh? I don't have to use anything that you suggest to me. That was it. The hood is brand new. The electric was already there. That's all I had to do was connect the equipment. Okay? They were mad because I didn't get the permits. You know, over here you guys are gonna speak the truth. I don't want no bull, b.s., because it's not right what you guys did to me. \$42,000.00 you guys took, my three kids' money from college, away from me. Have a nice life.

PRESIDENT DENCZAK: The next speaker is Ken Kocinsky.

MR. KOCINSKY: My name's Kenneth Kocinsky. I reside at 427 Wells Avenue NW, Apartment #3, and I just want to make a quick proposal here. Going through Canton's Comprehensive Annual Financial Report, on page 41, note 5, Deposits and Investments. It says, "Deposits: At the year end the carrying amount of the City's deposits was 20 million, 448 thousand, 635 dollars and the bank balance was 21 million, 697 thousand, 787 dollars. Of the bank balance, 740 thousand was covered by federal depository insurance, and 20 million, 957 thousand was uncollateralized and uninsured." It says this is the deposits the City's been making to Star Bank. "Although the pledging bank has an investment security infull use to collateralize all public deposits which are held in the financial institution's name. Non-compliance with federal requirements could potentially subject the City to a successful claim by the FDIC." So, I wanted to suggest that maybe we could put that money into a no load bond fund and do payroll out of ADP or Key Bank. I don't know. I just, you know, I thought I'd suggest like maybe put the money in a bond fund instead of leaving it uncollateralized in a bank where it might get stolen. Thank you.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We are now under Miscellaneous Business. Is there any Miscellaneous Business?... Is there any other Miscellaneous Business?...

MEMBER SMUCKLER: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.
