His heart will forever be with Canton and its people." And, I think that says it all because this Mayor has been very concerned about the people of this community, he's been very concerned about each and every Councilmember, and he's always been concerned about what direction this city's headed, and, I congratulate you on your 3 terms, and I very much hope that shortly after all this is over that we can get together. Thank you, Mr. Mayor. (*Applause as he receives commendation*)

MAYOR WATKINS: Thank you very much Bill. We've had our ups and downs and our battles and differences from time to time, but it's been a real honor and a pleasure for me to serve with almost everybody that's here tonight. A lot of the folks that are here tonight were here when I started and I'm looking at Member Smuckler, Member Casar, Member Babcock. Mr. Mallonn, I was with your dad before you and going around the table, Debbie Vanckunas was here then, Joe was in the Law Department, and Ray Denczak was here when Noah floated the boat. Mr. Perez, Mr. Mroczkowski, all you good folks, and Mr. Dougherty you weren't here in the beginning but you came along shortly thereafter.

MEMBER DOUGHERTY: Oh, I was here.

MAYOR WATKINS: Because when I came in, Bill Healy was the Councilman, the first time, and Rosemary and Joe, Richard. It's been a wonderful opportunity for me to serve. It's been a great pleasure for me to have had an association with all of you folks and while we have differed from time to time on issues, I don't think that I've ever once questioned your integrity or your honesty or your devotion or your love of this City, and that has made a big difference as far as my life is concerned and as far as my opportunity to serve. I'm grateful for that. I'm not gonna get maudlin here tonight. Somebody told me earlier, don't get maudlin, and I won't. But, we've had some good times and some bad. We've had....I could go down for, with everybody sitting at this table and go through some interesting history that we've had. RA, I started out with your dad, but he was in Council then and later then became the Auditor. We had a lot of good times and I still remember your momand she was at Light Up Downtown this last time. And it was very fascinating for me because there she was, in a wheelchair, but she had to come down for Light Up and I re-introduced her to my daughter Malia. JoAnn was the nurse for Dr. Graham at that time and she used to hold the kids when they'd get their shots and always good took care of them and we're grateful for that. Joe, we've...I've known Joe with the Fire Department and now as Safety Director. I'm grateful for that opportunity to serve together. And Mike, I can't begin to tell you how much your services have meant to me personally because you were always there. You were always there when I needed you. Joe Martuccio, I appointed you to your first job as Law Director. Somebody said, "Are you out of your mind, you're supposed to appoint a Republican?" I said, "gee, you mean he's not a Republican?" Ray, we go back an awful lot of years together, all the way to the time when I was fighting you about putting a fence in front of your house. I had to say that. I said it before so I had to say it one more time.

PRESIDENT DENCZAK: Get the correct nomenclature, it's not a fence it's a guardrail--and I'll probably never get a chance to do it again, but your 3 minutes are up Mayor.

MAYOR WATKINS: I think I could get you overruled right now, with half the house yet to speak. Debbie, we started out way back with you in Council. You were a clerk there at that time, not the Clerk but you were an employee and we go back a long ways so I'm grateful for that, and your sidekick there, I haven't known her that long but, she's done a good job and we're grateful for that. Kim, we fought, I remember Kim when he was just a little guy and he ran around with my nephew Mike and he would get out of line and I'd slap him up side the head. I swear, didn't I?

AUDITOR PEREZ: We had our days.

MAYOR WATKINS: Yeah, but they were both pretty wild young men, but we had, we had some good times with my brother George. And Craig, it's been real good knowing you and working with you. You've been a credit to your Ward and to the citizens of this community and you've been very, very caring. John, you know, I've known John for a lot of years. I knew him back in the days when he was still a big muckitymuck with the Union. We didn't fight then either, did we? We got along well, and John's been very, very supportive of the things we've tried to do that I think were productive and valuable to the City and I thank you for that service. And, Dougherty, I don't know what to say about him because this guy gave me more trouble since I've been Mayor in 12 years than anybody I've ever known.

MEMBER DOUGHERTY: Thank you.

MAYOR WATKINS: Constantly! 3:00 in the morning the phone rings and he says "I got a problem." I said "Why don't you call the Saf...Service Director?" "Well I did but he's not available." But we would go out and we got together and got things worked out, and I'm grateful for that and I appreciate it and we did the Light Up in the NEAR area for a number of years and your kids, you know your kids like me better than they like you.

MEMBER DOUGHERTY: Yeah.

MAYOR WATKINS: Richard, our stay together hasn't been quite as long but it's been very eventful and one of these days, one of these days, Richard, you're going to find a Mayor who will find \$250 million to build a zoo. And that will be the crowning achievement of your life and I know that.

MEMBER HART: That and recycling.

MAYOR WATKINS: And recycling...Yeah. But, I thank you for your service and your friendship. Rosemary, we go back an awful long way too and I'm grateful for your friendship and that of your husband Don and worked with him in the Police Department and a lot of other areas too and that's been a good thing for us and a good thing for me. And, Joe, you're now the Councilman of what used to be my ward. And our association goes way back to the Fire Department when you brought in Uncle Guido from Youngstown to hold a gun at my head to sign a contract. And you did.----I'm kidding. We're talking about Rocky Russo who was in the negotiation process with us and he came from Youngstown and we went to a meeting, a dinner at the 4 Winds and Rocky got up at the lectern and if you've ever, for those of you who don't know Rocky, he's kind of a bald-headed fellow, stout, short, but he looks like Uncle Guido, I swear he does. And he reaches in his pocket and brings out a 38 and puts it on the lectern. And he looked at me and he said "Mayor, we're gonna have a contract when we leave here tonight, aren't we?" We did, I didn't argue with him. I'm not arguing with a guy with a 38 in his hand, but that's been a lot of fun and some good years together. And all the folks that are here tonight, many of you that I've known from the Press and from other areas, thank you. Thank you for everything you've done and everything you've been to my life. And our Union friends who we've worked with for so many years. I guess I could talk for an hour and a half but the President won't allow me. But, I am grateful and it's been a wonderful opportunity for me to serve, a wonderful opportunity to make some great friends over the years. From the bottom of my heart and that of my wife, and my family, thank you for your friendship and thank you for your help. Anything that I ever did that was worthwhile, I never could have done without your help and your support. So I am grateful for that and I will never forget it. Thank you much. (APPLAUSE)

MEMBER SMUCKLER: Mr. Council President, can we go back to Resolution #91?

PRESIDENT DENCZAK: We will go back to Resolution #91. Madam Clerk?...

And take it even a step farther in working very closely with Member Hawk on adjoining problems in wards including ward cleanups and also dealing with the Weed and Seed Program which I hope, in the future, does get off the ground. You've had a short stay here Kathy, but, I think it's been of benefit for everybody to have you here and I wish you the best of luck in the future. (APPLAUSE)

MEMBER ALTIERI-BUCHER: I just wanted to thank all of Council and it's been a privilege working with everyone here and including Mayor Watkins as well, I said that before in my article, and it's been very enjoyable and it's nice meeting the new girls in the office too and including Debbie. Thank you very much. Bye-bye. (APPLAUSE)

PRESIDENT DENCZAK: The Resolution is adopted.

MEMBER CASAR: Member Smuckler, it is my privilege and honor to give this Resolution to you from this Council-of-the-Whole. I just want to say that as elected Majority Leader for next year, I just hope and pray that I can do the job that you were able to fulfill. I know the dedication you've had over the years as Councilmember and also as trying to lead this Council is very great and very appreciative by many members of this Council. And I know that if it wasn't for your leadership, we probably wouldn't have accomplished as much as we have accomplished, especially this last year. As you know, Bill, in the past we've had some rocky moments between us also-- but also in the last 2 years, 3 to 4 years I should say, we've learned from each other's mistakes, we learned to cooperate, we learned to get along and we did get along, and we did get along and I want to commend you, Bill, for the wonderful campaign you put on just lately and I, you know, things just didn't come your way. But I'd also like to say that this is the second time you're leaving Council and I too left Council 2 times, and came back the third time so I'm sure if you choose to come back, you'll be back here. And again, good luck and congratulations for everything you've done, and for you and your family, God speed. (APPLAUSE)

MEMBER SMUCKLER: Some 28 years ago, I joined Canton City Council fresh off a Council victory that led me to believe at the age of 28 I could climb any mountain. A number of times, I chose to climb mountains whether than walk through the valleys. What I found was as the years went on, I grew older and the mountains got higher. At the age of 48 and a whole lot smarter for the experiences in government as well as in life, I pursued a dream. In August 2002, I announced for Mayor of Canton, knowing full well only a small group of followers led by long-time friend Donna Weiss, Greg Hawk, James Carmen and my family would help me scale a mountain in the Democratic primary. Thank you for your friendship and sticking your neck out for me and my family. My wife who stood there 20 years ago ready to scale the first mountain and ready to climb every mountain in between, would stand again to help me obtain my dream. Randi, thank you for giving me the chance to dream. Missing there were 3 followers who would climb mountains for me anytime I called, Ralph Sussman, Mike Cirelli and former councilman Dick Davy. In death, I miss you all so much, especially the last election. The primary victory was bittersweet knowing the General Election cast was limited and the mountain which lay before me looked insurmountable and I didn't know which way to turn. What happened, as so often does in my life, a rescue attempt was made. Once again, someone else who would climb mountains for me and not ask for anything in return, Tom Harmon, would re-enter my life. Tom Harmon had offered me help, kindness and direction when I didn't know which way to turn. Tom gave me the confidence I didn't have, the ability to bring people together who I had alienated, and the capability to see things differently than I have seen over the last 20 years. Tom Harmon, you taught

me the meaning of giving and I will always be indebted to you for that. With 1 or 2 exceptions, all of you in City Council gave your support, endorsements and some of your time to go door to door with me. I will forever remember what it took for you to come to my rescue. You will always be remembered and I'm only a phone call away to help you climb any of your mountains you have. Even though I was unsuccessful and was not elected Mayor of Canton, I learned some valuable lessons in climbing mountains which I would like to share with you during this last Council meeting of 2003. Enjoy the power and beauty of your youth -- you will not understand the power and the beauty of your youth until they have faded. You can't grasp how much possibly lay before you. Remember the compliments received, forget the insults. If you succeed in doing this, tell me how. Get to know your parents, you never know when they'll be gone for good. Be nice to your siblings, they are the best link to your past and the people most likely to stick with you in the future. Appreciate the innocence of your children, stop to smell the roses with them because all too quickly seasons change, the roses will wilt and your children's youth will fade into memories. Understand that friends come and go but for the precious few you should hold on. Work hard to bridge the gaps in geography or in lifestyle because the older you get, the more you need the people you knew when you were young. Be careful whose advice you buy, but, be patient with those who supply it. Advice is a form of nostalgia. Dispensing it is a way of fishing from the past from disposal-wiping it off, painting over the ugly parts and recycling it for more than it's worth. This holiday season, more than any holiday season has taken on a new meaning and a chance to reflect on my 20 years in government. For those of you I've hurt along the way over the last 20 years, I apologize. For those of you who have helped along the way, I am glad I was given the opportunity. For those of you who have climbed mountains for me, I am grateful. As I leave Canton City Council and look for the next mountain to climb, I can't say good bye, but just let me say until we meet again. Thank you everybody. (APPLAUSE)

PRESIDENT DENCZAK: As the Presiding Officer, I haven't had an opportunity to speak tonight. I'm going to make it very brief. Bill, you are one professional campaigner. I recall when you and I ran in the Democrat party for President of Council, you conducted a very professional, high-caliber campaign. In fact, I think if the election was in another two days, I would have probably voted for you myself. But your voice will be missed in this Council and I'm sure we'll see you again somewhere on the political horizon. Who's next? Kathy Altieri, you are a dedicated Councilperson. You did wonders for your area, for your ward and for your city and I'll miss your voice also. Craig Massey, what can I say?—your ward is the ward that got me started in politics, the 4<sup>th</sup> ward. And it's a good ward to come from. Believe me, I know that you've done a dedicated job for the people of your ward, for the City of Canton, and you will too be seen on the horizon in the future. What's that? Oh, the Clerk said speak into the microphone. I don't wanna speak into the microphone, I'll probably start crying. John, I admired your tenacity when you took over as Finance Chairman. I knew it was a big problem, but I knew you'd be the type of caliber of a person that could handle the job. And I'll miss your voice here also. Who else, is there anybody else?... RA Mallonn, oh, you got re-elected, didn't you?... (laughter) I'll miss all of your voices, you were a credit to the community and to your particular political party.

We'll have the swearing in ceremonies and immediately following we will have the regular business meeting, the first meeting of the new term. MEMBER HART: Mr. President, just one person I want to thank Mike Miller for everything he's done for me in Ward 7.

MEMBER MALLONN: Mr. President. Yes, I would just like to personally thank Member Mroczkowski, Member Massey, Member Altieri, it's been a pleasure serving with you folks the past several years and you are definitely an asset to the City of Canton in your Ward and you will be greatly missed. To Bill Smuckler, Bill, we haven't always been on the same page for the last 7, 8 years, but in the last 6 months or so, I think we became close during your election bid for Mayor of the City of Canton. I truly appreciate your friendship, we've grown closer in the last couple of months and I consider you a true friend. You will be greatly missed and I'm looking forward to seeing you back here in the next couple years. To the Mayor. Mayor Watkins, thank you for everything. You've always been there when I've needed you. You never played party politics and whenever I've called you, you've always been there and tried to assist me and the constituents of Ward 3 and, while we're commending people, I would personally like to commend our Service Director Mike Miller. Michael, when I was elected 8 years ago, I think it was the first week I was thrown into the fire in regards to the widening of Whipple Road and I was very new at this political game and you were right there along with Smuckler to guide me through that. And Michael, I want to personally thank you for everything you've done for me throughout the past 8 years. You've always been there and taken care of my problems and the constituents of Ward 3. So to each and everyone of you, happy holidays and everyone of you will be greatly missed. Thank you.

MEMBER DOUGHERTY: Mr. President. Yeah, I too want to thank all of you Council people who are leaving. I appreciate your dedication. You're all very honest people and that's very important. Bill, thank you for everything. You were a true leader. Thank you. Mayor, I thank you and Bill you too, when you guys go through Ward 6, you'll see things you were a part of that'll be there forever—new day care centers, golf courses, Mahoning Road Plaza--you guys were a part of that. So come over and visit any time. Mike, I think I was here 2 years before you came and I called you the first day you were here and I have called you, and I think I have called you every day since. But, anytime I called you were there, 10:00 at night, 1 in the morning you were right by my side, no matter what the problem was. You never gave me an ounce of problem, always willing to help and take care of things. That, I'll never forget. Thank you.

MEMBER DIAMOND: Mr. President. There's one quality that both the Mayor and Bill Smuckler share, and that is, that they look at every issue that came before this body as to how it would effect the citizens of Canton. Dave Dougherty just gave you a laundry list of what Mike Miller and the Mayor have approved for his ward and that's a testament to the Mayor, never, ever playing politics with these Council people and more importantly, the citizens of Canton. If the Mayor thought it was a good idea, he didn't care if the sponsor was a Democrat or a Republican. He was a man of integrity and a true leader and those qualities came from our majority leader and also from the Mayor, so I thank them both. And I really think there should be a trophy that goes to Mike Miller because, despite what I'm sure Mike Miller thought of many of us, many different times, he very rarely lost his temper, he always patiently explained his position and he was always accessible. of steel workers that's been drinking from 4:00 to 7:00 and I remember the comment out of them, "Let's shoot him". Willie Moore stood up and says "hey, they'll be no killing here. You guys go down and get some more beer", and they ushered John out the back door. But, we have a long history, John, and I think we're going to have a long future also. Craig, I'm going to miss your comments, every time I walk out somewhere and hear Carl Munday. Craig has called me that, I think, since he's first come in because he's always asked me what's up, what's going on and where's, ya know. Craig has a lot of energy and good luck in your future endeavors. Kathy, I remember when you first ran against Peel Coleman. I said "Peel, why is she running against you?" "Oh, I pissed her off," he said. He says, "I can't get that damn store down and she's going to run against me until I get it down." Well, he got it down, Kathy, no, is it?...did he get it down? You couldn't get it down, he got it closed off. He got it shut down but he couldn't get it torn down and I know that was one thing in that area that needs to be done and hopefully it will be done with the new Chief of Staff sitting there. We've had, we've had everything that memories can ever be there for and I appreciate everything that we've done and everything that we've worked together for and just want to say thank you. Michael Miller, we went to school together, I've known you for many years. Some people call you arrogant, conceited, and I agree with them. But, you have this photographic mind that you remember numbers, you remember things off the top of your head that's unbelievable. Sometimes I don't believe everything you remember, but you can always throw something out in the wind. Mike, you probably could cover the worst nightmare and come out smelling like roses. You always seem to have that ability. So, good luck in your future and I think no matter how far north you go, you should have a pretty successful career. And last but not least, I'd like to, Bill, we grew up together, we've been friends forever, we've been political allies, we've had our battles. I remember a gun issue when you brought your daughter in. And you used your own daughter to defeat an ordinance that we had down here. Bill is probably a political analyst at the best, I mean, he can look at things, figure out the way things are going and know which way his constituents want him to go. I'm more like the bull in the china shop that just tries to knock all the china over than to go that route. Bill, you know, you worked hard, you probably, of everybody I've ever known running for office, I've never seen anybody change as much as you changed this last election. You've went into rooms of 3-400 people, and you used to feel so uncomfortable, and you could walk up to everybody in that room and say hello. I watched you do things that you never did things in the past, you've done everything that anybody could ask when you ran for office and, I'll tell you what, as one of your supporters, I could never ask any more of you and I know that you will be back in the future. And, you know, January 9th, we'll sit and talk.

PRESIDENT DENCZAK: Any other miscellaneous business? ... Mayor and then you.

MAYOR WATKINS: Just one brief addendum to everything that I've said already and that is, this is to Bill. We've had a lot of fun and a lot of fights and a lot of good and a lot of bad things that have gone on over the years. I think it's important that I say this. Your political career is not ending, mine is, yours is not. You are very young, inexperienced, but you're getting a lot of experience as you go along. But the kinda guy Bill is, he came out on election night and he came down to the Marriott Hotel after the election results were announced. He brought his wife and children along to congratulate the winner. This was a class act. And Bill is a class act and so is his family. It's been my pleasure to be associated with all you all these years. Thanks, Bill.

MEMBER BABCOCK: Mr. Chair.....

PRESIDENT DENCZAK: Law Director and then Member Babcock.

LAW DIRECTOR MARTUCCIO: Thank you, Mr. President. I have one word for all of our leaders who are departing as they're in transition. One four letter word and it's love. Despite all our differences in generations and parties and approaches and in the way some of you demonstrate your love, sometimes, not always, normally, the one thing that you all have in common is a love for the city. The two newer folks, you had the misfortune of coming in during a down-cycle The older I get, the more I'm convinced everything moves in cycles. And you happened to ride into a rough cycle, but you rode it well. Never losing sight of your constituents and their needs. John Mroczkowski is a manly man who brought a sense of calm and diplomacy when we needed it most as Finance Chairperson. He bridged the gap between management and labor and did it as well as any diplomat could do. Bill, you have blossomed into an amazing leader. You have all of the qualities that go into that ingredient of intelligence, wisdom and experience, and I know that you will make better use of it in one way or another. Mayor, Mike Miller, your team has always made us feel welcome. I have always felt trust, and friendship and support on the 8th floor and all of the things we've done together through all of these years. Mike, your passion is exemplary in terms of your detail, work habits, your devotion to your kids and your hobbies. And the Mayor is a consummate definition of the word gentleman. So, as we transition out one third of our Council and a three term Mayor and a three term Service Director, I feel privileged to have worked with all of you. Be proud, I know it's been a rough time but if we keep pace as we do, with news reports, you Council, Administration, Auditor, Union Leaders, these Unions particularly, have the foresight well over a year ago to see what was coming to most of the cities, most of the states and the federal government. You saw it coming well in advance of many others and called it for what it was and dealt with it. Now, we didn't resolve all of our differences, but you were able to avoid a lot of the misery that some of our neighbors are going through in Columbus, Cleveland, Toledo and last week Pittsburgh was written up in the paper as the city with a new convention center and a sterling future whose credit rating is now at junk bond status. So, it's a credit to you, all of you, with all of our differences that we were able to ride that through. I'll conclude by saying a quote from one of my favorite authors, one of my favorite books and it's very timely of course at this time of year, and that is "God Bless Us Everyone."

PRESIDENT DENCZAK: Member Babcock.

MEMBER BABCOCK: Well, I've been in Council about as long as anybody and I was acquainted with all these people before I got in Council. All but Greg and Kathy. And, Mayor, the Mayor and his wife and me are real good Indian fans so we got to be real friendly. The Mayor has always been a friend of mine. He used to sit behind me in Council before. And Mike, I, Mike knows that I think a lot of him and I think that I tried to see that he held his job but I guess I didn't do any good. But I want to wish everybody good luck in the next couple years, I think some of them will be back

PRESIDENT DENCZAK: Member Casar.

MEMBER CASAR: Mr. President. Mr. President, I'd be remiss if I didn't say something in regards to the...first of all, the four Council people, Councilpersons that are leaving here, it goes without saying, my respect and my thanks that I can personally give them for their diligent, hard work that they've done to help Canton get back on its feet, it's going to become the city that it used to be and probably better than it used to be. That goes without saying. But I would

especially like to say thanks to the Mayor. Mayor, you and I been came into government together in 1970. Got swornin in these Chambers here. We served together for 10 years in Council and a couple years as Majority Leader-- and especially you as Minority Leader because the Republicans never have bee in the majority in Council. And I want to say that even though we had many disagreements, we were never disagreeable. After we discussed what we had to do on the floor, we went next door and had a soda pop or whatever. And, I thank you for your friendship that we've grown stronger over the years, and hopefully it will continue with your wife and my wife being friends as we have been with you all these years. And I just want to thank you for the opportunity to be your friend all these years and continue to be. And Mike Miller, I'll never forget in 1992 when you came in as Service Director and I said to Dick, I said, where did you get that guy? I mean, that's exactly what I said. And you told me at that time, you said, he's young, he'll learn. Well, I just want to say, Mr. Miller, Mike, I used to call another individual the best Service Director I ever served under, but I must admit, you are the best Service Director I have ever served under and it's going to be a sorry state of affairs around here without you. And I honestly, truly mean that because you have done a yeoman's job for any councilman that ever asked you to do something for them. But you know every project that's going on and you've known everything that's gone on for the last 5, 10 years past and you know what's going on in the next 5 or 10 years ahead. You're a remarkable individual and I really welcome the opportunity to have known you and to continue to be your friend, especially we have grown to be friends in the last 6, 7 years. And I really appreciate what you've done for this city because you are true Cantonian that's worked hard for your city and I only wish, and I mean this, that you were coming back here on January 1st because this city is dearly going to miss you.

MEMBER CARBENIA: Mr. Chairman. You can't see this far, I know you can't. But, I would be remiss if I didn't say something. I think that I would like to thank all of you for working with me and for me and, Bill, you taught me a few things. You taught me how to count, that's an inside joke, but he taught me how to count. This last 6 months, I think we did get fairly close, I think you helped me by walking in my ward and I think I helped you by walking in our ward. And, I would like to thank you for all the time that you have put in city council because I've known you for quite a few years. Even though I didn't go to school with you guys, since I'm older, I still enjoyed the friendship with 'ya. Kathy, I had a good time negotiating, or working with you on some of these things that are coming down like Habitat for Humanity and all the things that you've done. You've done a great job, I'm sorry to see you go, but I know you're going to be trying to come back. Mayor, I've known you for a long time, a long time. You were my councilman, years ago when I was President of Firefighters, I'll never forget you coming forward and helping us, always helping us, even as a councilman. And Mayor, I think you've helped all the city workers, you've given them a good living wage, and I think that they all appreciate that once, in the future years, I think you'll be one of the better Mayors that's served this city. Mike Miller, I don't know about you buddy. They say he doesn't get mad but I think he gets it all off when he plays basketball. You know, that's where he gets his frustration and anger out. But, I'll tell you one thing, I think he's the best Service Director that I've ever seen and I've seen a lot of Service Directors here and negotiated with them too. And I know one thing, he always tried to do what was right and you are correct about a person that can look down the road 5 years ahead. He could look down the road and see that. I hate to see you go, I wish we could have kept you. Mr. Massey, I've known you for along time too, when you were a young man. I knew you when you played football with my son, and you've grown up to be one hell of a guy and I wish you, I wish you, all the happiness in the world. I hope that you can be one of the Legislators. I hope you work hard and I hope you achieve that. And now my buddy John Mroczkowski, I've known this guy for many years. We grew up together, me, him and Dan Sciury. Dan Sciury used to shine our shoes (laughs), and I know one thing, this guy was tenacious when it come to negotiating. I've been with him many, many times and I would pick this guy to be with anywhere, under any conditions, I would pick this guy. I don't know how you guys talked him into being Finance Chairman, that's one time I only thought, that's the only time I

ever thought he didn't know what the hell he was doing. So, at that, I hope everybody here has a nice holiday. Thank you.

MEMBER HAWK: Mr. President. I would like to thank Members Massey and Member Altieri. Two years ago we came in here together and we worked in the spirit of cooperation. That's something I'm truly going to miss when you're gone. I've really enjoyed working with both of you. It's been, it's made everybody's job in this Council a lot easier. Member Mroczkowski, taking care of a budget and working hard as you did and using his own words, got his hands around it, to make a difference in our city, your leadership will be sorely missed. Bill Smuckler, the guy who I call up yelling and screaming, and he calms me down and gives me the correct advice. I thank you Bill for all of your guidance. Mike Miller, a gentleman who's always done everything in the best interest of the city. Finally, to Mayor Watkins, what a tremendous job you've done. I don't think that anybody in this town can ever walk into our downtown area and not look at it and think of you. I remember when I first came down here and looked at that and saw, and I can now still picture the changes and the things you've done down there. Congratulations, Mayor, and thank you so much for everything you've done for me. Thank you everyone.

PRESIDENT DENCZAK: Member Mroczkowski, were you asking for the floor?

MEMBER MROCZKOWSKI: Yes, thank you. Very short, the evening is long, and I want to thank everyone for the kind words and some of them, this bingo stuff, I don't know about, Kim. But, through this whole thing and thinking about what to say, I forgot about Mike Miller. He's, we've been counting the days down together. Mike, I apologize, you were a big, a big help in the finance. You led the way, you showed what could be done within that department and how to do things. You'll take that knowledge and someone will use it. Too bad it's not going to be us but I hope some day to work with you again. And in my 6 years, you were the best Service Director I ever knew.

PRESIDENT DENCZAK: Is there any other miscellaneous business?

SERVICE DIRECTOR MILLER: Mr. President. I just want to thank everybody for the kind compliments tonight. It's been a pleasure working with all of you. January 2<sup>nd</sup> I'm going to be kinda shuddering wondering whether Dave Dougherty's still going to call me at home, if he's got a flooding problem or he's got a snow problem. But it's been a pleasure working with all of you. You've made it easy to do my job and we've all worked together, I think, for the citizens of Canton. Mayor, I can't thank you enough for the opportunity. And hopefully, I've got a letter to the editor going in the newspaper in a few days that will tell you how much I appreciate that. Thank you.

CLERK VANCKUNAS: Mr. President. I would just like to say that it was truly a pleasure to prepare each and every one of these Resolutions that was passed out tonight and I hope that you will enjoy them for years to come. I did my best and I hope that they're appreciated. A special note, I've done school tours with the Mayor and to hear him talk to young people is truly inspirational. He is a gifted speaker. And, a special note John Mroczkowski. I've attended budget oversight committee meetings and as a result gained a great deal more respect than I had previously for our department heads. And I think it takes a special person to walk into a room and redirect people toward one common goal and you did that -- just like a pit bulldog, but you did it. And, best of luck to all of you. Thank you.

PRESIDENT DENCZAK: Any other miscellaneous business? .....

MEMBER SMUCKLER: Mr. President, I move we adjourn for 2003; seconded.
