MINUTES OF THE SPECIAL MEETING OF JANUARY 1, 2004

The special meeting of Canton City Council was held on Monday, January 1, 2004, at 11:30 A.M. in the Canton City Council Chamber following the swearing-in ceremonies at 11:00 A.M. The meeting was called to order by President of Council Ray Denczak.

PRESIDENT DENCZAK: This is the official special meeting of Canton City Council. The Chair is going to declare a five minute recess for the audience to clear. (*Special meeting of Canton City Council recessed at 11:37am and resumed at 11:46am*) Ladies and gentlemen, can we have some silence here please. Please, we must preside over this special meeting of Council. Thank you very much. At this particular time, the President of Council calls the special meeting of Council for this new term. At this time, the Chair is going to declare that Debbie Vanckunas serve as Clerk pro tem. Beverly Bevington and Beth Wensel will serve Council staff pro tem until they are elected so we can conduct this meeting. Roll call please.

The roll call was then taken (as follows) by pro tem Clerk of Council Debbie Vanckunas. The invocation was given by Councilmember-at-Large Donald E. Casar, followed by the Pledge of Allegiance led by President of Council Denczak.

MEMBER CASAR: Mr. President, I move we adopt Resolution #4; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Resolution #4. Are there any remarks?

MEMBER CASAR: Mr. President, this, I know, according to State Statute 171.21, it's mandatory that we do this. But,

I just wanted to, for Council's information and also for the record, that I've been in contact with a couple State Legislators and also talked with our Law Director, Joe Martuccio, where possibly, in the future we could get this changed where we would be able to do it on the internet, via the website. We're spending approximately, anywhere from \$35,000 to \$42,000 a year to advertise these legal notices in the City in The Repository. It is my intention to pursue this because I feel that this is money that could be used in better ways, and I think we should be coming into the 21st Century and use the electronic media for something of this nature that almost everybody has access to computers today and I want to pursue this and hopefully by doing this at a minimal cost, it would be almost nothing to the taxpayers by going with the electronic media. So, I just wanted to make this clear, I'll be working on this, and also for the record. Thank you.

PRESIDENT DENCZAK: Are there any other remarks?.... That the question you're voting on now is Resolution #4. By voice vote, all those in favor signify by saying aye. Those opposed no.

PRESIDENT DENCZAK: Resolution #4 is adopted.

OPENING REMARKS:

PRESIDENT DENCZAK: Opening remarks. I guess I'm the first to make my opening remarks. I must apologize. This past week has been a rather hectic week for me and I didn't have a chance to prepare an opening statement. So, I will be making a press release within the next couple days informing you of how I feel about this new Council and this new term. The next to make an opening remarks will be our new Mayor, the Honorable Janet Creighton. Mayor?....

MAYOR CREIGHTON: Thank you very much Mr. President and it's my honor to be serving with all of the members of Canton City Council and Canton city employees in the next four years. This morning I made a few remarks after my swearing in and I just want to share a few things again, with those that are assembled here and with City Council, and I think it's incumbent upon all of us to remember that we've not been simply handed an elective office but we've been charged with a public trust, and our citizens now have entrusted us to make a difference in our city, and every neighborhood and our approach to economic development in solving the budget deficit. We need to make Canton a great place to live, work and raise our families. Those are the 3 major focuses of the Creighton Administration in the first 100 days. I have met with each and every one of you and, again, I want to thank you personally for your graciousness, your cooperative efforts and your kind words and spirit of cooperation and I think that's the story that we, as the official leaders of the City of Canton, need to carry forward because the tasks before us are going to be very challenging but we all know by working together, we can make a difference. And again, it's just a reminder that it's not just the Mayor, it's not just a Councilperson, it takes all of us working together along with our businesses, our churches and temples, our schools, our community organizations and our labor unions that we all share in this commitment to the future. Just in conclusion this morning I did pass out to everyone the Athenian oath which is an ancient oath from years, thousands of years ago, and I shared that and we took that oath together, the cabinet and the Administrative support staff, and I think that the last sentence really sums up how all of us should feel and what our goals should be for the next four years. We will transmit our City of Canton, not only, not less, but greater and more beautiful than it was transmitted to us, so help us God. And I think that with that mission, we will all do what is right for our citizens. Thank you very much, Mr. President. I look forward to working with you and the rest of Council as well as the other elected officials and, again, my thanks to all of you for helping me in the transitional period of becoming the new Mayor. Thank you.

PRESIDENT DENCZAK: Next opening remarks will be by the Majority Leader, Donald Casar.

Mr. President. First of all, I'd like to take this opportunity to welcome the new members of MEMBER CASAR: Council, that being Thomas Bernabei, Terry Prater, Zachary Kelly - (corrected) Kelly Zachary, and Thomas West. I feel that the.....and the new Mayor, Janet Creighton. I feel that these individuals have the knowledge and experience in certain fields that will be very valuable to this City Council, and I'm looking forward to working with each one, each and every one of them. Secondly, I'd like to take this opportunity to thank my fellow Democrats for making me Majority Leader. I take this responsibility very, very seriously and I will work hard to make you proud that you did cast your vote and effort to make me your Majority Leader. I would like to make a few statements in regards to some of the changes that we've made or are in the Rules that you just adopted. First of all, as you noticed, we are going, Rule #44, we're going to a 3-person committee instead of 5, and I think the changes that were made will be better for the City of Canton and also for our expediency of legislation. And the committees will be more efficient and more responsive. Furthermore, the Chairmen of these committees will deliberately seek out from all elected and appointed city officers, such as the Mayor, Law Department, Law Director, Auditor and other information that this areas of expertise before legislation will be enacted. Another point in regards to the committees, I will encourage and hopefully, as I said way back when they elected me Majority Leader, I will encourage the Council to initiate more legislation on its own. This is not to say, however, that we will automatically oppose programs proposed by the Administration. On the contrary, we will support and implement these provisions that provide, as long as they provide the programs that they implement, I mean they propose, to meet the best interests of the City. I strongly suggest that the Administration, and it's not to say that this Administration will do this, but past Administrations that I've been here for over 20 years have done this, so before I make these comments, I want to make it clear that it is not necessarily this Administration, but I want to let them know what this Council's action's gonna be. I strongly suggest to the Administration, that the Administration will find itself in trouble if it consistently asks Council on Friday to shape legislation by Monday. This Council will be less inclined to accommodate the Administration, as it's done in the past, with crisis legislation. When Council knows that the Administration has for many weeks been sending in pieces of legislation or a proposal to Council, and deliberately hold it back or it just don't get down here--we, as the Council, will of course do this. We want it down here so we can study it and then we can make an honest decision, if it should go forth or not. And, we also recognize that on occasions, there are times when legislation has to be an emergency and we will cooperate and we will get it done but we'd like to see it as more as the rule and not as an exception when this happens. That's basically all that I want to say and with this being said, I'd like to say we will cooperate. We will cooperate with the Administration, and we will do the best job that we can do to make the City of Canton a proud city and if we can move forward and enjoy our 2 years here with harmony with the Administration and its Councilmembers. I thank you again for the opportunity to serve with you.

PRESIDENT DENCZAK: Also given an opportunity to speak is the Minority Leader, Member Diamond.

MEMBER DIAMOND: I also welcome the 4 new members. During the campaign we've met, we've talked, so they're not actually new members to, I don't think, to any of us, and they've shown their interest, they've participated and I think that they'll be very productive. Looking forward to the next 2 years, we still have a lot of work to do but there is credit to be given to the past Council, to the members who are no longer with us, and the Administration. In a bi-partisan effort, we solved many, many of our financial problems. We still have more to solve and I hope that that same spirit of cooperation continues with the new Administration and with the Council. Although we have a majority of Democrats on Council, during the last 2 years, they did work cooperatively with the Republican Administration to solve, to chip away at our deficit and I hope that that continues with the new Administration because we're not here to serve any political party, we're here to

serve the citizens of Canton. So, I look forward to working with this Council and I hope we accomplish a lot. Thank you.
