MS. FREEMAN: Good evening. I have three comments.

Drug funds continue to elude the most at-risk community. Is there anyone here interested in talking about these issues? And then there is the ghetto that I moved into. I am still in shock that Canton has such a community. Is it okay for people who live-- oh, it is okay for people who live in Jackson to come down and say what is needed, but who is talking to the people who live there for their ideas and suggestions? Is there anyone -- is there any -- is there already a group or something going on and how can I become involved in the group? Reference Lynn Court, 7th Street, 8th Street NW. The houses, it's terrible over there. Okay. My third comment is, I would like to commend the new Mayor for becoming involved in education because education is just as important as jobs. Thank you.

MEMBER HAWK: There will be a meeting to address housing concerns -- there will be two meetings actually, and we are encouraging all the neighbors to attend. There will be flyers going out. We are there to listen to the people in the neighborhood and receive their input for which direction this neighborhood should go. We're working very hard. The Mayor's committed to putting new housing into that area, and we are going to work very very hard, very diligently, to make sure that's going to happen. So, those meetings will be there. We'll have -- city officials will be there, representatives of school boards will be there, Stark Community Foundation will be there, builders will be there, other agencies will all be in to formulate a plan to redevelop and rejuvenate that area. I thank you.

PRESIDENT DENCZAK: Next speaker is Robert Fisher. Now, Members of Council, you know you've changed your Council rules. I don't write the rules, I just enforce them. This is going to be the last time I excuse anybody from obeying the new rules of public speaks. You're supposed to print your name. And, uh...

MR. FISHER: Sorry, Mr. President. You got me again.

PRESIDENT DENCZAK: I know you're not aware of the rule changes, however, there is a rule change and it states that when you sign up and you read the rules, you'll know that if not completed as required, the presiding officer will not recognize that particular speaker. But I'm gonna one more time let it slip by. Okay.

MR. FISHER: Did it to me again. You just keep overruling me, but that's alright. I love you anyway, Mr. President. Mr. President...

PRESIDENT DENCZAK: (CHUCKLES) Okay. State your name and address please.

MR. FISHER: Robert Fisher, 1010 Walnut Avenue NE, Canton. Mr. President and Members of Council and Mayor and other public officials present, I came here, and maybe I miscounted, but I came here to commend you for waiving council's -- waiving the statutes for the appointment of Safety Director Bernie Hunt. However, it's the second reading, but I still want to ask you, ask for your support in doing that waiving under these circumstances. I heard the discussion tonight. I certainly don't want to repeat it now, but I think that discussion was worthy because of the need for the position, the need for Mr. Hunt, who is both a friend and a client, to be appointed to that position as the Mayor wants. I think you guys will do it, guys and ladies, will do it. I certainly support you doing it. Now I stand here as one of the persons with Councilman Coleman who urged city residents for a long time, but all of us grow from what we do, and one of the things I want to talk about one day is that let's make it the court district, let's call it the court district. It makes sense that the entire court district that includes Louisville, North Canton, Waynesburg, Plain, Canton South and others, but not Jackson and Perry, be that place for residents. It makes sense to think about that and do that, and I urge you to do that. And I think it makes sense because Mr. Bernabei and Law Director Martuccio and I were talking tonight, on your agenda #70 there is contracting where our police prosecutor will be serving those communities. Yes, they're paying for them now, and I was glad to hear, because they ought to be paid for by those communities. And I think you ought to think about it. Please do that. I also want to do one more thing. I want to commend the Mayor. When she campaigned she said she wanted her administration to look like the City in diversity, and she's done that, and I'm asking you guys to support her doing that as soon as possible. Next week if you could go back, Mr. Casar, and go back to the agenda, it would be very nice for you to waive 22A to put that ordinance, and get it passed tonight. It'd be a wonderful thing to do. But I understand your rules and I live by your rules, but I'm urging you to do that. I thank you.

PRESIDENT DENCZAK: The final speaker is Reverend Dye.

REV. DYE: Good evening, President, Mayor and Council. My name is Reverend Robert Dye, 1405 - 23rd Street NE, Canton, Ohio 44714. Although I agree with the residency requirement, I believe there are exceptions to that rule. I would ask you to consider that as an exception in that I believe that the Mayor ought to have the privilege and the courtesy to appoint her cabinet, and those persons appointed by her or requested by her to serve in her cabinet should be given consideration in waiving the residency rule. Therefore, I stand here asking you to waive the residency rule and show a unity as a Council to give the Mayor that privilege and that right to exercise the right to form her cabinet and to appoint her Safety Director as requested. The second thing I ask is that, I've only been in the City five years, it would be nice, if you haven't thought about it already, it would be nice for Council to consider showing Council meetings on cable. There are allot of people throughout this City I believe who would like to see what's going on, who can't be here, and it would be nice if somehow you would have your Council meetings on cable so this whole community could be a

part of the Council meeting. And thirdly, I would like for you to get some heat in here. (LAUGHTER)

PRESIDENT DENCZAK: Reverend, we turn the heat off because sometimes this Council meeting gets a little heated itself, but apparently that's not gonna happen tonight. Members of Council, I'm just going to make an editorial comment. You've probably been reading in the paper about what's happening up in North Canton with the Mayor, and I'm glad Council isn't playing that particular role and the Mayor's not playing that particular role with Council. Okay.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: That ends the public speaks. We're now under Miscellaneous Business. Is there any miscellaneous business?

MAYOR CREIGHTON: Mr. President, in a continued spirit of cooperation, for those of you who may not have heard my State of the City address, it is with pleasure that I announce to this group that I have asked Councilman Greg Hawk from Ward 1 to serve as the representative of the administration for the Summit Neighborhood Housing Coalition. I believe that Councilman Hawk's passion and his drive to bring new housing which we all support will be indicative of his leadership, and I think that we can look for big things, but I did want everyone to know so if you hear him spouting off that he is the administration's representative, that it is not misguided. He in fact has graciously accepted and I look forward to his leadership.

MEMBER HAWK: Mr. President. Mayor Creighton, I thank you for your compliments of me. I appreciate the appointment. Thank you.

PRESIDENT DENCZAK: Any other miscellaneous business?

MEMBER CASAR: Mr. President....

PRESIDENT DENCZAK: One moment please, Member Casar. The Clerk has asked me to remind Members of Council ... (*INAUDIBLE COMMENTS BY CLERK*) Oh, I forgot, one of the Members of Council is absent tonight, so... The Clerk wanted to take a group picture of the Members of Council, so we'll have to wait until Member Mallonn is here.

MEMBER CASAR; Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.
