PRESIDENT DENCZAK: Announcement of Committee Meetings please.

MEMBER HAWK: Mr. President, Finance Committee will meet at 6:45 April 26th.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks under Open Forum. We have two people signed up this evening. First speaker is Charles Lively.

MR. LIVELY: My name is Charles Lively. I live at 802 Highland NE. I'd like to address this committee. (*NEXT COMMENT INAUDIBLE, MICROPHONE WAS NOT ON*) Did all you people get to read the paperwork that I asked you to read, or that the President asked you to read? Did anybody miss that paperwork? Did anybody read it?

PRESIDENT DENCZAK: I had it passed around here. It came back to me here. Did everybody see this?

MEMBER CARBENIA: Is that the one where there's...

MR. LIVELY: Where there's eight rapes, six counts of imposition, and it's right next door to a school. Now the Mayor knows all about it. I fought you people. I fought Congress. I fought the Sheriff's office and I lost. They told me that it was a State- operated thing and there's nothing they can do about it. My wife says go talk to the Mayor and she's sitting there and she'll tell you I did that. She requested of me to please give her a chance to straighten it out. What I couldn't get done in a year, she got done in one week. I got a call from a Congressman. They were too close to the school. Several things was wrong. I tried to tell the Sheriff that. The Sheriff told me, forget it. Well, my wife and I did not forget it, and I am very, very appreciative of our Mayor. This City has a chance of making it now. I hope she does the job she's doing. And I thank you, Ma'am. I thank the Council for listening and I wish you would have read the letter. Eight counts of rape. Where I come from it would have never reached eight. You'd had one chance, the second one he'd never get out of jail, let alone eight counts. That's all wrong. All wrong. Thank you.

MAYOR CREIGHTON: Mr. President, just so everyone understands, there is a situation near Gibbs School in which there were sexual predators put in a home within 760 feet of the school. The law mandates that they must be within 1000 feet. We also know that there are other perpetrators there. There are other types of individuals that have come out of prison, but especially with the school system and the sexual predators, that was really a violation of the law, and we made some calls and found out that it's really owned by a local person and we're still doing a little bit more investigation, but I want you all to know about that situation and if in fact there is anything else going on, you need to let us know because we're gonna track them down.

PRESIDENT DENCZAK: The next speaker is Alice Sarver. Did I pronounce that correctly?... Oh, yes.

MS. SARVER: My name is Alice Sarver and I live at 1225 41st Street NW. Madam Mayor, President of Council, Council Members. Recent headlines in *The Canton Repository* have reported that cans have been stolen from the recycling bin at the fire station. Well, I'm here to thank the thieves for doing that. This negative publicity has indeed actually been wonderful publicity for a very worthy cause, Aluminum Cans for Burned Children. Several months ago in this Council Chamber, a gentleman got up and spoke on behalf of this program. At that time I was disappointed and dismayed that Council did not follow up on his appeal nor did *The Repository* report the story of a citizen who had the courage to stand before this Council for a very worthy cause. Then Safety Director Joe Concatto did acknowledge at that meeting that the fire stations were involved in collecting these cans and it was not well publicized, and should be. Someone dropped the ball then, and hopefully now that a crime has brought us to the forefront, a lesson can be learned by all of us here in attendance tonight to follow through and to hold ourselves accountable to what you have promised that you are here to do. I just want to stress what a really wonderful charitable opportunity are all available to us in the City of Canton. I would like to offer the following suggestions as a solution to good communication between this Council and your constituents. Perhaps a notice in your City utility bills cited that recycling does take place at our fire station. Perhaps publication by the secretary of this Council meeting directly to <u>The Repository</u> as to what your agenda is, who speaks and what's been talked about, rather than rely on *The Repository* to report only what they seek to report. And perhaps public service announcements on the radio could be used for this particular cause. We have an opportunity in this City for some wonderful, wonderful charitable opportunities to give to people, and I think you as Council should set that example. Maybe these boy scouts could get involved too. Thank you for your time.

PRESIDENT DENCZAK: We are now under Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER MALLONN: Mr. President, yes. On Tuesday, April 27th at 7:00 PM at the Mayfield Senior Center located at 3844 11th Street SW, I will be holding an informational meeting regarding the Wal Mart property as well as the relocation of Scotnicky Court. That is next Tuesday, the 27th, at 7:00 PM at the Mayfield Senior Center on 11th Street SW. Thank you.

PRESIDENT DENCZAK: Is there any other miscellaneous business?

MAYOR CREIGHTON: Mr. President, as a follow up to Alice's comments, this would be the opportune time for me, first of all, seeing that it is National Volunteer Week, to thank all of those on City Council, in the Administration and in the audience who take the time to volunteer. That's what makes us a vibrant community, and along those lines, anyone who has time on Friday morning at 8:30, we are cleaning up Canton. And after we get done with that on Friday, my next goal is to clean up 77 and the expressway ramps, and by God I'm gonna do it, and I'll do it by myself or I'll do it with a group of people, but I'm sick and tired of seeing the trash, and the next thing that's gonna happen, the hammer's gonna come down on those trash vehicles that come through our City that do not batten down their backs, and by golly, Ohio State Highway Patrol and I are having a chat. (APPLAUSE)

PRESIDENT DENCZAK: Is there any other miscellaneous business?

MEMBER CASAR: Mr. President, after that, I move we adjourn; seconded. (LAUGHTER)
