PUBLIC HEARING #1 ZONE CHANGE REQUEST BY DENNIS & CAROL REED

PRESIDENT DENCZAK: We had a scheduled Public Hearing for 7:30 PM. The Chair opens the public hearing at this time in regards to a request by Dennis & Carol Reed to rezone lot 30741 located at 3801 Greenwood Place SW to permit a family support services facility in an existing house adjacent to the Reed Funeral Home complex. The Planning Commission recommends approval. Is there anybody in the audience wishing to speak for or against this rezoning, please come forward....

MR. SANDROCK: Ladies & Gentlemen, my name is Scott Sandrock. I'm the attorney for Mr. & Mrs. Reed. My office address is 220 Market Avenue South here in the City of Canton. I'll try to keep this brief. Just for the benefit of the Council and I know that each of you have already had a chance to see the summary of this, but in short, the Reeds operate a family support service, which is in essence a no charge, group exchange of families who are suffering grief with the loss of a loved one. Due to the expansion of services at the home, there is inadequate space at the home for a private session for these family members. Again, this is a no charge, voluntary group. They own the house immediately next door to the facility and have requested the change to permit the group to meet at that facility. Again, it's not retail, no sales are made, no charges are made. Now, this was submitted to the City Planning Commission and after hearing consideration, the Planning Commission recommended its adoption. Mrs. Carol Reed is with us here this evening and can certainly answer the details of any questions that you may have better than I, but would ask the favorable action of this Body on this request. Again, I'm happy to answer any questions that, that anyone would have concerning that item. Any questions?

PRESIDENT DENCZAK: I think the Councilman took care of that.

MR. SANDROCK: Thank you very much.

PRESIDENT DENCZAK: Is there anyone else in the audience wishing to speak for or against this rezoning, please come forward?... I'm right in, I'm right in back of it, right in back of it, and I have had problems with people cutting through my hard and so if they would mark off the yard and put a fence, a good fence around that, it'll stop that. So, that's all I got against, I don't have anything against them building, so they can build anything, I just want a fence for my yard. Okay.

PRESIDENT DENCZAK: Thank you. Is there anyone else in the audience wishing to speak for or against this rezoning, please come forward....? MEMBER ZACHARY: Mr. President, I did speak with the developers of this project and they more than willing to put up a fence for Mrs. Bowles.

PRESIDENT DENCZAK: Very Good. Are there any other remarks?... If not, roll call vote please.

NO REMARKS ROLL CALL VOTE: 12 YEAS, 0 NAYS

PRESIDENT DENCZAK: Ordinance #6 is adopted. #6 ADOPTED AS ORDINANCE NO. 67/2004

PRESIDENT DENCZAK: Let the Journal show that all ordinances have been given their reading as required by State Law. We'll go back to the original place on the agenda now.

PUBLIC SPEAKS (ORDINANCES OR RESOLUTIONS FOR ADOPTION ONLY):

PRESIDENT DENCZAK: Public Speaks on Ordinances or Resolutions for adoption. We have two people signed up under this portion of Public Speaks. The first person is Craig Massey. How many meetings do we got going over there?... Go ahead Craig.

MR. MASSEY: My name is Craig Massey. I live at 1927 4th Street SE here in Canton and today I'm here to speak about Jackson swimming pool. I have been hearing and seeing a lot of negative press about Jackson Swimming Pool, when in fact, hundreds of children use that pool each day, not 40 which was stated by Mr. Milsap. Senior citizens also utilize that swimming pool for aerobics and children are bussed in every day to utilize that swimming pool. The pool itself is okay; now I understand the housing where the kids go in to change their clothing, there may be some problems there. But, there's really no reason for that pool not to open this summer at all. I feel if we can get money together to open up a skating rink, we can get money together to fix up the housing over at Jackson Swimming Pool. Also, I understand there's going to be a committee formed and I would like to sit on that committee, if possible Mr. Casar, about Jackson Swimming Pool. If that's out of your hands, I'm asking the Mayor to sit on that committee, for the Jackson Swimming Pool. And, I also understand, or heard Mr. Casar say, if the pool is going to be closed, it has nothing to do with Council, it has something to do with the Administration. So, we need to do all that we can do to make sure that that pool opens today, excuse me...we need to do all that we can do to make sure that pool opens

PRESIDENT DENCZAK: The next speaker is Dr. Chris Smith.

DR. SMITH: Good afternoon. I'm Dr. Chris Smith, 458 Waynesburg Road SE and I'm here also to speak in regards to Jackson Pool. You know, I think back, when I was coming up as a product of the southeast area, I look at Allen Park, which was closed, and the kids had nowhere to go; I look at Jackson Park which was closed with a railroad track coming through it; I look at Nimisilla Park where they put stipulations on that and the kids had nowhere to really play at certain times, certain areas, certain things that they can do, we closed Cook Park. Then we had Crenshaw Park that, I understand that was done in a era that never was corrected, so that was a park that was left undone. So now when you read the papers, and you hear about Cook, I mean Jackson Park being closed, that sort of puts a damper on me because I think about the summer jobs that it would not create for college kids and also summer jobs for the kids. There are also camp sights that come down to Jackson Park also and I feel that it would be so unfair if Jackson Pool closes. This pool has been a part of the community for many, many decades and as far as what the cost to repair, that really shouldn't be an issue. The issue should be the children of the community of the southeast end and of Canton and contrary to what many of you think, children from all over, not just the southeast end, comes to that pool and, it's not only just for blacks, I know that's what people might say that it's the blacks closin', but if you notice the picture that was in the paper that day, it was a mixture of kids. Also, I really close into saying that I really hate to see that the pool would close. I should hope that we could find money for repairs so that it can stay open for the summer to create jobs and give the kids something to do. And, I also would like to say in closing, that I think it would be in the best interest of the City to not close the pool. Thank you. (APPLAUSE)

PRESIDENT DENCZAK: No one else has signed up to speak in regards to this matter. The Ordinance will come up later this evening.

MS. RADCLIFFE: Mr. President, thank you very much and thank, thank you to Thomas West and the Council. You know, in 1987, I remember sitting on the Governor's Task Force looking at the conditions of filth in Canton, Ohio and as a result of our testimony of witnesses of the things that were happening in Canton, the Ohio Commission of Minority Health was established. It was the first Commission in Ohio, in the United States, because there was a need, that there needed to be monies put aside for minority communities to eliminate some of the disparities in health. I just recently moved back to Canton and I found a copy of that testimony and it seems as if the more we change, the more things stay the same. But, one good thing I can say that one of the things that I had spoke on, that if you had mental health in this Community, you'd better have it before 5:00 because there were no buses and I'm here today to say that SARTA does run 24 hours. There are buses now. We do have our foundations who have made funds available to take care of health issues where it's inaccessible to people. We have the Sisters of Charity Foundation, we have the Stark County Community Foundation and other foundations who have generously given money to help us in this cause. And, not only

that, we have many, many groups who are looking at so, looking at the health issues in the, in Stark County. Our job is not done yet, there's still a lot of issues here but we're making a little bit of a headway and I want to thank you all who have made a contribution for the health of minorities in our community. Thank you. (APPLAUSE)

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #15. Are there any remarks under this ordinance?... Very well, roll call vote please.

NO REMARKS ROLL CALL: 12 YEAS, 0 HAYS

PRESIDENT DENCZAK: Ordinance #15 is adopted. #15 ADOPTED AS ORDINANCE NO. 76/2004

ANNOUNCEMENT OF COMMITTEE MEETINGS

PRESIDENT DENCZAK: Announcement of Committee Meetings please.

MEMBER BERNABEI: Mr. President, there will be a Judiciary Committee meeting next Monday evening, at 6:30 pm.

MEMBER BABCOCK: Mr. President, Public Safety and Thoroughfares will also meet next Monday evening at 6:30.

PRESIDENT DENCZAK: Any other committees?... Finance Committee?... Ordinance #2?

MEMBER HAWK: Mr. President, Finance Committee will meet also at 6:30 next Monday. Thank you very much.

PRESIDENT DENCZAK: Members of Council, 5:30 next Monday, the Chamber of Commerce will be here too to make a presentation on downtown development.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks Open Forum. We have several people signed up to speak. The first speaker is Sandi Belliveau. Am I pronouncing that correctly?

MS. BELLIVEAU: Thank you. This is my first time up here so, please bear with me. My name is Sandi Belliveau. I live at 1022 5th Street NW in Canton. I'm here representing part of the Summit Neighborhood. The boundaries that I'm representing here tonight are Newton to, I mean, I'm sorry, are Brown to Fulton and Tusc to 7th. On the agenda tonight, our main issue is what we received in the mail last Thursday is that we now have 6, 6 convicted sexual predators that now have been released in our neighborhood who are now, all six are living at the 1218 2nd Street NW house. It's a lime green, two story house close to the intersection of 2nd Street NW and Brown. With me tonight representing me is Cindy Cox, Vickie Perrin and Lisa Stalder, all in the neighborhood that I just spoke of. We have a Joseph E. Gibbons, 1 count of sexual battery, 1 count of gross sexual imposition; we have Ty B. Young, 2 counts of rape, 1 count of gross sexual imposition; we have Neal McMasters, 1 count of rape; Christopher Gilliot, 1 count of rape, 1 count gross sexual imposition; Phillip Brink, 1 count gross sexual imposition; and Frederick A. McIntyre, 3 counts of attempted rape. We're here tonight because the neighbor, our neighborhood is in a uproar. I just brought, just a few tonight, I'm not quite sure where to go with this but I do want to make it known that all of us are very concerned. We're on a target list for bringing our area back and not to discredit any other neighbor hood, but, if we're going to try to do that, that would be the last place that you would want something like that to be housed. I mean, I understand when people are rehabilitated and everybody needs a chance. I actually have another sex predator, "ex" sex predator in my neighborhood, who I have no problem with at all. He's good to everybody, he's trying, he's on his way up so, I have no problem with that at all. I have neighbors who have young children, have grandchildren, single parents and we now have some of the gentlemen in this house actually staring at the women and gawking at the women. That's one of the major problems. The other major problem at my corner, at 5th and Newton is a man who not only loiters, but in my opinion is actually stalking the neighborhood. He is there constantly. I'm not sure what his name is, I think it's Robert or Roberto. Chief McKimm does have email pictures of him. I've also made it very clear who he is, what he does. The Canton City Police Department has helped us immensely so far, really, really, I'm really impressed with the way the city has come to our aide, and they've really just put a big hole in everything going on back there. We still have the prostitution problem. On my way here tonight, I did pass an old prostitute that's back again named Cindy with short hair now and a pair of shorts up to here. She's back on the street again which we're not at all happy with. That's my two main issues here tonight is

fighting for my neighborhood, trying to maintain a normal life style for the people who are living there, people being able to sleep all night, people, women being able to come out and plant a garden without 3 or 4 guys stalking them, loitering at my intersection right at my corner there, 2, 3, 4 o'clock in the morning, walking, standing, walking across the street and standing for 10 minutes; walking to the alley standing for 10 minutes; it's almost like it's a mind game just to try to push the neighborhood over the edge. So, those are our 2 main concerns tonight. Thank you. I appreciate the time.

PRESIDENT DENCZAK: The next speaker is Cindy Cox.

MS. COX: I only wanted to add one thing to Sandi's.....

PRESIDENT DENCZAK: State your name and address please for the record.

MS. COX: Cindy Cox, 201 Brown Avenue NW. The house that these men are living in, they are unsupervised, they are free to come and go as they want and we have neighbors that are concerned. Their kids are afraid to go outside and play now. That's all I wanted to say. Thank you.

MAYOR CREIGHTON: Mr. President and to members of that community, I had a call late Friday afternoon from a, from another one of your neighbors. I called her back Sunday and I drove by today to look at the house just so I had a visual where, where it was, I know which house you're speaking of. I am not sure yet, I'm going to do some homework as we did on the other house on Arch Court, which is not in your area and in that particular case, they had sexual predators within a thousand feet of a school. I know this is not within 1,000 feet of a school, but my question will be, is it zoned that 6 people can live in the house, is it a placement home, how did they get there? We're going to do our investigation just as we did on the one on Arch Court. So, I don't have an answer for you tonight, but I will be checking it out tomorrow.

PRESIDENT DENCZAK: The next speaker is Vickie Perrin. (SHE DECLINES TO SPEAK)

MS. PERRIN: The next speaker is Craig Massey.

MR. MASSEY: My name is Craig Massey. I live at 1927 4th Street SE, Canton. My question is for the Mayor. For some time now, the City has been trying to get rid of some of its property and I'm speaking about the Peel Coleman Center. If you're able to sell that building, what will happen to Youth Development? Will it be housed or will we still be in the business of youth development? If you're able to sell that building, will the name Peel Coleman remain on that building, because as an African/American, it makes me feel good to see that we contribute to this community as well.

MAYOR CREIGHTON: Mr. President and Mr. Massey, first of all, I don't want to put the cart before the horse. I was engaged in an interview with WHBC on my first 100 days, you need to know how that whole issue came up and they asked me about real estate that the City owned. My goal is to see a Stark County Urban League developed for the entire County. My goal would be to give it to the Stark County Urban League. As far as Youth Development, that is not even on the screen right now. I am not talking about closing any place down so let's just stop the rumors in the community. I am not closing the Peel Coleman Center, I simply made a statement that the city owns far too much real estate. We are not real estate brokers, but we need to house programs that cater to our citizens and we need to get the best bang for our buck. So, Craig, I don't have an answer for your tonight, because I haven't even thought about Youth

Development--what I was talking about was the physical structure.

MR. MASSEY: Right. Thank you very much.

PRESIDENT DENCZAK: The final speaker is Lisa Stalder. (SHE DECLINES TO SPEAK)

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under miscellaneous business. Is there any miscellaneous business?

MEMBER BERNABEI: Mr. President, going back to Ordinance #10 which was McGrann Paper for tax exemption. Question....whoever can answer this from the Administration. Do we have a policy in place that determines, or how do we determine whether we grant 5 year, 10 year real property, personal property, or whatever kind of tax exemption and are we doing enough to tie these tax exemptions to job creations? I think this is the conversation we had in committee last week. I omitted to bring it up at the time of the adoption of the Ordinance. I think it's a subject that several members of Council discussed last week.

MAYOR CREIGHTON: Mr. President, Mr. Bernabei, I'm trying to recall on this one. First of all, the law dictates that you can only go so many years for personal or with real. And, I just, I can't, I can't draw to my memory, Tom, I'm sorry, Councilman Bernabei, if they requested that or if that was the recommendation when they came to us. So, if you wouldn't mind, if I could check it out tomorrow, I, I, I just, I can't remember, but the honest, the other answer to your question is there is not a set policy. It's normally what, it's the need of that corporation and up to the maximum amount allowed by law.

PRESIDENT DENCZAK: Do you yield, Member Bernabei?... You yield?... Member Casar.

MEMBER CASAR: Mr. President, Member Bernabei. When it came before the CIC committee, that was what their request was and we acted on it accordingly with their request and that was the recommendation of the staff and the committee, I mean the Board, accepted it as recommended and it came to Council.

PRESIDENT DENCZAK: Is there any other miscellaneous business?

MEMBER ZACHARY: Mr. President, I'd like to direct this to the Safety Director and ask for his assistance with something that I have going on in my ward right now. We're very happy that the people on the northwest end there are starting to clean up their problem but it's starting to creep into areas of ward 4 and I have people who are afraid to come out of their homes because of the drug problem on 2nd and 3rd Streets NE as well as 6th Street SW, and I'm asking for an increased police presence in those areas so that we can start addressing some of the problems that are over there.

SAFETY DIRECTOR HUNT: Mr. President, Member Zachary, if we can speak later, after this meeting, if you can give me some addresses, I will make sure that our zone cars are notified and that our vice department knows these addresses.

PRESIDENT DENCZAK: Do you yield Member Zachary?... Member Zachary, you finished?....

MEMBER ZACHARY: Oh yes, I'm sorry.

PRESIDENT DENCZAK: Any other miscellaneous business?

MEMBER HAWK: Mr. President, one final comment on the sexual predators on 2nd Street. This morning, Sandi and Cindy and Vickie and Chief of Staff Concatto and I met on this. We are working diligently on it. Director Hunt's working on it, the Mayor's working with it. We're going to address this problem in the appropriate fashion. We had a very good response to it very early this morning. We got together, we got something accomplished and I'm very happy that you take the time and you're concerned for your neighborhood and you bring this to our attention. You are the eyes and ears of us, of City Council, of the Administration and of the Police Department. Thank you for your concern for your neighborhood. We truly appreciate it.

PRESIDENT DENCZAK: Is there any other miscellaneous business?

MEMBER WEST: Mr. President. Mr. President, last week I had made some comments in reference to Jackson Pool and I just wanted to make the record clear that there's nothing that would please me more than to have Jackson Pool open, and I'm very thankful to Tad Ellsworth for getting someone there to make sure that the pool is structurally sound, that we have the data that we can make an informed decision. Thank you.

PRESIDENT DENCZAK: Is there any more miscellaneous business?

MEMBER HAWK: Mr. President.....

PRESIDENT DENCZAK: One moment. Mayor....Madame Mayor. When you first took office, January 1st, you made the statement that you was gonna have, in 100 days, you was gonna have Canton go on a new....can you somehow give Council a communication as to what direction we're taking now after the 100 days are up? Thank you Mayor. Yeah, send it to Council. Okay. Member Casar.

MEMBER CASAR: Mr. President, yes. Last week was a Clean Up Canton. I want to commend the Mayor and her staff and all the volunteers that went out and physically, Saturday, Friday morning which wasn't that great a morning and proceeded to pick up trash around the immediate city area, city hall area, up, down, I think around Cherry Avenue over to McKinley and over to West Tusc and so forth and I understand that they gathered around 350 plastic trash bags and I think it was a, something well-deserved, that we should commend the Mayor for this because it, it's just a, it's a small thing at the present time, but if they can get 350 bags in such a small area, imagine what else is out there in our city and that we should be conscientious of the fact is that we all should look for this and if we see a piece of paper, whatever, pick it up. If we see someone throw it down, tell them about it also but I would, I want to commend the Mayor and her staff and all the volunteers that went out and worked Friday morning. (APPLAUSE)

PRESIDENT DENCZAK: And as a footnote to that Mayor, you missed one place - 2416 38th Street. I got all kind of beer bottles, McDonald paper bags, milkshake containers, laying in my yard every morning. So, next time you have this civic duty, would you pick up 2416 38th Street? (*LAUGHTER*)

MAYOR CREIGHTON: Mr. President, it's great exercise to bend over and pick it up. (LAUGHTER &

APPLAUSE)

PRESIDENT DENCZAK: Now don't encourage her for cryin' out loud. You're starting to get on my nerves, you know that?

MAYOR CREIGHTON: Well, you know, while we're on...I have to also...I want to thank Councilman Bernabei for helping. I know that I've received calls from some of the rest of the Councilmen and they couldn't join us for a variety of reasons and, it demonstrates that we all work together. Treasurer Schirack helped clean up trash. I appreciated that, and, a lot of city employees and I want to make one thing perfectly clear, it doesn't matter to me whether you spend your 8 hours on city time picking up trash or sitting behind a desk, it's that you're making a difference in our community. So, to those who shook their head about why we asked city employees, we got the job done and we ain't done yet.

PRESIDENT DENCZAK: Is there any other, is there any other miscellaneous business?

MEMBER DOUGHERTY: Mr. President. Yeah, on that same note, Saturday from 9 to 12, the NEAR group in my ward will be having a clean up and we'll be going along the trail and planting flowers and cleaning up that area too.

PRESIDENT DENCZAK: Hit 2416 38th Street, will ya?.... (LAUGHTER) Is there any other miscellaneous business?

MEMBER HART: Mr. President, just on the same line, I'd like to, on behalf of many of the students at Crenshaw Middle School. This past week, we were all out picking up, you know, a little community service, making our, you know, the school neighborhood a little bit better and I guess for the ladies from Greg's ward, I guess it's a sad commentary when you go on to the Sheriff's website and I think if you were to probably download all the names of the sexual predators, and it's all over the city, you would probably be up, my guess would be close to 40 pages.

LAW DIRECTOR MARTUCCIO: Mr. President, while we're sharing notes on a positive note, members of Council may take note they have a cover girl celebrity among them. Member Zachary was honored by *Walsh Times* and appears on their cover for her accomplishments. (*APPLAUSE*)

PRESIDENT DENCZAK: Where did I lose control of this? (LAUGHTER)

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.

NO REMARKS ROLL CALL: 12 YEAS, 0 HAYS
