MS. HAWKINS: (INAUDIBLE, MICROPHONE WAS NOT ON-THE SPEAKER'S NAME IS LOUISE HAWKINS OF 1104 - 6TH STREET SW & HER SUBJECT MATTER IS THE LIQUOR LICENSE AT 6TH & COOK SW) ...It deteriorated over the years. Just a few years ago, there's been an improvement, a great improvement, but we still are trying to improve it a lot more. With this proposal that's planned to come into the area will take away that improvement, and I am totally against it. That's all I have to say.

PRESIDENT DENCZAK: The next speaker is Constance Brown.

MS. BROWN: President of Council, Mayor, and Members of Council, I'm Constance Brown. I live at 620 Bachert Court SW. That is about three blocks from the proposed Boyd's Drive Thru at Cook and 6th. Over the last nine years we have seen a great improvement in the area. We're taking steps forward to cleaning up the area and improving our neighborhood, and we feel very strongly that having another drive thru or liquor establishment in our area would definitely step us backwards. We do not have a history of handling these things well in our community. So we would ask that you very strongly consider rejecting the request for the liquor license. I do have a couple of questions for Council. Is it true that if Council denies the liquor license that the State could grant a state liquor license?

PRESIDENT DENCZAK: Do we have a representative from the Law Department here?... Can somebody answer -oh, yes.

SAFETY DIRECTOR HUNT: Mr. President. Ma'am, if City Council objects to the issuance of this liquor license, the individual requesting the liquor license has the ability to appeal that to the Liquor Commission in Columbus in which case, if he would lose that again, he has to go to Common Pleas Court, and that is the only route for him if he is denied.

MS. BROWN: Thank you. If by some chance he received a positive ruling at the second stage that you mentioned there, is there anything else that Council can do to keep the establishment out of our community?

SAFETY DIRECTOR HUNT: Mr. President. Ma'am, what a City Councilmember does in a situation like this when they have objected, they will contact the police vice unit, they will run a history of that address to determine how many calls we've had. We will also -- the Councilmember usually also goes door to door and talks to individuals and lets them testify at the hearing, and finally, the Councilmember also checks with the Health Department, Zoning and Code Department because often times there are other violations that the City can go forward on and bring forward in our case.

MS. BROWN: Thank you. That helps to clarify it a great deal. Thank you, Mr. President.

PRESIDENT DENCZAK: Mayor Creighton, you're in the process of seeking a new employee for the Community & Economic Development Director, is that correct?

So again, this is not anything to do with a specific person or people. This is just that hopefully we can all act like adults and address this as a community. Thank you.

PRESIDENT DENCZAK: Madam, what-- be more-- Madam, please be more specific. Where is this located?

MS. KIRKLAND: Ward 8.

PRESIDENT DENCZAK: On 48th Street?

MS. KIRKLAND: 41st.

PRESIDENT DENCZAK: You live on 41st?

MS. KIRKLAND: Yes. sir.

PRESIDENT DENCZAK: And the road project is on 41st?

MS. KIRKLAND: It's going to be, yes.

PRESIDENT DENCZAK: Yeah, okay.

MS. KIRKLAND: The grant was already approved.

PRESIDENT DENCZAK: Okay. Okay. Thank you.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We are now under Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER PRATER: Mr. President. Yes, I'd like to announce that Ward 5 has organized a clean up day this Saturday in conjunction with a neighborhood group and an Eagle Scout candidate who needed a community service project. PRESIDENT DENCZAK: Now, I just got zapped by this woman and I got zapped by this woman (MAKING REFERENCE TO INAUDIBLE COMMENTS MADE BY CLERK OF COUNCIL).

MAYOR CREIGHTON: It's your lucky night.

PRESIDENT DENCZAK: When you said I bent over, she (MEANING CLERK OF COUNCIL) said that's my best side. (LAUGHTER) What a dysfunctional Council I have here.
