7:30 PUBLIC HEARING RE: REZONING OF 1131 WERTZ AVENUE NW FR: PB-3 TO PB-4

PRESIDENT DENCZAK: We have a scheduled public hearing for 7:30 PM. It's a request by Jeffrey Dimmerling to rezone 1131 Wertz Avenue NW from PB-3 to PB-4 for a commercial building with living quarters on the 2nd floor and a rear storage building. The Planning Commission recommends approval. The Chair opens the Public Hearing now in regards to this matter. Is there anyone in the audience wishing to speak for or against this rezone, please come forward... Is there anyone in the audience wishing to speak for or against this rezone, please come forward.. State your name and address.

MR. MESSINGER: My name is Paul Messinger, 3022 - 12th Street NW. I have a few questions about the rezoning. There's a field behind my house and a few others and myself and another neighbor is concerned about changing the storage. It would bring in other storage units, but that would look like the ones that were built on Wertz called All Star Storage which really looks bad. My comment is, North Canton and Jackson and everybody else, when they put in storage units, they build really nice ones and we allow really crummy ones to be built in our area, but I don't know if, that might be Canton Township area behind my house. Outlot 517 is zoned for residential, Canton City, and I've got no problem with them changing the zoning, as long as it's not ugly and it's, you know, the junk's cleaned up around the back and, because the guy has stepped forward and changed the zoning to be proper and it was never zoned properly anyway and the guy's standing up and doing that right. So, my comment is that, as long as it looks decent, I don't have a problem with it, but we need to have the junk cleaned up and then go from there.

PRESIDENT DENCZAK: Is there anyone else wishing to speak for or against this zone change, please come forward... Is there anyone else wishing to speak for or against this zone change, please come forward...

MR. KNASSAS: My name Alex Knassas. I own three commercial properties...

PRESIDENT DENCZAK: State your address please, where you live... Where do you live? State your address, please.

MR. KNASSAS: My address is 2923 12th Street NW, Canton. I own three commercial properties next to 1131 Wertz Avenue. The property being considered for zoning change. I strongly oppose the rezoning because I believe it will devalue my property, and I ask you to deny the request for rezoning. I am also concerned because of the disregard the owner of the property has shown to his neighbors. The area behind his building looks like a dump piled with junk, including five cars, a boat and number of other items that looks like they have been discarded. If the owner wants his neighbors to consider his request, he should show, he should show us that he takes responsibility to his property and clean it up. If you are interested, I have some pictures showing what I'm talking about. They were taken last Thursday. Thank you for your consideration of my opposition to the request for rezoning. This is my pictures. (*Pictures distributed to Members of Council*)

PRESIDENT DENCZAK: Is there anyone else in the audience wishing to speak for or against this zone change, please come forward.

MR. DIMMERLING: My name is Jeff Dimmerling. I live at 1131 Wertz Avenue. First, I want to address Paul's concern about the field behind all of our properties. There's a big field back there, it's a couple acres. That is Canton Township. I don't own any of that so I have no plans to change any of that and that's not being rezoned to the best of my knowledge. Only my property is. So, I think that addresses that one. And, in terms of him, this addresses cleaning up the trash for both Alex and Paul. I've made it very clear to my tenant that I want all the small stuff that you see in that picture inside. I have both a secured area and the building that he rents out. I want all of that small stuff back inside where it was. He found one of his employees stealing from him so he's in the middle of an inventory. He's trying to clear out room in there and had a bunch of that stuff outside. I told him he needs to get it all back inside and get it cleaned up so it looks decent and then, once we get that done, it'll be business as usual. We're only, we're zoned B-3 now, we rented the back building to him and the back area to him assuming that B-3, you know, you could do storage with B-3 but apparently you can't, you have to be B-4 I come to find out. So, like Paul said, I'm trying to make things right. So, that's really all I have to say on the matter if anybody has any questions.

PRESIDENT DENCZAK: Member Hawk, is this in your ward?

MEMBER HAWK: Yes, Mr. President, it is.

PRESIDENT DENCZAK: Is there anyone else in the audience wishing to speak for or against this zone change, please come forward... DIRECTOR ELLSWORTH: Mr. President, before you do that, I do have the list of contractors.....

PRESIDENT DENCZAK: Service Director......go ahead.

DIRECTOR ELLSWORTH: Before you do that, I do have the list of Contractors. The three that were on the list were Valley Ford Truck Sales in Cleveland, Wadsworth Ford Sales in Wadsworth and 32 Ford Mercury Inc. in Batavia, Ohio. There were no locals on the list for this, for this contract for this particular model of truck.

MEMBER CASAR: Mr. President. Are you saying that no local.....

PRESIDENT DENCZAK: Are you asking me this question? Are you asking me this question?

MEMBER CASAR: No. I asked for the floor for Mr. Ellsworth.

PRESIDENT DENCZAK: Okay, go ahead.

MEMBER CASAR: Service Director Ellsworth, you say that the local, our local Ford dealers did not bid on this or were they not asked to bid on it?

PRESIDENT DENCZAK: Public Speaks, Open Forum.....

MAYOR CREIGHTON: Mr. President, Oh, I'm sorry. Mr. President, thank you. The Jackson Pool Committee will meet at 4:45 on August 10th on the 8th Floor. 4:45, August the 10th on the 8th Floor.

PRESIDENT DENCZAK: Next... Oh, Public Speaks. You threw me off over there Mayor.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum, City business only. We have one speaker signed up. Pete DiGiacomo, is that correct?

MR. DIGIACOMO: Yep. I'd like to thank Council for letting me speak tonight. My name is Pete DiGiacomo. I live at 600 Dent Place SW, Canton, Ohio. I guess I'll start out by saying, I realize and understand that the entire City of Canton has a, has a drug trafficking, drug use problem. It's well known. What I'm here to speak about is what is happening within a hundred yards, two hundred yards of my house. I don't like it. I don't know how to get rid of it. I've called Canton Police, Metro Narcotics, Canton Vice, I've called the Mayor's Office. The Mayor's Office told me to call the Safety Director. The Safety Director, I left a message, he did not return a phone call. I've talked with Captain McKimm about a year and a half ago. I've also spoke with my Council person. Canton City Vice, Detective Sparr, I spoke to at least 3 or 4 times. I've given him addresses of drug activity. There's a bar on 9th Street SW, the Pastime Bar. He said that yes, they're aware of what's going on there. We have black, I see black and white cars come by from time to time. The trouble is that when they see them come by, they stop their activity. Two weeks ago, I had to get very indignant with a dispatcher. The dispatcher's first name was Chris. I called about drug activity. I don't call if somebody just comes out of the bar and they're going to smoke some marijuana and go back in. That's just an every day occurrence, that's nothing. I'm not going to get upset about that. The thing is when they're sitting in their vehicle other people are coming to the vehicle, leaving, other people, ya' know, it's a little party going on, they're also dealing. I called about that the one evening. I waited about 5 or 6 minutes. A cruiser goes by at 9th & Wells SW, so I call back and said hey, a cruiser just went by. They said the cruiser's on another call. I said well, can we get somebody down here? As soon as we get a unit free. I hung up the phone. About 3 minutes later, another cruiser goes by 9th Street. This time, heading in the opposite direction. I asked again the same question. This dispatcher Chris said, you know, we're very busy and we can only handle the calls as we get them in. I asked her again, I said, could you please get a cruiser down here? I said I've called quite a few times. I said all I wanna do is get some arrests. Arrests stop people

from coming around, and, ya' know, there was nothing said, it was like a pause. I said well, I'll tell you what, I'll call you back every 2 minutes until I get a cruiser here. Her response was bye bye, hung up the phone. I immediately pressed re-dial and asked for a sergeant or an officer and told them what happened. As I'm speaking, then, the cruiser finally shows up. They arrested the person. He had crack cocaine on him and he had also swallowed some. Like I say, the, just the normal, every day marijuana use, I don't even call about that any more. It doesn't make sense. The thing is that when I do call is when I see the drug use that's going on for 5, 10, 15, 20 minutes, a half an hour, when you have a drug dealer that's dealing. They use cell phones. You know, they call where they're at.

PRESIDENT DENCZAK: I'm sorry sir, but your 3 minutes are up so, bring your remarks to a close.

MR. DIGIACOMO: Okay, I, I'm just bringing this to the Mayor's Office. You know, I've brought it to every body that I can think of with not much help or satisfaction. Thank you.

PRESIDENT DENCZAK: Mayor, is your office aware of this matter?

MAYOR CREIGHTON: I would like to talk to you when we're finished here tonight, sir.

MR. DIGIACOMO: Yes ma'am.

MAYOR CREIGHTON: Thank you.

MEMBER ZACHARY: Mr. President, if I could. I asked Mr. DiGiacomo to come here tonight because I am having a serious problem on the southwest end. It's not just on his street, it's in that general area, and every time that you ask for assistance from the Police Department, you're being told that they have limited resources, and, you know, I get a lot of people who throw in my face that we're devoting a lot of time and attention to the prostitutes in the northwest end, no offense Greg, but I think as the problem moves, so should the Police move with the problem, and, it's migrating to other areas of the city now and we need help in that area. We definitely need help in that area so I would ask the Mayor and the Safety Director, whatever we can do to get Vice on the problem, because they're not going to do it in front of, what I call, the bumble bee cars, the black and whites. They're just not gonna do it. So, if we could get some help down there, some assistance, I would really appreciate it.

PRESIDENT DENCZAK: Is this problem on Dent in your ward?

MEMBER ZACHARY: Yes it is. It's on Dent, it's on Union, it's on High. There's a lot of vacant houses out there that people deal crack out of and homeless people who are on drugs go and break into these houses and it's gotta be stopped.

PRESIDENT DENCZAK: Mayor, you're on notice.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER WEST: Mr. President, I just want to announce once again that on August 1st, in an effort to revitalize Nimisilla Park, we're going to have a clean-up leading towards the kick-off of what we call the Joy Fest 2004 where we will have national recording artist Vickie Winans come down, ½ Mile Home and Keith Wonderboy Johnson. There's going to be a rib burn-off, soul style, as well as a carnival event, so please come on out and have a good time.

PRESIDENT DENCZAK: Member West, I noticed on your flier that this is free. Does that include the ribs? (*laughter*)

MEMBER WEST: Yeah, you can bring your ribs down and..... (laughter)

PRESIDENT DENCZAK: Is there any other miscellaneous business?...

MEMBER ZACHARY: Mr. President, oh, I'm sorry. I just want to announce that there's going to be a Crime Watch meeting on Monday, August 9th at 5:30pm at the Peel Coleman Center, and that's for Ward 4.

PRESIDENT DENCZAK: Any other miscellaneous business?...

MEMBER PRATER: Mr. President, since we amended Ordinance 39, are we supposed to....? (INAUDIBLE)

PRESIDENT DENCZAK: No, you can bring this up under miscellaneous business.

MAYOR CREIGHTON: Mr. President, you must have been reading my mind. You can go ahead and pass those papers around. Yes, tonight, actually, I am pleased to announce that we do have a new Economic Development Director. Her name is Margareta Poorman. She goes by Margie. That's easier to remember. You are getting a fax sheet, ladies and gentlemen, Members of Council and Mr. President. This is the information about Margie. She will start on September the 7th of 2004. Her salary will be \$80,000.00. She's married to David Poorman and the mother of a 2 year old, Katie. She and her husband share those duties. She graduated from Youngstown State with a BA in Economics and a minor in History. She currently lives in Toledo, Ohio. She is currently the Vice President of Administrative Affairs for the Regional Growth Partnership of Toledo, Ohio which is Lucas County. She has had that job since 1999 and I'm happy also to announce that her past experience includes city economic development under Mayor Finkbiner of Toledo. She's also been a member, or, I'm sorry, worked for the Chamber of Commerce in Youngstown and has that experience and she was also with the Foreign Trade Division, Department of Commerce in Washington DC. She's also served as President and a board member of the Ohio Development Association and the International Economic Development Council and she was also a CIC member for the City of Sylvania, Ohio. So, I'm very pleased tonight to announce that Margie has been hired. I will tell you, out of respect to this Council, I had asked her to join our, I had asked her to join the City 2 weeks ago, but knew that we needed to pass the amendment first. MEMBER WEST: I have a house in Westpark district if she changes her mind.

PRESIDENT DENCZAK: There's a house for sale at 2416 - 38th Street. That could help you out, Rosemary. Is there any other miscellaneous business?...

MEMBER WEST: Mr. President, just to ask the Mayor to piggy-back off that. Now that we know the Community Economic Development Director's job, do we know where Sheila Barrino will be going?

MAYOR CREIGHTON: Sheila Barrino is the current Director. We had a conversation this afternoon. Those discussions are on-going. Sheila will be treated with the respect she deserves as a city employee of 29 and a half years and Sheila will have a place in Community Development. I'm just not quite sure yet where that will be. I am not asking you to create anything. We will find a space.

PRESIDENT DENCZAK: Any other miscellaneous business?...

MAYOR CREIGHTON: Mr. President, just 2 more things. First of all, I just want to report to City Council the Farmer's Market is absolutely fabulous. If you haven't been there, you need to be there to buy your fresh produce every Saturday and your baked goods which are absolutely outstanding and, also, I'd like to announce that I accompanied the Fire Department this past week as they installed another fire smoke detector and we do have more smoke detectors and we need more people to apply. We'd love to be able to give them away. It's a service that we provide. Our Fire Department does a fabulous job and we even come out to the senior citizens and install them so, you know, let's help them out and get 'em some more smoke detector applications and let's help our citizens.

PRESIDENT DENCZAK: No, Madame Clerk, I do not need one at my house. (Laughter)

CLERK VANCKUNAS: It's free.

PRESIDENT DENCZAK: It's free.

MAYOR CREIGHTON: You would qualify as a senior citizen. (Laughter)

PRESIDENT DENCZAK: Who's Chairman of the Personnel Committee? I'm gonna have a talk with you. I want more money. If I'm going to be assassinated here by my colleagues. No, you're welcome to pick on me any time. I got big shoulders.

MEMBER CARBENIA: We will.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?

MEMBER HAWK: Mr. President, one quick comment. Saturday morning I was having breakfast at one of the local

diners and the comments I overheard from the booth in back of me that the folks were down there to go to the Farmer's Market and then they were going to ride the train.
