MR. MOLLETT: (INITIAL COMMENTS INAUDIBLE, MICROPHONE NOT ON) Now? Oh, okay. Let's start over again.

MR. MOLLETT: My name is Felix Mollett. I live at 1323 Warner Road SE in Canton, and I've been a resident 42 years, and I just acquired two lots on the side of my property and this alley runs between both of my properties. And I've been taking care of this alley for 30 some years, cutting grass, everything, cause it's through my lot, 'cause the City will not cut the grass they told me until it gets three feet tall. So I've been taking care of it for 30 some years, and so now that's why I put this action to try to get this alley for myself, to adjoin my property.

PRESIDENT DENCZAK: Chief of Staff Concatto, is this a dedicated alley, do you -- are you aware of this?

CHIEF OF STAFF CONCATTO: Yes, I believe it is.

PRESIDENT DENCZAK: It is dedicated, but unnamed.

CHIEF OF STAFF CONCATTO: I'm just gonna defer, I'm not sure of that. I don't have it in front of me. I don't have the ordinance in front of me.

PRESIDENT DENCZAK: Okay. But is there a ruling now that the grass has to be three foot tall before its mowed?

CHIEF OF STAFF CONCATTO: Mr. President, I'm not aware of that ruling. Sir, was that -- did someone tell you that, that it would have to...?

MR. MOLLETT: Yes. I've been calling -- every year I call three or four times, call the City to get the grass cut when it get out of hand on the lot I just purchased. Like I say, I've been a resident for forty some years. I've been going through this every year, calling the City two or three times a year to come and cut the grass. And they would cut it and put it on the tax of the property owner. And when I purchased the property, so that was the procedure I had to go

through every year getting the grass cut, so that's why I decided to own this alley that run between my properties since I purchased this other property, and to get this alley so it can be joined with the other property. I've been taking care of it all these years.

MEMBER CASAR: Mr. President, I move we adopt Ordinance #48; seconded

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #48. Are there any remarks under this ordinance?...

MEMBER CASAR: Mr. President, the Service Director has sent a letter to Council asking that it be postponed to August 23rd. However, after he sent this letter, he got a formal quote from a local Ford dealership in the City of Canton and it was higher than the one proposed to buy from Valley Ford. However, the Service Director two weeks ago stated that we did ask for a quote from the local car dealership, and indeed they did call on a verbal quote, but it was just only to see if we could do it for \$15,000 or under. That way they wouldn't have to bid it at that time. Downtown Ford said they could not. They were not asked to formally bid this vehicle, but the formal bid that they did receive that I have in front of me, it is a 2005 versus the one that we did bid for \$21,000 which is a 2004, and there were more incentives on the 2004 than there are on the 2005, and also that is why it is about \$3,000, \$4,000 more. But this being said, I want to compliment the Service Director because now from this point on, he said he's gonna go out for a written quote from at least one dealership or manufacturer, and/or distributor, whatever the product may be, within the City of Canton. So I think that is a step in the right direction to try to get our business in the City of Canton. So for that reason, I'm gonna move that we adopt this ordinance this evening; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #48. Are there any remarks?...

SERVICEDIRECTORELLSWORTH: Mr. President, I would like to take this opportunity to thank members of Council for pointing out something that I was not aware of. The previous system for doing these bids, when you look at the State contract, was to call. Now, according to the Water Department, they did call and ask for a bid, you know, so

somebody's mistaken. But in any case, when I discovered we weren't receiving written quotes for these state contract purchases, I immediately did send out this letter asking, actually requiring, all city departments, when you look to purchase vehicles from the state contract, to get a written quote from at least one local vendor in the City of Canton if one such exists. So, I would like to thank members of Council for pointing that out to me because I was not aware that that practice of just calling for the quotes was going on, and we will get written quotes from now on, and I thank you for that.

PRESIDENT DENCZAK: Any other remarks?... If not, roll call vote please.

MEMBER HAWK: Mr. President, Finance will meet at 5:30 also Monday. Thank you. Mr. President, we had called a meeting of the Finance Committee for tomorrow at 9:30 in the Caucus Room. We will not be able -- we feel that we may be in violation of the Sunshine Law in calling that meeting. We feel we might not have had the appropriate announcements so we're gonna cancel that meeting and we'll call it at a later date. I will talk with Mr. Ellsworth in regards to the -- we were going to review the state of the income tax collections, and I guess at tonight's meeting we talked about it briefly in front of everyone and found out that we are up, so we're in better shape than we thought and hurray for us.

CHIEF OF STAFF CONCATTO: Mr. President, I'm asking if I can meet with Council committees at 5:15 to give them an update on the Federal project, Federal Campus Project. It was #16 on the agenda. I explained it a little bit in committee meeting, but I have more detailed information that I would like to give to Council, and if I could do that at 5:15, I'd appreciate it.

PRESIDENT DENCZAK: On the 23rd?

CHIEF OF STAFF CONCATTO: Yes, sir.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: We're now under Public Speaks, Open Forum, City business only. We have three people signed up to speak. Harold Howard.

MR. HOWARD: Good evening. My name is Harold Howard, II. I live at 1603 Navarre Road SW, and our neighborhood has a problem with trucks loading, or being loaded and unloaded in the middle of Navarre, in the middle of Clinton Avenue beside my house, middle of Bank Place behind our house. They're unloading freight trucks, loading their own trucks, and loading customer trucks with building supplies, and it's been going on for almost three months since they loaded up their own lot, don't have no room to pull their trucks into their lot. The location of this, if anybody's familiar with Danner Press, it's Danner Press's old Plant 2. It sits on Bank Place. Supposedly, the building's being leased to them by Putnam Properties, and is still owned by the person who owned Danner Press. We bent over backwards to help Danner Press when they was thriving in our community. I think it's time we asked him to bend and open up where he's got that fenced off for the parking lot for Danner Press to make it accessible for the company he's leasing to to load and unload trucks and for their customers to have a place to park.

CHIEF OF STAFF CONCATTO: Mr. President, the Safety Director is not here, but we have discussed this issue. He has had police out there to ticket those trucks. What it is is there is a -- due to the roofing issues that we know that exist in Canton through the hail storm and a lot of roofs going on, a major supplier of those roofs is right there. The material comes in for them to distribute it there. They've been told to get the trucks off the street. They've been told to ask Mr. Putnam who I believe now owns the Danner Press buildings that they can move over into the other section over there and pull their trucks in over there and unload them and get them off the streets. I will follow up with the Safety Director in the morning. He's well aware of it. He has talked to the owner of this distributing company, and we'll continue to pursue that. I understand your problems, and we will pursue that issue.

MR. HOWARD: I have one other matter. They're driving over our sidewalks and sinking them into the ground. Is there anyway possible we could have cement posts put up at the corner of Navarre and Clinton?

CHIEF OF STAFF CONCATTO: Right after we make them fix the sidewalks. We will do that. I mean if they're driving over the sidewalks, that's illegal, and I will also give that to the Safety Director tomorrow morning. He is aware -- I'm not sure he's aware of the sidewalk issue, but I know that your complaints are valid about the trucks and it will probably continue for awhile 'cause there's still allot of roofers out there doing roof. It's not an excuse for them to use our streets where there's no parking or where they can't park those vehicles. We'll try to mitigate that.

MR. HOWARD: Thank you.

PRESIDENT DENCZAK: The next speaker is Felix Mollett. You don't want to speak now that your issue has been passed?.... Okay. Next speaker is Daryl Austin.

MR. AUSTIN: Mr. President, key officers, Members of Council, the Mayor of the City, my neighborhood friends...

PRESIDENT DENCZAK: State your name and address, please.

MR. AUSTIN: My name is Daryl Austin. My address is 1427 Sycamore Avenue SE, Canton, Ohio, and I have a number of issues, Mr. President, that I have discussed inadvertently with my council lady, Kelly Zachary. And, we have a sexual predator who has moved within 1000 feet of our elementary school, Lathrop School. The next issue that I have is also we have repeated drug offenders who come back home to live in the neighborhood who have held us hostage just about with pit bulls, not only pit bulls, but with their habits of continued drug use. The third issue that I have is about the traffic which is surrounding our area at late night coming from different areas of the city to procure drugs for one reason or the other. The fourth issue that I have is the need for a periodic check from our city to come down in the late evening or late night hours and check on those areas between Cherry Avenue and Market Avenue. The fifth issue that I have is we have a dumping site which was periodically placed there for no reason at all, and the community was not informed about it, and I was called as the community coordinator for that community, and which is at the base of Skyline Terrace in that area along the Nimisilla Creek line, and witnessed myself a truck driver from HMW Construction Company outside his truck early morning at 8:30 AM urinating, and that was on the 27th of July, 2004. We also have Joseph Jeffries Company who's traveling in and out and throughout our community dumping at this site. We have a number of tires, as well as a number of mounds of dirt which is left there by the Habitat for Humanity. And the sixth issue that I have is left with us from the previous administration in our community by a company called JMW who wants to use that dump site for solid waste landfill. I myself personally have gone throughout the community as the community coordinator, and I have gotten and had a petition signed which I left copies of in the Mayor's Office and as well with the Council lady, Kelly Zachary, and there was a formal meeting held at the Civic Center with regards to this issue with JMW acquiring a permit for that site. The community is up in arms about them wanting to use it for a solid waste landfill. Not only that, the dirt and the filth from the trucks coming through the community that it's leaving on those property owner's homes and their sidings. Last and not least, the Lathrop School District. The Lathrop School has been renovated, yes, on the inside. Those children were transported over to the old Allen School, but in comparison, if I were a child and I had to come back to the same school, yes the inside has been done, and look at the outside, what's sunken sidewalks on the outside of the school, and to be a handicapped child. If there should happen to be an emergency arise in the Lathrop School, I'm just wondering if those handicapped children would be able...

PRESIDENT DENCZAK: Sir...

MR. AUSTIN: ... to escape.

PRESIDENT DENCZAK: I'm sorry, but...

MR. AUSTIN: Thank you.

PRESIDENT DENCZAK: Under Council rules, you have three minutes. Your three minutes are up.

MR. AUSTIN: Thank you.

PRESIDENT DENCZAK: Member Zachary, are you aware of these problems?

MEMBER ZACHARY: That is my ward. I have talked to Mr. Austin numerous times. One of the things, when I went out there to look at the neighborhood, there is a set of railroad tracks right behind the property that JMW owns. I know he pointed out to me that a lot of drug dealers use that as a thoroughfare to get to where they're going, and I wanted to explore the possibility of maybe cutting off that street where those railroad tracks are so you can't get through there. Mr. Austin and I are still working on some other issues. One clarification, JMW is looking to do a solid waste transfer station, not a landfill. According to the company, it will be completely enclosed, but I do know there are some issues with the semi-trucks that are traveling throughout the residential neighborhood which he has asked that -- well, he's asked them not to do it, but it's still happening, so we're still working on some things.

MAYOR CREIGHTON: Mr. President, just a question, Councilman Zachary, or Councilwoman Zachary. Do you happen to know what school the sexual predator is within 1000 feet?

MEMBER ZACHARY: It's Lathrop School.

MAYOR CREIGHTON: I'll need that address.

CHIEF OF STAFF CONCATTO: Mr. President, yes. Do you have the specific address where they're dumping?

MEMBER ZACHARY: The property that he's talking about, Habitat owns part of the land behind Watson Place SE, and I have spoken with the Executive Director of Habitat and she has promised me that she would go out there and clean that property up, and I take Beth at her word, she's a good person. It does border the property that JMW owns, and I know that they are legally within their rights to put whatever they want to back there, so... (*CHUCKLES*), you're kinda stuck between a rock and a hard place because that's what they do, that's what their company does, that's what they have a permit to do, so they do move a lot of dirt back there. There's a lot of concrete in some spots, and I'm not sure they're done with their -- well, I know they're not done with all of what they're trying to do with the company, but it has posed some problems for the residents.

CHIEF OF STAFF CONCATTO: And this is the same location that Jeffries is dumping at?

MEMBER ZACHARY: Correct.

CHIEF OF STAFF CONCATTO: And is that -- he is dumping illegally, or he is...

MEMBER ZACHARY: They're not dumping illegally. It's not an illegal operation. They are doing everything within the law.

PRESIDENT DENCZAK: How could that be the law?

CHIEF OF STAFF CONCATTO: I would imagine if it's zoned, and if he owns the property that he has the right to...

PRESIDENT DENCZAK: Is it zoned as a junk yard?

CHIEF OF STAFF CONCATTO: I would have to look that up. It doesn't necessarily have to be a junk yard. I would

need to investigate what that...

MEMBER ZACHARY: Mr. President, the Health Department, they go over there once a week for a surprise visit and they've never found anything that would indicate that the company is not doing what they're supposed to be doing, and they welcome any of the citizens to come along. If anybody wants to from Ward 4, I can set that up for them.

PRESIDENT DENCZAK: Okay.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We are now under Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER CASAR: Mr. President, may I ask the Service Director a question please?

PRESIDENT DENCZAK: Yes, you may.

MEMBER CASAR: Service Director Ellsworth, now that the Hall of Fame is gone for another year, we will be hopefully soon starting the blacktop program. I was just hoping you would be able to tell us when we plan on starting it and when it will be completed this year, and hopefully it won't be September, Oct-- I mean October, November as it was last year.

SERVICE DIRECTOR ELLSWORTH: Mr. President, the blacktop program will begin immediately. We did start before the Hall of Fame on Market Avenue. We wanted to get that portion done before the community parade. We were successful in doing so. The program will begin again immediately. The Street Department will dedicate people to go with North Star, the contractor, so that we get all these streets paved. I would hope that we would be done by the end of September, but I can't guarantee that, but we will begin immediately.

MEMBER CASAR: And also, Service Director Ellsworth, I asked you for a list, I don't know if you have one, and possibly you might want to, I don't know if they'll use it or not, get the news media so the residents will know what streets are being blacktopped.

SERVICE DIRECTOR ELLSWORTH: Yeah, Mr. President, we normally will-- before we begin to blacktop, we will do a news release letting the residents know when that will be happening. I don't have a schedule of when those-- each of those streets will be paved yet. I'm awaiting back from our Street Department Superintendent, but we will do news releases each time before a street is paved.

MEMBER CASAR: Carbenia says he wants you to start in the 9th Ward first.

PRESIDENT DENCZAK: Member Carbenia, you want everything tonight.

MEMBER CARBENIA: No, I'd just like to have the list, if you could.

PRESIDENT DENCZAK: Is there any other miscellaneous business?...

MEMBER PRATER: If I might follow up on Mr. Howard, our first speaker this evening. The business that he's talking about is in my ward. Chief of Staff Concatto is correct, it is a problem. It's an ongoing problem. We're well aware of it. I've talked to Mr. Howard several times on the phone. I've talked to the manager of the business. I talked to Safety Director, Mr. Hunt, at least weekly. I was down there on a Saturday morning when one of our police officers was rerouting traffic because we couldn't even get a sanitation truck through. It is definitely a problem. We're well aware of it, we're working on it, and Mr. Concatto's correct, it's probably gonna stay as is for awhile, but we're certainly looking into it.

SERVICEDIRECTOR ELLSWORTH: Mr. President, I'd just like to take this opportunity to thank members of Council for adopting the three different ordinances earlier tonight that were related to projects that we have going on in the City. So often we get accused of slowing things down in government. These projects, they're very important to the residents who live in those areas, and I'm very appreciative of the support of Council in getting these projects under way as soon as possible. I'd also like to take this opportunity to commend all the city work force for the outstanding job they did on Hall of Fame this year. I don't know if many of you noticed, but I think the City looked better than it ever has for Hall of Fame week, and we've got a number of compliments from people outside the City, inside the City, as to what a great Hall of Fame week we had, and I just wanted to offer my commendations to all the city employees who work for me.

PRESIDENT DENCZAK: Is there any other miscellaneous business?...

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.
