We have given Lisa Miller the responsibility to do that, she does our appraisals. As soon as the, we're looking for the funding...it's going to cost us about \$2500 to do that appraisal...we will have the funding we believe out of the Mayor's Community & Economic Development money to fund that appraisal. I could not get it done in time for this meeting. I do not have an estimate of any costs, they weren't kept as far as what we might have put in that property...that was your request. I do not have that either. But it'll probably, even if we find the funding very quickly, it takes probably 30 to 60 days to do an appraisal.

MEMBER CASAR: Mr. President, I do not want to put a...Chief of Staff Concatto, I don't want to throw a curve ball into this program or project, because I think it's worthwhile, but in the same token, I know, and I may be off a \$100,000 or so, but I'm sure we spent over \$500,000 on that piece of property to make it a parking lot for the City workers that work in the Sears Building, and I can't understand why it's no longer needed. And although I think I stated three weeks ago, I want to see them come to the City of Canton downtown, but that's very valuable property and I know it has to come to CIC Committee for final disposal of the property. But I would like to see, at least this one Councilperson, would like to see how much money we have expended in that, an appraisal, before we pass this legislation. And so I would therefore move that we postpone this until, we'll start with next week's meeting, September 20th. I so move; seconded.

MEMBER WEST: Mr. President, just for clarity. Mr. Casar, are you saying next week then for the appraisal or...?

MEMBER CASAR: I'm just using that as a starting date and if they have it by next week, fine, if not, we can postpone it...if this Council wishes to, we'll postpone it for another week until those answers come forth.

CHIEF OF STAFF CONCATTO: Mr. President, if we can get the County appraisal, is that okay? I cannot get an appraisal that quickly, but I can get the County appraisal. I'll do some more research as far as what the costs...I cannot find that, but I'll go to another department.

MEMBER CASAR: Mr. President, I move we adopt Ordinance #37; seconded

PRESIDENT DENCZAK: Moved and seconded that you adopt Ordinance #37. Are there any remarks under this ordinance?

MEMBER DIAMOND: Mr. President, since we last discussed this ordinance 3 weeks ago and postponed it, one more city has proposed a lodging tax. Three weeks ago, we had five surrounding townships and municipalities that were taking advantage of an economic tool to increase their general fund. And in the last couple weeks, the city of Alliance now has its lodging tax pending before its Council. And I think that when you see all of our surrounding neighborhoods coming together and utilizing what I think is a fair and equitable tool, I think that the proposal has merit. The sole purpose for this tax is to charge people, the majority of the people that are coming from outside of the City of Canton, to increase our General Fund, so that we continue to have funds available for City services and for City personnel. Our personal income tax accounts are down, our corporate tax accounts are down. We're looking at anywhere from 400,000 to a million dollar deficit next year. We cannot run in the red; when we're in a deficit, we either cut City services or we lay off personnel. This, in my opinion, is a vehicle to help the residents of the City of Canton. I wish the Marriott continue success. I think they're an asset; I think they are a quality establishment. I think people will continue to come to that hotel, but I don't represent the hotel. I represent the citizens of Canton. And if there is a means available for City Council to increase our revenue to provide those services and provide the personnel, I think we should join with the five other municipalities and townships that are already reaping the benefits. Again, I'm not talking about projected figures. In the year 2003, we took in 732 dollars. Under my proposed legislation, we would have taken in \$61,000. Those are salaries that pay City employees, that next year we will not have if we continue to go by the old method and let our surrounding areas reap the benefits of this law. So I would ask that people look at who we're supposed to be responsible to and who we're supposed to be representing. And as I said, business in Canton is great-we need more of it-but our first responsibility is to the citizens of Canton. And we have a method that is tried and true. The municipalities and cities that enacted this lodging tax have not lost customers. I mean the hotels in Stark County have risen by 5% last year. That tells me that...

PRESIDENT DENCZAK: (TIMER SOUNDING) Member Diamond, do you know what that little signal means?

MEMBER DIAMOND: I know, I know.

PRESIDENT DENCZAK: All right. Bring your remarks to a close.

MEMBER DIAMOND: I would just ask that we take advantage of a law that helps the people that we are supposed to be representing. And that I am asking that you support this legislation. Thank you.

MEMBER CASAR: Mr. President, I had the Director of Marketing and Sales for Marriott speak to Council this evening, because he requested it so I afforded him that opportunity. And I want to first of all want to say that I too represent the citizens of Canton and I think my record proves that. But I want to say for the record because when Mr. Fuller spoke, it was in Caucus and it wasn't on the record, so for the record he basically said that it is not a 3%, but it's a 100% increase in tax because we're going from a 3 to a 6%. And number two, he stated that most of this money is contracted from companies such as Timken, Diebold, so forth and etc. They're paying the bill. Not that I have a big heart or a heavy heart for the corporations that have to pay that extra money, but in my opinion, it is coming from this area, not necessarily from the people coming in as guests for the hotel services. And as I stated three weeks ago, I feel that unlike the other 5 communities that have more than one hotel, we have one hotel that is growing, the occupancy is up to 70%, and hopefully that this lack of 3% has drawn these corporations to contract with the city...our hotel, meaning the Marriott, and if it has or hasn't, I don't know. But all I know is that two years ago, the former Administration, the Republican Administration sent to Council twice...the first time, this Council turned down—at that time the Council turned down

\$5 license plate tax. Then they sent it back down again and this Council approved it. And I'm happy to say that I did not vote for it. And I'm happy to say I will not vote for this tax tonight because shame on the Administration, shame on this Council if we can't balance our budget without asking for an additional tax, be it from insiders or outsiders, I think that we should look to...and \$61,000, that may sound like a lot of money, and it is, but when you're talking a \$47 million budget, it's really not. And to increase the taxes just to bail out the General Fund by \$61,000, I'm sorry, I can't go along with that.

PRESIDENT DENCZAK: Any other remarks?...

MEMBER DIAMOND: Mr. President...

PRESIDENT DENCZAK: Anybody else have anything to say?

MEMBER BERNABEI: Mr. President, I congratulate Member Diamond for initiating this legislation. It is a subject worthy of debate for this City Council and it is the kind of legislation that I am pleased to see Councilmembers initiate. I, however, personally cannot support this. I am troubled by imposition of this tax because it is a tax being imposed essentially solely on one taxpayer and that is the Marriott. They would be the predominate taxpayer in this particular situation. I consider that it be inequitable for this kind of a tax to be adopted. And that is why I personally would be opposed to it.

MEMBER DIAMOND: Mr. President, I thank Member Bernabei for his honest and straightforward remarks and we have a difference of opinion. I believe the Marriott's in the business of doing business, and with business come expenses. I went to Indianapolis last week and I paid a 13% room charge. Their downtown is booming, it's revitalized, it looks great. I was in Columbus a month ago, I paid I think a 15% room tax. I see cities all over the United States when I travel and I usually don't ask what the tax is before I make my determination on what hotel to stay in. The Marriott has a quality hotel. I don't believe in any way that an additional 3%, which is the same as the surrounding areas, is going to cause people not to stay there. If that were true, then the hotels in Belden Village and in Perry and in Plain and in Akron and Massillon would be empty and instead of having a 70% occupancy rate at the Marriott, we'd have 100%—if people would determine where to stay based upon a 3% lodging tax. And that's my personal opinion. I personally think \$60,000 is a lot of money when you're dealing in the red. It may or may not be to some other people, but you have to say we're going to cut somebody next year or cut two people, or cut out part of the paving...we need to start with \$60,000. We're not going to find a million dollars in one pot. We need to initiate new programs, fair programs, that can increase our revenue and we do it by tens of thousands of dollars, not by a million dollars. So, again, I would ask people to consider what this means to the City of Canton as far as revenues go. I want to tax people coming in who are using our Fire Department, who are using our Police Department, who are using our Street Departments, in order to maintain those services for the residents of Canton. Thank you.

PRESIDENT DENCZAK: Are there any other remarks?.... The question you're voting on now is Ordinance #37. Roll call vote please.

PRESIDENT DENCZAK: Member Bernabei, what time was yours...6? (INAUDIBLE AFFIRMATIVE RESPONSE FROM MEMBER BERNABEI)

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum, we have one person signed up....Vanessa Millizan... I pronouncing that correctly?... Vanessa Millizan on Fulton Road?.... (NO RESPONSE) Apparently she's not here.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: Member Casar, Member Carbenia and Mr. Martuccio, the Chair would like to meet with you in the Caucus Room after this meeting for just a few minutes. We are now under miscellaneous business. Is there any miscellaneous business?...

MEMBER HART: Mr. President, yeah, on each Member's desk I placed a letter that was given to me because this could have some implications in their own ward, and for Law Director Martuccio, could you please look at this letter that was sent to me from Mr. Kelleher and, you know, be able to respond because I think that at the next meeting, there may be

a few residents from the area that might like to, you know, get your opinion on that please.

LAW DIRECTOR MARTUCCIO: Mr. President, I have had a chance to read the letter, Member Hart. And I think I've been called a "girlie boy" without the benefit of an Austrian accent. Girlie Boy. I think there's an inference here that it's gutless government not to respond to some of these alleged zoning violations. I think it's gutless to be macho enough to come out shooting like a terminator and putting the taxpayers' dollars at risk with excess damages. But in fairness to the letter that's before me, I will consult with the Zoning Inspector to see if there are any violations other than those which are already covered and pending in the lawsuit and I will address those.

MEMBER HART: Okay, thank you, and also for Safety Director Hunt, I had the opportunity to be down here Friday afternoon during lunch time and I just want to see that if you could have a little better traffic control. There was a huge line of City employees out there on their lunch paying a rather large amount of money for the ability to dunk our Chief of Staff for the United Way. And I want to congratulate Joe and he probably could have got a lot more money if he would have had longer pants on, 'cause the legs really scared a lot of people away.

CHIEF OF STAFF CONCATTO: Mr. President, just a note that he was not one that was in the line and was willing to pay a measly \$5.

MEMBER HART: I'll give you \$20.

PRESIDENT DENCZAK: Whoa, whoa, whoa. Chief of Staff, everybody knows that he's cheap.

CHIEF OF STAFF CONCATTO: But I would like to thank Member Carbenia, sore arm and all, I'm not sure if it was \$20 or \$30, and I'd like to thank the Mayor, both of which walked up and hit it with their hand and knocked me in.

MEMBER WEST: Mr. President, I'd like to ask the Service Director or the Mayor, the residents that live on Irwin Place NE. Irwin Place NE, every time it rains, they have increased anxiety. I'm very concerned that they have had massive flooding and haven't had any answers as to what's going to happen or occur down there to eradicate the problems. Do we have any response that I can give them?

SERVICE DIRECTOR ELLSWORTH: Mr. President, every time it rains, I travel down to Irwin Place to see what's happening with the creek. We have initiated several creek clean-ups to help get some of the debris out of the way. The unfortunate situation about that area is that it's a flood plain. And I am assured by our engineers there is next to nothing we can do to eliminate flooding in that area. But what we can do and what we're looking to do is to help the creek to flow more smoothly. It may involve things further downstream in other jurisdictions than the City of Canton's to help that to happen. But our engineers are looking at it. We've done several, actually quite a bit of work in that particular portion of the Nimishillen Creek to try and alleviate some of those problems. But every time it rains, that's the first place I go.

CHIEF OF STAFF CONCATTO: Mr. President. Member West, also if I may, we had had a plan put in place earlier that morning, and although we could not stop the rain and floods, the first people that we would look to evacuate were the ones on 9th and Irwin. I was out at 3 in the morning to see where that creek was. If it was anywhere where we thought it was going to overflow, we had a plan in place to open a place for them to go, notify them that there was going to happen. It doesn't seem like much, but at least we would have got them out of harm's way for that evening.

MEMBER WEST: Thank you.

MEMBER ZACHARY: Mr. President, just real quickly, there's a crime watch meeting scheduled this Thursday, September 16th at 6:30 p.m. at the Monroe Center. All of Council is invited to attend, as well as any members of Ward 4 who are in the audience.

PRESIDENT DENCZAK: Who else was calling?...

MEMBER CARBENIA: Mr. President, I'd like to ask the Chief of Staff a question please.

PRESIDENT DENCZAK: You may.

MEMBER CARBENIA: Was Ray Denczak in that line?

CHIEF OF STAFF CONCATTO: Mr. President, can I answer that?

PRESIDENT DENCZAK: No.

CHIEF OF STAFF CONCATTO: There's your answer.

MEMBER CARBENIA: I knew that.

CHIEF OF STAFF CONCATTO: And he was not in that line, and by the way, Member Hart gave me \$20 to contribute to the United Way because he was not in that line, Mr. President.

PRESIDENT DENCZAK: I will be in the line to feed the needy though.

MEMBER HART: And President Denczak's got so much money, he could probably donate 50.

MAYOR CREIGHTON: Mr. President, I guess I am somewhat surprised 'cause we were giving away free food at United Way.

MEMBER DOUGHERTY: Mr. President...

PRESIDENT DENCZAK: Wait a minute, wait a minute... Where does it say to get the Council President? Do I get to ring the bell at the Stock Exchange now?

MEMBER DOUGHERTY: Mr. President, we'll stay on line with free food, and remind everybody that Saturday is our picnic and that if all of you could come, I would appreciate who can be there to volunteer and make this a great success as we have in the past. And for any of you that haven't donated...Mr. President, I thank you for yours, you did donate. So I'm trying to get things going in the right direction for you.

PRESIDENT DENCZAK: All right, now I'd like to have it back, I need it just for that purpose.

MEMBER DOUGHERTY: So we start at 8:00 in the morning on Saturday for set up and then the function's from 11 to 1. We're done by 2. So at anytime during that period, if you can come down and help, I'd appreciate it. Thank you.
