PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum, we have 5 people signed up to speak. The first speaker is Joel Scott.

MR. SCOTT: Hi. My name is Joel Scott. I work for.... My address is 8855 Louisville Street, Louisville Ohio. I work for Collins and Aikman. In 2002 you gave them a tax abatement. This is kind of addressed to the Mayor and her staff. The company's following up through with their promises with 92 jobs they promised to bring in. The layoffs keep coming, keep coming, and we got notice a couple weeks ago that they're sending about 60 to 70 jobs down to Homesville. Their tax abatement, I don't think they're keeping their promise. Just wondering if you could do further investigation and see where we're at.

Mr. President, yes, later on I was going to ask to have the Economic Development MEMBER CARBENIA: Department or maybe Manuel Patterson to investigate this because under the agreement, it does state that they're going to have these jobs and they've received tax abatement, personal and property tax. So, I wanna look into that because they're not doing what they're supposed to and we want, we want to try to help these young workers that are in our town and we want to try to keep them here.

MAYOR CREIGHTON: Mr. President, thank you. I will address this through Community Development. I would just remind everyone that tax abatement agreements are reviewed at the, usually, in March of the next year because the Department of Development requires them to file a report on December the 31st and we normally just don't go in and grab an abatement out from underneath from someone, but I will be happy to get an explanation and report back to you.

MR. SCOTT: Thank you.

PRESIDENT DENCZAK: The next speaker is David Stewart. (Mr. Stewart declined to speak.) The next speaker is Ruby Brogdon.

MRS. BROGDON: My name is Ruby Brogdon. I live at 1617 3rd Street NE. I am complaining about 2 houses that's growed up. One's in front of me with a big bag of garbage in the front. It is 1620 is one and 1521 is the other one. And, on Riverside Drive, we have to walk in the street on the opposite side of the wall. A tree is growed out. I almost got hit by a big truck that couldn't see me when I stepped out. The next complaint is on Riverside Drive, around the creek, that needs cleaned out. We had, a few years ago, it's been a long time, someone murdered a young lady and threw her over in there. So, some of you might not remember, and I would like to see that this house, these houses are cleaned up. One is right in front of me. The other one is on the opposite side down in front of me and that's all I have to say.

MAYOR CREIGHTON: Mr. President, Mrs. Brogdon....

PRESIDENT DENCZAK: Mrs. Brogdon, over here. The Mayor.

MAYOR CREIGHTON: Hi.

MRS. BROGDON: Hi.

MAYOR CREIGHTON: Question, 1620 and 1521 3rd Street NE, tell me about those houses, is it just garbage out front or are the houses in ill-repair?

MRS. BROGDON: When I, I haven't been back in Canton but 2 weeks. I went and registered to vote. I used to speak up here. Mr. Denczak has been here longer than I have and Mrs. Babcock. (laughter) Mr. Bernabei they have already heard from me, so...(audience laughter)

PRESIDENT DENCZAK: (inaudible)

MRS. BROGDON: I'm back at my same habit, complaining. So, 16, ah, it look like they deserted. They cut it real nice at 1521. It look like they deserted this house, it got trees in the yard and everything. In front of me, this young man, he kept this nice, but now it's growed up and a big bag of garbage, it look like garbage in the front and it look like, I don't know what happened to him, he used to keep it real nice. When no one was living in the house, he would come and cut the grass. Nothing done and it's in front of me.

MEMBER ZACHARY: Mr. President, if I could just address Mrs. Bogdon.

MRS. BRODGON: Pardon?

MEMBER ZACHARY: I'm sorry, if I could just address you, Mrs. Brodgon. I did try to return your phone call but you gave me a work number and, unfortunately, the answering service wouldn't let me leave a message with them.

MS. BROGDON: Yeah, sometimes they gets nasty that answering service.....

MEMBER ZACHARY: I would be more than happy to sit down and meet with you.

MS. BROGDON: They only comes on....they, they only on from 10 to 5, but I do have, I have a personal number in my apartment.

MEMBER ZACHARY: Okay. Okay. If you would give me that number, I would be more than happy to sit down and meet with you.

MS. BROGDON: Yeah, I will give you my personal number.

MEMBER ZACHARY: I do keep a copy of all the properties that have been turned in. It could be that those properties are already on the list and we'll see where they are in the process. If not, we'll get them turned in and taken care of.

MS. BROGDON: But I don't care what. All I want is it cleaned up. Cleaned up.

MEMBER ZACHARY: Yes ma'am.

MS. BROGDON: And I've already reported it to the Health Department today about the dogs and smellin'.

PRESIDENT DENCZAK: The next speaker is Bill Aston.

MR. ASTON: Hello. I am Bill Aston, 1924 Dennison NW, Mt. Vernon Neighborhood. You don't have to move to live in a better neighborhood. I want to congratulate the City, Mayor Creighton and everyone else that was involved in hiring our new Economic Development Director, Margy Poorman. Along with that, I want to talk about the development of some businesses. In our neighborhood, along Cleveland Avenue between 38th Street and Route 62, there is many, many businesses. Obviously, it's a very business-oriented area. There's almost any kind of fast food franchise you can think of, some are local ones, there are several family-owned, locally-owned restaurants there. There's a number of other businesses, automobile businesses along that area. There's doctors, lawyers, veterinarians, a great, a great amount of businesses along that area. There's also others that are less desirable, at least in my mind. There's at least 2 businesses that um, the quick cash places. I don't really find those that desirable and I kind of see them as preying on people that, that need the money and it just kind of gets them deeper into debt. Also, there's a number of car lots there, some of them not as great as others may be. But, coming closer to my point, we do have several empty businesses in that area, one or two are for sale, a couple others have been empty for a long time and if, if we all remember two and a half years ago, what happened with an empty business in our neighborhood. Shame on us all. But, as I move forward with this, and back to the new Economic Director, I hope that she assumes her duties and gets assimilated in our, in our City, that she not forget our outlying neighborhoods and that as these businesses would leave, that there would be plans working with other people who want to come in, more family-oriented businesses that would take over. Again, like I said, we have several businesses empty in our neighborhood right now. And, again, I'll just conclude. We can all live together in a better neighborhood and Canton could be that better neighborhood for all of us. Thank you for your time.

PRESIDENT DENCZAK: The next speaker is Greg Roach.

MR. ROACH: My name is Greg Roach. My address is 2107 37th Street NW. I'm also from that Mt. Vernon neighborhood and, I have a little different point of view than what Mr. Aston does. I'm, I'd like to address you about a persistent zoning violator in our neighborhood. The zoning law calls for a commercial business to have a buffer between the business and a residential neighborhood and there's a business on the corner of Mt. Vernon and Cleveland Avenue called XTC Video. Their back lot is zoned residential and, adjacent to another residential business. And in a *Repository* article dated September 14th a representative of the Law Director's office stated that this business must plant trees at the back of the lot, creating a buffer. Well, the back lot is zoned residential, and if that's the case, the only true buffer between the business and the residential area is the asphalt itself. I'm sure that the Zoning Department is aware of this. For some reason they cannot or will not enforce their own ordinances. Mayor Creighton is aware of this. If you, if you drive up Cleveland Avenue, there's other vacant buildings up there. There's a business located in the 3700 block of Cleveland Avenue that's been vacant for at least 2 years, and should be opened back up. Is the, is the City going to turn the same blind eye on this business that it already has on a persistent violator? And, if that is the case, um, we should, we should eliminate the Zoning Department if they're not willing to enforce their own ordinances, we should eliminate the Law Director's Office and their support services if they're going to continue to thumb their nose at the residents of the neighborhoods and, unless the Mayor steps up and exercises some kind of managerial authority over the whole situation, we should move to a Council-base, truly Council-based government, take the money we save from salaries and support services for some other, some other purposeful need and I'm here making a call, a call to action for City Council. It's a sad commentary on what's going on there, and, in my view it may be in the best interest of the City's residents for a

number of the government representatives to get their resumes together and prepare to move back into the private sector. Thank you for your time.

PRESIDENT DENCZAK: Mayor, are you familiar on what's going on here?

LAW DIRECTOR MARTUCCIO: Mr. President, last week, Member Hart brought to my attention a letter that was offered by a resident of the Mt. Vernon Association, Mr. Kelleher, some 3 months ago. My understanding is that he has since moved to another state, but, I said I would check the allegations in the letter, and I have. We had the one and only Zoning Inspector that we have re-visit XTC. We reviewed the letters in our file. We have sent lawyers, letters to the lawyer representing XTC, letting them know that they have been in, have not been in compliance with certain zoning regulations such as striping in their paved parking lot, handicapped spaces, the buffer space you mentioned, the greenery. They have come into compliance with some of it. Some of the striping, the handicapped spaces and so on, they have not come into compliance with the green space and we are going to pursue that, as a zoning violation that we have brought to their attention. There are others in the area that Mr. Aston and you have discussed that have come to our attention. Unfortunately, with only one Zoning Inspector and part of a part-time lawyer devoted to zoning, as these things are brought to our attention, then we can pursue them a little more vigorously With regard to the other comments, I would invite you, Mr. Roach to make an appointment to come and meet with me, to come and talk about the amount of time that the Law Department has spent on that particular area, that particular business and some of the other things we do, so that you can understand a little better what we're involved in. We spent a great deal of Law Department time and a great deal of City money on expert consultants in the form of David Langdon to address certain issues that came up a couple of years ago and last year. Part of what you mentioned is in litigation, specifically part of a lot being zoned residential. We are being sued, obviously, by the association along with the business, in the dispute over part of that parking lot, so I really can't comment on the merits of that, other than to say that it will be fully addressed by the Court, along with any nuisance value the business may have been, have brought to the neighborhood. But, again, we are renewing our efforts to look at those zoning regulations and I do invite you afterwards, or to give me a call and come up and meet with me and we can talk a little bit more about what we've done or haven't done in your eyes with regards to that particular place, or your neighborhood.

PRESIDENT DENCZAK: That ends the Public Speaks portion. Member Mallonn?....

MEMBER MALLONN: Yes, Mr. President, I would like to call a Parks and Recreation Committee meeting on September 27th at 6:45 in regards to communication number 508. Thank you.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: Public Speaks, we're now under Public Speaks. I'm sorry. There's writing here I can't even read it. Miscellaneous Business, I'm sorry. Before we go into Miscellaneous Business, Members of Council, I have an announcement to make. I have some good news and I have some bad news. The good news is there was twins born in Columbus, Ohio, and that's the bad news. The good news is they were born to the daughter of Rita and Don Casar here in Canton. Those 2 kids should have been born here in Canton because I understand they're both Democrats (laughter) and we need more Democrats in Canton. One of them, when they grow up, they may get a chance to ring the bell in the Stock Market. (laughter)

MEMBER CASAR: Mr. President, no, you said there were, you, Mr. President you said they were Democrats, I don't think so.

PRESIDENT DENCZAK: What?

MEMBER CASAR: You said they were Democrats, I don't think they'll get to ring the bell.

PRESIDENT DENCZAK: Oh, (laughter) that's true, that's true.

MAYOR CREIGHTON: I thought maybe there was somebody smart in your family?

MEMBER CASAR: All right, she just crossed the line.

PRESIDENT DENCZAK: Aren't they born to Don's daughter and son-in-law?... The children's names are Lisa and Luke and we wish them luck in their newborn children and when you bring them to Canton, bring them to a Council meeting so they can meet the Chair. I'll make sure they're Democrats. Okay, is there any other Miscellaneous **Business?**

MEMBER DOUGHERTY: Mr. President, yeah, I just want to give out some thanks for Saturday. We had our annual picnic which was a great success. Over 300 people attended. We nearly ran out of food. That would be 400 hamburgs, 300 hot dogs in 2 hours so, as you were talking about Don, there's a lot of people who were busy and couldn't make it and I appreciate everyone's donations. Mary, thanks for handing those fliers out for me again and getting the word out. We sent out 3,000 fliers so that people would get notified. Member Hawk, thank you for coming in the morning and then, I believe you did some volunteer work with Habitat later on in the day. Mayor, thanks for stopping by. Joe, thank you for stopping by and making sure things were going okay. RA, I'm going to need you to cook again next year because we have to teach Member Hart how to get that done right, okay?, so, it's your job and he said he tried really hard and did a good job but, we gotta work with him a little bit, okay? I appreciate Richard, what you did too and Rosemary did the Heart Walk in the morning and then we put her to work when she came down there so, I think she was pretty tired by the end of the day. Thanks to the staff for their help and everything they did and all the donations. Member Schirack donated and I appreciate it. You gotta realize too that there's a lot of people that helped out, you got Chips Enterprises giving donations, I just want to run this down. I haven't done this kind of thing in the past. This is our 12th year that we've done this. Hostess, Wonder Hostess donated, McDonalds of course, Mary Ann Donuts, Fisher Foods, Nickles Bakery, Canton Chair, Keep Canton Clean, Family Time Entertainment-they donate their time when they come and give that 2 hours of entertainment, so, they do an excellent job and I really appreciate what they do there. McKinley Grand, Marriott, also, let us use their refrigerator so things wouldn't spoil on us while we were working. The Health Department too, are one of the bigger departments that really donate groceries. We had 50 bags of groceries and stuff that we could get out so, we did that also. It was a good success. Thank you very much.

MAYOR CREIGHTON: I appreciate Dave's remarks but I think that the audience and the public should know that this is really a project that Dave Dougherty started. And, not only was Dave there but his entire family, and that speaks volumes of the family unit that they have that they gave of their time and I understand that some people could not be there because of other responsibilities but, it's really kind of Dave to take his time and, and organizational skills so on behalf of the entire City, Dave, and I know that everybody that helped, we really appreciate what you've done and what you'll

continue to do through the years. Thank you very much. (APPLAUSE)

PRESIDENT DENCZAK: Member Dougherty, did you pick up all the trash after the, because I don't want to read in the paper again where the Mayor's cleaning up trash downtown. (laughter) Is there any other miscellaneous business?...

MEMBER HART: Yeah, Mr. President, again, I want to thank Dave and his family because, you know, they've been there and I watched those kids grow up. Especially Dave. Also in terms of entertainment, I guess you haven't lived until you've been there and you've watched Dave do the 'macarana' and some of his other dances, and I did hear many comments that those were the finest burned hamburgers and hotdogs that some of those folks every had the opportunity to eat, so I will try to get a little better at cooking. But, I was asked to read the letter that I passed out to Councilmembers last week and to the Law Director and so, if you'll just give me your indulgence for a few minutes. It says: I ask that you read this letter into record at a term, near term meeting of City Council regarding zoning issues on Cleveland Avenue North, most especially in the Mt. Vernon Neighborhood. Re: The Adult Book Store at the corner of Mt. Vernon and Cleveland. All those zoning issues exist beyond this establishment. You and I have conducted several discussions concerning zoning problems in this area and I addressed these issues before Council and Public Speaks at its meetings on November 25, 2002 and I presume they are a matter of record. For now, I would like to advise you of the following. My wife has been in contact with the City's Zoning Inspector. The Inspector assured her that the proprietor of the identified adult business at the corner of Cleveland Avenue North and Mt. Vernonduly has been notified, in writing, of his zoning violations. Chapter 1161 of the City's Ordinance specifically states the procedures to be followed including enforcement. Without delving into the procedures, this establishment failed to follow in requesting waivers, variances, etc. The fact that the Zoning Inspector notified the owner that he was in violation invoked Section 1161.99, penalty, of the City's Ordinance regarding zoning which reads as follows: Any person who violates a zoning ordinance or fails to comply with any of its requirements, shall be fined not more than \$500 and in addition, pay all costs and expenses involved in the case. Each day such violation continues after receipt of a violation notice, shall be considered a separate offense. The owner of tenant of any building, structure, premises or part thereof, and any architect, builder, contractor....

PRESIDENT DENCZAK: Member Hart, how much longer is this letter?

MEMBER HART: Just, probably another 30 seconds.agent, or persons who commits, participates in or assists, maintains. It says, it sounds to me that a whole cast of characters involved in this project including owner, architect, builder, contractor, agent each should be subject to a \$4,500 monthly fine for non-compliance. It says in closing, I presume that the Law Director's advice is to do nothing unilaterally in allowing the pending law suit to run its course. It says, sorry, Mr. Hart, to me, this is gutless government, too much of which the citizens of Canton have been receiving since we moved here in 1978.

PRESIDENT DENCZAK: Who signed it?

MEMBER HART: This is John Kelleher. He lived at 1820 Mt. Vernon NW before he just recently moved. There's

LAW DIRECTOR MARTUCCIO: Mr. President, I think you'll understand the comments I made last week now that

they're in context. Let me repeat, I believe I have been called a 'girlie man' without the benefit of an Austrian accent and I mentioned that, it's also flattering to be called gutless when I have one of the biggest bellies I've sported in my entire life. (Laughter) I think it's gutless and irresponsible of an elected official who's sworn to uphold the laws of the State of Ohio and Codified Ordinances of Canton and Federal law, to come out blasting like a terminator and put the City's finances at risk. There's certain things that we've had to pursue and we have. There's certain things that we've had to develop, and we have at great time and expense. There are some things that are better left, right now, in the court system, where they are, to be decided by a Judge and/or jury and the Courts of Appeals where it will undoubtedly go, given the nature of the people who are involved in this case and the monies involved. Again, to repeat, we have one and only one Zoning Inspector, and while this neighborhood feels rightfully like their child has been severely injured, we, have to do a form of triage where we get so many zoning complaints and so many allegations of harm around the City, that we have to tend to those which are the worst, in terms of hurting the most people, in terms of facing the most litigation, costing the most money of all of the tax-paying public residents. That will all come out, I assume. And again, I repeat, those issues which have been brought to my attention that are in violation and have not been cured through the attorney and the business, will be taken up again and we will follow them as they are back in our attention. Some are complied with and some weren't.

MEMBER CASAR: Mr. President, I'd like to ask Member Hart two questions. Member Hart, was there a purpose of reading that letter, number one, and what did it really accomplish?

MEMBER HART: I was asked by the residents I try to represent to read the letter.

MEMBER CASAR: I really feel that a copy to all Councilmembers would have sufficed, especially when you're talking about things that are already in litigation.

MEMBER HART: Again, I'm following up on a request that was made to me by my constituency.

MEMBER CASAR: Member....Mr. President, it's just my opinion.

CHIEF OF STAFF CONCATTO: Mr. President, just one quick comment since I've been involved with this issue prior to this Administration and during this Administration. A lot of people, when you're in a position to make a decision, there are a lot of people that may not agree with your decision. We understand that. When we look at this store, this XTC, the video store and all the things that are associated with it, just because we only had one Zoning Inspector does not mean that we did not spend, or that we did spend many, many hours discussing this issue. It was not something that we blindfolded ourselves with. It's something that we looked at, not only from a standard of the neighborhood, but as a City as a whole. These decisions that we made were not made in a vacuum. They were made with a lot of discussion between the Administration, with the Law Department, with Council members, and they were decisions that we felt we had to come to. You may not like the decision, but let me give you this, a lot of effort was put into making those decisions to protect our City and that's how those decisions were arrived.

MEMBER CARBENIA: Mr. President, on this Collins and Aikman, I'm glad the Mayor says that she's in agreement with me to investigate them, but, the only thing I'd like to make clear that the, under this contract, we have a right to renegotiate or take this away as a Committee of Tax Review Committee and the Tax Review Committee meets in February or March and they, they talk on the subject and investigate these things, but we can, that as a minimum meeting of one meeting a year, we can call other meetings and at those meetings we can take action and I think, I think we're on the same

Board. So, thank you, Mayor.

MEMBER DIAMOND: Mr. President, Member Casar indicated on the postponed matter, the property on Cherry, that he distributed a fact sheet to all the Councilmembers. Neither Member Hart nor myself received those. Were those distributed in your Caucus only, and if so, can we get a copy?

MEMBER CASAR: Mr. President, I'm sorry that I omitted the 2 Republicans but, Member Concatto, I mean Member Carbenia also said he didn't get one. So, I'll make sure they get a copy. I passed them out in...

PRESIDENT DENCZAK: You'll make sure she gets it? Hart, did you get a copy?

MEMBER CASAR: Mr. President, they weren't there when I passed them out.

PRESIDENT DENCZAK: Okay. Is there any other miscellaneous business?

MEMBER CASAR: Mr. President, I move we adjourn; seconded. Can't.....

PRESIDENT DENCZAK: One moment. I want to notify you, Member Casar. Your estimated adjournment time, you move at this time....

MEMBER CASAR: Mr. President, that's because Hart read that 5-minute letter...

PRESIDENT DENCZAK: Member Casar, the Chair will recognize your motion.

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN ROLL CALL: 12 YEAS, 0 NAYS

PRESIDENT DENCZAK: This meeting is adjourned.
