PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks. We have 6 speakers. The first speaker is Jeanette Stevenson.

MS. STEVENSON: I can't hardly understand why the city.....(INAUDIBLE)

PRESIDENT DENCZAK: Okay, state your name and address please.

MS. STEVENSON: Are you ready?

PRESIDENT DENCZAK: Yes, state your name and address.

MS. STEVENSON: Well, what I'm here, what I'm here about is there's enough trash....

PRESIDENT DENCZAK: Please, state your name and address.

MS. STEVENSON: My name is Jeanette Stevenson from 4th Ward.

PRESIDENT DENCZAK: And your address?

MS. STEVENSON: 211 Monroe SE.

PRESIDENT DENCZAK: Very good. Thank you. Go ahead.

MS. STEVENSON: Okay now? All right. I feel like enough trash has been dumped on the 4th ward. I can't understand why so many landlords that don't live in the 4th ward that's allowed to buy up these houses real cheap, half fix them up and rent them around to people who don't have any money and they might stay there one month, two months, and you go down the street and they done throwed all of their furniture out on the street and I can't understand why the City is keeping, letting this happening when they have to go up and pick up this trash. That's number 1. Number 2, I can't understand and giving all respect to the Mayor---I've talked with her and she understands some of where I'm coming from. But, I can't understand how we can put a light up at WalMart's that's not opened and we can put a light up at Sugardale for them to get outside. When Timken built on 11th Street, they could put 3 lights and next, on Sherrick Road and Cherry, where children are going to school, have to cross railroad tracks, there is no light. Coming all the way down from Waco to Sherrick Road, 3 schools and not 1 light there for my children. The growth, the shrubbery grows up so high that you can't even see around it. The Principal from Lathrop called, Mr. Womack on the 12th to have that cut down 'cuz nobody could see. They didn't get out there until the 17th and I just can't understand that we value business more than we are our children so, I mean, I got some policemen and I put them on the corner there at Sherrick and Cherry and when they saw the traffic, I said, what do you think's wrong here? They said, lady you need a light up here. How come anybody can see it but the people who need to put a light? Are we going to wait until somebody gets killed? You have sick predators. They have to walk clear out from Sky Land Terrace, all around before they can get

to school. Their mothers have to walk some where, there's no bus for the children to get to school. And yet, I can see that you're passing a law that said let's put a light on to the school building. And you don't have one out there on Sherrick Road and Cherry they're comin' off the expressway, you got trucks comin' every kinda way. When are you gonna put a light up there? That's all I want to know. (*AUDIENCE APPLAUSE*)

PRESIDENT DENCZAK: Who's ward is this in?... Member Zachary.

MEMBER ZACHARY: Mr. President. Hi, I've talked with Ms. Stevenson about this issue before and I do agree with her there does need to be a light there on the corner of Cherry and Sherrick Avenue. I've received more than one phone call about it. I had also talked with the engineering department because near the new Allen School is a very dangerous intersection and they're doing a study on that corner right now to put a light there. But, I do agree with you one hundred percent, Ms. Stevenson, I'm willing to work with you in whatever way I can. I know that we've recently seen a big push to clean up downtown, but I wholeheartedly agree with you about let's clean up ward 4 too. If we can have city employees clean up downtown, let's move them around a little bit. But, I say all that to say that I have placed so many calls to the Street Department. I have placed so many calls to the Health Department. It is to the point where I've asked Kevin Monroe if he could give me an itemized list of all the work orders that have come through ward 4 because I keep calling, and I keep calling about some of the same properties and nothing is being done. So, I would like some type of follow up on that Mr. Service Director because I know that I reported some properties just across from Mrs. Baltimore back in April and they have not been tended to at all and I do know that we sure have these sources, but it's been several months now and this is enough. I'd like to see some progress in that area please.

SERVICE DIRECTOR ELLSWORTH: Mr. President, Member Zachary, if you could give me a list of those addresses that you called about that you didn't have any action on, I would appreciate that.

MEMBER ZACHARY: Mr. Ellsworth, I have a list of over 200 houses that were given to Safety Director Hunt back in April, I believe. And, some of the houses that I reported so far is just because I've driven by and made a phone call so I would really like someone who is actually paid full time to do their job, to pull those work orders for me and I will pull the addresses out individually if I need to. Thank you.

MS. STEVENSON: And as I, as I close, if you don't put a light out there at Sherrick Road and Cherry, I will become the light. I guarantee you that I will stand out there and stop traffic when them children are comin' out of school because I'm not gonna see not one kid killed while the rest of the City is building up. You'd better start takin' care of the southeast end because if I have to go all the way to the White House, that's where I'm going and I'm not against the Mayor. I know that she came down and talked to me but I feel concerned about my children. (*AUDIENCE APPLAUSE*)

PRESIDENT DENCZAK: Safety Director?...

SAFETY DIRECTOR HUNT: Ma'am, the light that you are requesting at Sherrick Road and Cherry. The Traffic Engineer, I will speak to him. They have to do studies before they can put lights up. I will make sure that we do review that area. You spoke to me earlier about, I believe, about, generally, lights also, not just the stop lights, but also other lights.

MS. STEVENSON: (INAUDIBLE FROM THE AUDIENCE)

PRESIDENT DENCZAK: All right. Sir..... One moment please, this is getting out of control here. Safety Director, if you have any problems, speak to her after the meeting. This is the public speaks.

SAFETY DIRECTOR HUNT: I'll see you later ma'am.

PRESIDENT DENCZAK: The next speaker is Joyce Sumlin. Is that correct?

AUDIENCE RESPONSE: She had to leave.

MS. BELLIVEAU: Do I just speak in here, or, what's the deal with this? Okay. Sandi Belliveau, 1022 5th Street NW, Canton. I only have one negative thing I want to bring up and that's a major drug trafficker, 24/7, who is terrorizing my neighborhood. Sammie Lee Moore, 1106 5th Street NW, birth date, May 10, 1959 from the State of Alabama. Okay. Vice knows about him, the Police know about him. He got into it with me about 6 weeks ago. Got arrested for drunk and disorderly. A week later he was picked up for having crack cocaine and marijuana on him. He was out because of an early release so now he's right back. He's on a bike, 24/7, seven days a week, I don't care what time it is, 3:00 in the morning I get up to go to the bathroom, there he is on that bike, peddling. Stoppin' at houses, makin' his drops, pickin' up his money, seein' people at corners. They actin' like he hasn't seen them all week. Hey, hey, hey, and they exchange stuff. Broad daylight, all over. The grand kids, the younger kids, everybody. Okay. He needs to go, he's a major problem there. I guarantee you, you, a policeman could stop him any time for probable cause and find something on this dude. Okay, that's the only negative thing. As far as my neighborhood, known as the Newton Zone, it's coming along just fine. I'm not going to get into the minor flaws that are still going on there because I've got Sammie Lee Moore, and if you take him out, you'll take the majority of all the other problems out between pimping and prostitution and a few that he's actually got working for him also. I do want to note that my street particularly has been blacktopped which looks beautiful. The area's cleaned up. Janet's done a terrific job at getting the, the papers and the trash and all the other miscellaneous blowing-around garbage out of our area. Our neighborhood's a tight neighborhood, okay. We've always been referred to as pretty much the low end of the totem pole. I'm not from here originally, but I know 40 years ago, it wasn't the low end of the totem pole, and I'm one of those people that I would like to have it brought back up to where it needs to be, okay? I'm tired of people saying Oh my God, you live there. I'm sick of that, okay? My, I have the best neighbors you can find anywhere. I'm tellin' ya, that's the reason why I stayed and when I think about leaving them, I can't do it. I just can't. We have police presence there. The police have been tremendous. I couldn't say enough about our Police Department. They really have been excellent. They're there constantly. Car 25, car 21, car 15, car 45, very well mannered. We had, they're workable. We have easy access to the Mayor's office, she's always accessible, okay. Chief McKimm's always accessible. I can't say enough about those 2 specific individuals and if I do too much, I'll start cryin' because if it wasn't for them, we would not be where we are, okay. If you could have seen our mess a year ago, verses the way it is now, I'm tellin' ya, I've lived through it. I've had my life threatened with gunshots, I've had threats to have my home burned down, okay, because we will not give into the scum bags around there and let them continue to terrorize. We've got people that have lived back there for 56 years and are 80 years old. Where are they gonna go? Who's gonna give them a mortgage? Why should they have to leave? NO.

PRESIDENT DENCZAK: Ma'am, your, I'm sorry, but, under Council Rules, your 3 minutes are up.

MS. BELLIVEAU: Okay, thank you, thank you so much. Thank you.

PRESIDENT DENCZAK: Safety Director are you aware of this, this guy on the bicycle?

MAYOR CREIGHTON: Mr. President, I was already alerted to that this afternoon and I've already sent an email to Chief McKimm and will do some follow-up. I was just....Sandi, when we're done can you just talk to me for a minute please. Thanks.

PRESIDENT DENCZAK: The next speaker is Veronica Callahan.

MS. CALLAHAN: My name is Veronica Callahan. I live at 3406 34th Street NE in the City of Canton and I should have been forthcomin' but, I got here a little late, but we are here as NAVE, Neighborhood Association Votes Empowered. Many of you participated with our Meet the Candidates on last year so you'll recognize us, but, because of a conflict in the date, you only see half of us but, we wanted to remind you that we're still out here. We still support you. We would like to concur that Mayor Creighton, you're doing a wonderful job and to all the Councilmen and women. This year has really looked up for our Neighborhood Association. We been to you guys for the last six years that I been a part of this and we have honestly seen a lot of progress in our neighborhoods. We appreciate you. We don't want you to think that we've overlooked your efforts in our CBGD Block Grant Funding for our beautification projects. It's was a great pleasure having the Mayor and a lot of other people in this room participate. I'd like to say also on behalf of my Council ward, Councilman Dave Dougherty, we appreciate you in our community and how you taught us the ropes on how to stopping that strip mall and just to let you know that we'll be back every time we need to, to keep our neighborhood safe, healthy and productive, and would everyone from NAVE please stand at this time? (*AUDIENCE APPLAUSE*) Thank you.

PRESIDENT DENCZAK: The next speaker is Constance Brown.

MS. BROWN: My name is Constance Brown. I live at 620 Bachert Ct. SW near the City of Canton and I want to take this opportunity to say thank you to the Council and all of your efforts here in the City of Canton because I feel encouraged this year also to see that the neighborhoods are improving and thank to you for your backing for the organizations that are improving the looks of formerly run-down properties and building new housing, affordable housing on empty lots. It just gives me a different feeling for the community, I believe it does for a number of us. I do have a couple of questions that are important to us. Let me say one thing before I ask the one. I am real excited, and I believe I speak for a large number of people on the southwest part of our ward, that I say we were thrilled to see some of the tax money being used in the southwest portion of ward 4 when they paved High Street. Thank you. That's great. I have one question about that. We had heard through the community grapevine that 7th Street was to be paved and five days later, High Street was paved. Are we still looking forward to 7th Street being paved?

SERVICE DIRECTOR ELLSWORTH: Ma'am I don't have the list in front of me. We did 7th Street NW, I can't remember if 7th Street SW is on the list. I'd have to look. I can give you, give me your name and number afterwards, I can give you a call tomorrow and let you know.

MS. BROWN: I'll be very happy to do that. And also, I'd like to take this opportunity to say thank you to Councilman Zachary and the detectives and the Law Department for all the efforts to keep the drive-thru out of the southwest part of this town, and I think it's just a marvelous thing that we won. We finally won on something here at the city level. Thank you. I have one other question too regarding safety issues. Are there some regulations about pit bulls? Are they to be tied, fenced, what are we to do if we see them running loose in our community?

SAFETY DIRECTOR HUNT: Ma'am, the City of Canton does have specific ordinances that govern vicious animals, I believe that's the term that we use, and pit bull has been determined to be a vicious animal and as a result of that there are certain fencing and caging requirements that are required. You can call the Law Department. They can give you that Ordinance so that you know it for sure.

MS. BROWN: Thank you. Thanks again. We look forward to the remainder of the year being great as we continue to improve our city. (*AUDIENCE APPLAUSE*)

PRESIDENT DENCZAK: Our final speaker is Mary Rawlings.

MS. RAWLINGS: I'm Mary Rawlings. I live at 2315 15th Street NE. In May I started the Neighborhood Association, Crystal Park Neighborhood Association and we just want to thank the Mayor and the Safety Director and Dave Dougherty and I'm happy to see Jason Reese here because he helped us get rid of a drug dealer in our neighborhood, in 3 weeks, he was packing. We're still in a game of war, we're still keeping an eye on where he's at. So, thank you and we want to show our appreciation to all of you.

PRESIDENT DENCZAK: Member Dougherty, did you have all these people come up here to speak tonight? (*laughter*) Okay, that ends the Public Speaks.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We are now under Miscellaneous Business. First of all, let me say that I'm Ray Denczak and I approve this message. I hear that so much on television I'm going bananas over it. I don't know if all elected officials or candidates are supposed to say that or not, but, but I said it just in case. Furthermore, if any of you Councilmembers have any problems in your wards that require police action, just dial 9-1-1 and ask for Officer Creighton. (*AUDIENCE APPLAUSE*) Member Casar, we're now under Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER CARBENIA: Mr. President, yes, I have a question for the Service Director. I'd just like to know when, if you have any dates on when they're gonna re...re-do the Cherry Street Bridge, the south, the southeast, if they're gonna re-pave that? I know they've done some repairs on it, but it's still pretty bad.

SERVICE DIRECTOR ELLSWORTH: Mr. President, ODOT is currently planning a complete reconstruction of that bridge. I can get back to you during the week about the dates on that. I thought it was to begin next year. Part of the reason we didn't pave it was because of that project. That's why we patched the bridge. I know it's in bad shape now. We did major clean-up on the bridge earlier in the year. It looks a lot, a lot better than it did but, that bridge is in very serious need of repair.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?

MAYOR CREIGHTON: Mr. President, I'd just like to comment. You know, it's nice to hear the compliments to the City Council and the Administration from the neighborhoods, but, you know, I think it just goes to show that we all need to work together because if we did not have the cohesiveness in our neighborhoods and the leadership that you have all demonstrated, we'd still be treading a lot of water and I really do believe that with the hard work of this City Council and the hard work of the Administration, I think we are seeing better days and I thank you for your interest. You do all keep us on our toes. Thank you.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN
