## PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks. We have one person signed up to this evening, Darrell Austin.

MR. AUSTIN: Mr. President, my name is Darrel Austin and my address is 1427 Sycamore Avenue SE, Canton, Ohio, the Mayor of this fine city and all fellow Councilmembers. With the three minutes that I have, I hope to cover some of the things that I hope are of importance here today. Background, meaning that my father, who was a construction worker in this city, who helped to build the cloverleaf that surrounds this big city here. Prior to that, there were earnest individuals who worked and lived in those homes that were taken away at that time. Not only that, he also helped to build, in his construction efforts with the locals that he worked for, the Hall of Fame. Not only that, now, I'd like to move my next point of interest, which is the Compton Elementary School District where there is no traffic light, which, I'd like to know and get some understanding from the Engineering Department of the City, when and where or how was the survey taken to want them not to put a blinking light there in that area. We also need night time city patrol in the City of Canton, in the southeast section, and, as I spoke last Monday night here in Council, my home, from being damaged by hail, was being repaired and the contractor's scaffolding was stolen from around the home. We need night time protection throughout that area in which we have. The solid waste site, which has been proposed, instead of them building or putting a solid waste proposed site there, and I understand, without being in discord with the Mayor of this City, I'd like for them to place the Norma Marshall Educational Center there. If not that, the Mini Hopkins Educational Center there or a building that reflects such. Not only that, is it time for us, as community members in this Council Chambers here today, to teach politicians how to be politicians instead of disregarding the hopes and wishes and the dreams of those individuals who live in this communities for which you represent. Last but not least, the microbial and the bacteria that comes, the water tables drifting slowly down into the ground that has to come back up and be consumed

by every individual in the community. Thank you Mr. President.

SAFETY DIRECTOR HUNT: Mr. President, you asked a question about the Compton Elementary School and the light. We have not done a study at that location, to my understanding. We have done a study at Sherrick Road and Cherry. The Traffic Engineer did a study and it does not warrant a light at that intersection. I called the Principal of Compton Elementary last week and requested that he get back to me so that I could go down there and talk to him about that and other issues. The Mayor and I did go down to Allen Grade School and we spoke to Roslyn Henderson, the Principal, and we had a good conversation so, I'm hopeful that he will call me and I will address that issue with them. Your other comment about the increased police presence, I spoke to Councilmember Zachary last week about increased presence in zone 4. Last Friday, I spoke to the Shift Lieutenant to make sure that we had more zone cars in that area. I have requested that the dispatch, central dispatch, monitor the calls to that zone because Skyland Terrace has called and indicated that there have been some long lapses and, not only that, I came down Saturday with my wife as we were coming to the City and I drove down the area myself and there was activity in the parking lot. So, we have some work to do there. We're going to do more. I have also spoken to Councilmember Zachary about the possibility of objecting to the liquor license, which is always a good way to a......to get their attention. So, we're doing some different things in that area.

MEMBER ZACHARY: Mr. President, if I could just piggyback on a couple of things that Safety Director Hunt is referring to. I had a meeting at the Drop-in center last week and when we left the meeting, there was at least six parked cars there and people hanging out of the cars and I witnessed a couple of drug deals myself. I called the police and for some unknown reason to man, it was almost like they had a sixth sense that someone had called the police and everybody who was not supposed to be at that location, scattered, before the police got there. One thing that I would like to ask is that if we could get vice's involvement in that area. We met with the store owner, we met with the guy that's running the Hall of Fame Mart. They are very amenable to having to correct this situation but they do feel that they're not getting enough support from the Police Department, per se. I don't know if those guys over there have a illegal connection to a police scanner. I don't know, but they say it's not uncommon for them to scatter right before the police come. They need some help, as far as undercover work over there. I think a few arrests would go a long way.

SAFETY DIRECTOR HUNT: Mr. President, just in closing, I spoke to the security fellow from Skyland Terrace, the one you introduced me to when we were at the meeting. They have turned their security cameras to that location. They are filming daily and I assured him that police response would be swift and that if they had to call us everyday, that they should do that. A final comment on their scattering when the police are called. Our lines are encrypted so, I, I don't have an explanation for that.

PRESIDENT DENCZAK: Thank you sir. You.....Thank you.

MR. AUSTIN: Statement? May I respond Mr. President?

PRESIDENT DENCZAK: No, I gotta give you fifteen minutes here because they started a conversation, so I can give you fifteen minutes.

MR. AUSTIN: Okay, yes sir.

PRESIDENT DENCZAK: You have nine minutes left.

MR. AUSTIN: If we could, Mr. President, put a huge asterisk by the conversation in which I entertained. Let's just say for argument's sake as I had began last week. The City and I understand it is a part of the city's obligation to address those issues with the State, as well. I called Congressman Regula's office several times and talked with a secretary who assured me that Mr. Bob Muldins would return my call and as of yet, I have not. You can understand my frustration, Mr. President, and Councilmembers, that I, not being able to get any type of a response from our State Representatives as well, not only that, and I do understand that, yes, this is a State issue, along with the EPA involved with it, that it's almost like saying yes, as long as you follow by these guidelines, which you have met. If you can, place this solid waste transfer site there. But, let me reflect, as I remember and recall when those community members in the City of Canton in the 4<sup>th</sup> Ward and 4<sup>th</sup> Ward, some of them, those names you might even recognize. The Palumbos, the Palaskys, the Pellegrinos, the Austins, which is my last name, the Cooks, all of those individuals are gone on, some of them. I am just a part of the legacy that still lives in the neighborhood rising for more air because they told those residents at that time that the cloverleaf expressway was going to take all of their homes and everybody needed to pack up their bags, their garbage and everything that they came to the city of Canton with, and move out. I'm one that's still there, and I feel that if we get the participation of City Council here, along with the Mayor, and the entirety of its staff, to go along with me as a coordinator to fight against the State, that the Para Lee Compton School in its existence for special needs children as well as those regular elementary school children who have to cross over that track to get to their school, without a blinking traffic light, with garbage being brought into the City from all points throughout this country, to be dispersed and transferred. Thank you Mr. President.

PRESIDENT DENCZAK: Thank you.
