PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY

PRESIDENT DENCZAK: Public Speaks, Open Forum, we have one speaker, Brenda Baylor.

MS. BAYLOR: Hello to everyone. I'm sure that you think I'm here to speak on water. This week, I'm not. I'll do that in 2 weeks.....

PRESIDENT DENCZAK: State, state your name and address for the record, please.

MS. BAYLOR: I beg your pardon?

PRESIDENT DENCZAK: State your name and address....

MS. BAYLOR: Brenda Baylor, 2722 Wood Owl Street NE and as I said before, tonight, I'm not here to speak on water. I'm here because I have some questions about Republic Steel and when I got here tonight, I had no idea that I was going to see where it says Republic Engineered Products and it says that they're now certified to global standards. I don't understand how you get certified to global standards but I really, this even made me more confused, because since this summer, as a result of living close to Republic Steel, we have had explosions and now we are at, pretty much, a daily boom to the point that it shakes the houses that are closer to Republic Steel. The explosion that took place during the summer was so bad until I ran to my door, it scared me to death. Other neighbors on the street ran out and we saw

this dust coming towards us. It looked, it was the most eery thing I've ever seen and I could imagine what it must be like in places where they have major disasters because I have never in my life seen anything like that. It was like this huge monster that was taking over the street. When it finally cleared, every house, every car, any thing that was outside was covered with a greasy, gray, dusty matter that most people that had cars outside, literally had to wash them. The people who have washed screens, and I've done that recently, my hands were literally black. I had to get a grease relief in order to get whatever this was that was in the mixture. If you look at the houses in Georgeview Estates, and I imagine probably any that are over in that area on Georgetown or anyplace else, they are probably a good tentimes dirtier than what they were before this. Now, that was bad enough, there were fire trucks that night, but since then, there is a boom to the point that houses actually shake. Today was the first day that I can think of in quite a while that I did not hear one but I wasn't home all day. Yesterday evening, there was one, the day before that there were two, the day before that, there was at least one. You never know when it's going to happen, it's just this loud boom and either you hear it or it shakes your house. It, to me, seems like an accident waiting to happen. I mean, it's like you, every time it happens, you keep thinking okay, this is the big one. You know, the whole place over there is just gonna go up. They're gonna explode something. I don't know what they're doing over there, but it's very scary and I need to know if that could be checked on and if they have, indeed, reached global standards, then I think that I need to re-think what I thought global standards were, because, it's not a pleasant situation. I mean, it's, it's really bad, and I don't know what's happening over there 'cuz I thought that part of the plant was closed down, but we get booms in the middle of the night, we've had people that live, you know, not on my street, I'm on Wood Owl, but on a couple of streets over.

PRESIDENT DENCZAK: Ma'am, your three minutes are up. Bring your remarks to a close.

MS. BAYLOR: Yes, okay.

PRESIDENT DENCZAK: Member Zachary, this is in your Ward. Are you familiar with this?

MEMBER ZACHARY: Mr. President, to answer your question, yes I am familiar, because I live very close to Republic Steel as well and I have been in my family room and have literally have almost had a heart attack because you feel like an earth quake's coming. I know that there have been some concerns that have been brought to me, not just from the residents in the area, but also from people who work at Republic Steel who are now concerned that they are running lead in their steel again. It seems to me that there should be some type of standards outside of them telling me, well, it's okay because we have approval from the EPA. Well, no one to date has been able to produce any documentation for me as far as what the approval entails and what standards are set forth. Yes, there is a legitimate concern, not only with new home owners in the area, but that, with the people who have lived there for a number of years with the safety of the quality of the air, in the area. Yeah, it does scare ya when you hear a big loud boom in the middle of the night and ya, and you think a second coming is coming and...you know, you want to check and make sure the house is in order. There are some legitimate questions coming out of this area I do believe need to be addressed by the City.

PRESIDENT DENCZAK: Mayor Creighton, are you familiar with this?... Mr. Allen?...

CHIEF OF STAFF/FINANCE DIRECTOR ALLEN: I will find out; I have a meeting scheduled with one of the executives of Republic Steel here in the next couple of weeks. I will find out and take the questions and investigate it as best I can and get back to you.

MS. BAYLOR: And, I would like to ask another question since the question was brought t the floor. Should not, and I'm asking, should not Republic Steel be required to steam clean our houses? They're hideous. I mean it is awful. T hey caused the problem over there. We're talking about, you know, a lot of those homes are brand new and even those that aren't. I mean, they're truly filthy and it's a result of that. I mean, you would have had to have seen the dust as a result of what happened, I mean, and so, ...it's awful.

PRESIDENT DENCZAK: All right ma'am. Mr. Allen, you'll check with them as to whether they'll cover any damages?

CHIEF OF STAFF/FINANCE DIRECTOR ALLEN: I will, Mr. President.

PRESIDENT DENCZAK: We'll find out.

CHIEF OF STAFF/FINANCEDIRECTOR ALLEN: I also understand our Health Department has been working with them, but I will get some answers for you.

MS. BAYLOR Okay, thank you very much.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under Miscellaneous Business. Safety Director, I want to ask you a question. Mr. Hunt, it was brought to my attention, I'm going to ask you, maybe you're aware of it or why it's going on. Fifth Street S.E. dead ends into South Market because of the post office there. So, it's a one way street that dead ends on Market. There are six operating traffic signal lights there. At the entrance of the vacant Hercules Plant, there's seven traffic signals that are flashing a yellow caution light. What is the need for these signals to be at these two locations?

SAFETY DIRECTOR HUNT: Mr. President, this evening Member Babcock called me in my office and asked me the same question. I didn't have an answer for her so I called the Traffic Engineer to go out to that area and take a look. I'll get back, I'll get back to you with an answer. I don't know.

PRESIDENT DENCZAK: Very good.

SAFETY DIRECTOR HUNT: I go by them daily myself.

PRESIDENT DENCZAK: Let us know. Is there any other miscellaneous business?

MAYOR CREIGHTON: Mr. President. I'm just, a few things. First of all, on behalf of the Administration, we'd like to welcome Ward 3 Councilman Jim Griffin. We look forward to working with you in cooperation in Ward. We appreciate your commitment to running. And second of all, the next announcement I have to make tonight, I passed out a press release but I would like to go on record. Tonight, it is my honor and privilege to introduce to you, the newest department head in the city. Nate Cooks, as you all know, Nate has tendered his resignation. He has gotten a better position with another, with a private company, and we are pleased tonight to announce the promotion of Lisa

Gissendanner and Lisa, if you would stand up so everybody, if you wouldn't mind, so everyone can see who Lisa is. (AUDIENCE APPLAUSE) Lisa has been the Assistant Director and has done an outstanding job and she has a big pla....big shoes to fill but we know that Lisa is up to the, up to the standards and she will do a great job. Along those lines, we'd also like to announce the new hours of the Southeast Community Center. This is an effort to allow the children, the youth of our community, to use the Southeast Community Center as it was intended. Therefore, the new hours will be 12 to 9, Monday through, I'm sorry, Tuesday, Wednesday and Thursday. On Friday and Saturday, they will be 9 to 5 and Saturday is a new addition. But, it is proper and fitting that kids have a place to go on Saturdays and then, we will be closed on Sunday and Monday. And so, we are asking everyone's cooperation. We hope that you'll visit with Lisa with any suggestions. We have some other ideas for the community center. We wish her well, we wish Nate well and we appreciate all that you have done in the past and will do. Thank you, Lisa. APPLAUSE) And, lastly, while I still have the microphone, I'm also pleased to announce that we have just recently, effective to....well, it happened the last few weeks, but today is the effective date of the Records Room which is located in the Police Department, will now be a combined effort of employees and will be open from 8 am to 4 pm without any interruption to service. In the past, it was closed down during lunch time and quite frankly, I did not find that acceptable. I think that our public service facilities should be open and we should be waiting on people at all hours when we are here in this building. So, I'm pleased with that; thanks to Bernie for all his work on that and I know that Jean Wackerly will also do a great job there. Thank you.

PRESIDENT DENCZAK: Member Griffith, do you have....Member Griffin, do you have anything to say?

MEMBER GRIFFIN: No. Mr. President.

MEMBER WEST: Mr. President, I have one statement and I want to applaud the Administration for opening up the Southeast Community Center on weekends, on Saturdays. I think that is so fitting and excited for the longest, I've always wanted to know how come our center hasn't been opened on Saturdays when our kids need it the most. I also want to congratulate Lisa and I know you'll do a great job. Congratulations. (AUDIENCE APPLAUSE)

PRESIDENT DENCZAK: Member Griffin, one of the prime duties of the Councilmember from the 3^{rd} Ward is to, during the winter months, to warm up my car for me after the meeting. (AUDIENCE LAUGHTER)

MEMBER GRIFFIN: I'd be honored to.

PRESIDENT DENCZAK: And make sure there's no bombs attached to it. Are there any other Miscellaneous Business?... Member Bernabei?...

MEMBER BERNABEI: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call vote please.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN ROLL CALL: 11 YEAS, 0 NAYS
