MEMBER ZACHARY: Mr. President, Personnel Committee will meet at 6:00 on Monday, February the 7th.

MEMBER GRIFFIN: Mr. President, my Environmental Public Utilities will meet Monday at 6:30.

MEMBER BERNABEI: Mr. President, Judiciary will meet Monday at 6:45 p.m.

MEMBER BABCOCK: Mr. President, Public Safety and Thoroughfares will also meet next Monday at 6:00.

CHAIRMAN CASAR: Any other Committee Chairmen need to call a meeting?...

MEMBER HAWK: Mr. President, Finance Committee will meet Monday, 5:15.

CHAIRMAN CASAR: Is that it?.... (NO RESPONSE)

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

CHAIRMAN CASAR: Public Speaks Open Forum, City Business Only. We have four speakers signed up tonight. The first Speaker is Chester R. Henderson.

MR. HENDERSON: Good evening Mr. President, Mayor, Presiding Officers, Members of Council, Fellow Citizens. My name is Chester Henderson. I reside at 1524 5th Street NE here in the City of Canton, Ohio. I'm here to formally complain before the City Council about the abandoned cars/junk yard that is right next door to my property. That property's owned by Mr. James Harris and that property is listed as 1534 5th Street NE here in the City of Canton. My wife and I bought that property about 8 months ago and we've been trying to see if we can't get rid of that eye sore. It's a bunch of abandoned cars/junk yard, it harbors rats and rodents, and nothing has been done about it. I have complained to Officer Jack Crider. I have complained to the City Health Director. I have also complained to my City Councilwoman and nothing has happened to my satisfaction. I've also spoken with Mr. Harris personally on several occasions and to no avail has anything of any good has come out of my communications with Mr. Harris. If my property was located on the northwest side of town, that junkyard would not be there, but, just, I don't know, because I live in that particular side of town, the hood, no one seems to give a darn. But, my property value is going down and down and I need help.

MEMBER ZACHARY: Mr. President, Mr. Henderson, I do want to thank you again for coming. He's a truck driver and it's difficult for him to get away most of the time to come to Council meetings. But, we have had numerous discussions about this. I believe this past summer, towards the end of the summer, they did make Mr. Harris kinda clean

up his sidewalk area a little bit but this is not the only property this man has in the City of Canton with this same problem. He also has one in Ward 2, as Tom pretty much knows, on Mahoning Road and he's not being made to be accountable by anybody for getting these junk vehicles out of his property. He has a gold, really large gold car parked in front of his home on 5th Street. The tires have been marked months ago. It's never been picked up and that is a problem. I understand your frustration, Mr. Henderson. He's come down here tonight at my request to ask that something be done. Why is this man continued to allow, to be allowed to keep these properties in this condition and every time they come after him for the cars, he buys a license plate and slaps it on and then it's okay. Well, it's not acceptable to live next door to that and I'd like to, at least, have something done.

SAFETY DIRECTOR HUNT: Mr. Henderson, I'd like to talk to you after we're done here. Usually Officer Crider does a very good job following the laws and ordinances for the City of Canton. He hasn't done it to your satisfaction; we'll find out what's going on. Give me, I'll talk to you afterwards. I'll come out and look at your property tomorrow.

MR. HENDERSON: Thank you, sir. I appreciate the, anything you can do to help to alleviate the eyesore that my wife and I have to look at on a daily basis. It has snowed recently and I can't even get in my front door because of that, I think it's a 1976, '74 Lincoln Town Car sitting in front of my property. Snow truck comes by and he plows right up to the back of that car and goes around it. Any of my family members, friends, or visitors that come to my house, they have to get out in the alley that's adjacent to my house, come in my back door; they cannot come into the front. All I'm trying to do is do what's right, you know. I'm here because I, this is my last resort. Like, Councilwoman Zachary stated, I drive an 18 wheeler and within the last 8 months, the police have come to my house on 2 occasions to ask me to move my commercial vehicles off the streets of Canton, or, it will be towed, and the last time they were there, they firmly told me that the next time my truck is parked on any street in Canton, they're not gonna come and ask me to move it, they're gonna tow it. Well, why is it that I can be told by the Police Department to move my truck but for the last 8 months, no one has done anything to my satisfaction, or to the City's satisfaction to address Mr. Harris on this deplorable condition that I have to live with on a day to day basis; and again, I hate to be redundant, if I lived in the northwest side of town, that junkyard, that car, those abandoned cars would not have existed one day. Thank you.

CHAIRMAN CASAR: Thank you, Mr. Henderson. The next speaker is Carethea Turner.

MS. TURNER: Good evening. Sir, President and other Council. I am Carethea Turner. I live at 538 14th Street SE. I am here about a problem that happened back in August 2004 at my home. I had a flood in my basement and I contacted the City and the City sent me out a letter 2 months prior to me contacting them, letting me know that it was not their fault that my basement got flooded. I then turned around and contacted the person that they said was the culprit of the reason why my basement got flooded. I have not had anything, any response from this man other than I'm gonna take care of it. My thing is, if this man was at fault for doing this, why did the City pay for it and why didn't the City contact this man and make him pay for it instead of using taxpayer's money and, he's not reimbursing me for what happened to my house, and I'm paying double because I'm a taxpayer, I work, and I don't feel that it's right. He should have been made to pay for what he did and he was never contacted by the City and informed this is what you did, you plowed over a manhole, filled it with dirt and we have to send out people for 3 days to stay out there and pump water out, have 2 pumps, pump water out and I have feces in my basement that my dad had to scoop out and put in trash cans until they can get the water to go down.

CHAIRMAN CASAR: Service Director, do you have any comments or....?

SERVICE DIRECTOR CONCATTO: Yes, I am aware of this, Mr. Chairman. What we've said, I believe, and I've passed this on to Councilperson Zachary, is that you have an issue with the contractor. You know who the contractor is and that contractor is denying his claim, then you should file a small claims action in court against him. But, we have no control over making that contractor pay your, pay that judgement if in fact he is guilty of what he, what you claim that he is. The City, I think, said it was not our fault and that we did identify the contractor and I believe, if right now, and I'm trying to work with the contractor, but right now, I would recommend you file a claim in small claims court.

MS. TURNER: Okay, like I say, my question was why wasn't, why didn't the City contact him if this was made to be his fault? Why didn't the City contact him, why did I have go and contact him because like I say, it was taxpayer's money that was made to pay for something that was his fault.

SERVICE DIRECTOR CONCATTO: Mr. President, I believe that the issue is that he denies that it's his fault. I mean, he, we may claim it's his fault, but he denies that it's his fault. So, I mean, he has a right to deny it, I don't know...that argument then becomes with, unfortunately, becomes with you and he with that contractor and again, I believe that's the area for you right at this time, is to probably file at small claims court. I don't know that that's an expensive issue but, that would be the next step for you to take. I will continue to try to work through this, but, timing is not very good right now and I understand that you've been frustrated. I don't blame you for that. I've seen the pictures. I know what, what your claim is. The Law Department, I've seen the claim with the Law Department. The Law Department denies that it's the City's responsibility, so, I will continue to work towards it but I would suggest that your only outlet right now is to file with small claims.

MEMBER ZACHARY: Mr. President, I think it's a deplorable shame that no one, at least from the Administration's side, and we say we are here to serve the citizens of Canton, has even bothered to call Miss Turner to talk to her about it. She was sent a letter indicating that this was not the City's problem, but I'm sorry, any person sitting in this room who has raw sewage bubbling up in their basement, would not like it. It is somebody's responsibility. Somebody is liable. The City is saying that they're not, Joseph Jeffries Company is saying that they're not liable. Caught in the middle is a young woman who has no where else to turn. It's a shame. We've batted her around for months. We met with Mr. Jeffries and he promised her that he would take care of the problem, and instead of doing that, he went to the City and jumped on who's ever head he could to say why are you trying to blame this on me. Someone needs to step up and take responsibility and we've always seem to put it back on the resident and say you need to file a small claims suit. We are inconveniencing this woman number 1, and number 2, she can not afford to replace the things that were lost in her basement. Someone needs to look into it from our end, at least, and be responsible and do what's right, and I'm not saying that if they're not liable, that we should pay for it, but we should make the responsible parties take the responsibility and do that. Thank you.

SERVICE DIRECTOR CONCATTO: Mr. President, Member Zachary, you have called me a couple times on this and I have not talked to Ms. Turner because I talked to you and I think I recommended to you that you talk to him. If you wanted me to call her personally, I could have done that. I wasn't trying to avoid talking to her. I just thought that you had that line of communication and that I, I think that I recommended to you to tell her to sue Mr. Jeffries if that was her desire to do that. I was not ignoring her, as the Administration, it's just that I thought in our conversation that you were going to pass it on.

MEMBER ZACHARY: All of this information was conveyed to Mr. Turner, or Miss Turner, Service Director Concatto, but like I said, I am the go-between and I'm caught in the middle because I'm trying to, to, to work on her behalf and as well as deal with the other side of it and we're not getting any where. So, like I said, someone from this Administration should sit down and talk with this woman. The Jeffries Company did and then ran back and said hey, why are you blaming it on us? Someone needs to be responsible and, and take the responsibility.

MS. TURNER: I'd just like to thank you for hearing my side and I just hope something is done. I think Mr. Jeffries should be made to pay back the City the money that the City had to put out to re-do this manhole. I mean, he should have to pay somehow, not, not only to me but he should have to pay to the City because it came out of the City's pocket. Out of the taxpayer's pocket, for them to re-do this manhole that he plowed over and the City's saying that they're gonna take him out there and show him, I want to be there when they take him out there and show him. Thank you.

CHAIRMAN CASAR: Thank you. The next speaker is Otis Hasker.

MR. HASKER: Good afternoon. My name is Otis Hasker, Carethea Turner's dad. I'm the one who had to clean up the mess in the basement. I seen the raw sewage down in the basement, don't look nice, don't smell nice. It took me 3 days to clean the mess up. It took me a month to get the stink out. Now, had it been me that knocked the manhole over, you all would come to me and make me pay for it. Some man with a lot of money, cheap-tap this thing and you-all don't do nothing to him. We pay taxes. Three days they pumped water. The City paid for the manhole, they paid for the manpower to pump the water out. That come out of my money. I worked 30 years in Canton, and never saw nothin'. This is what my daughter gets for payin' taxes, trying to buy a house and live nice. This here just don't make sense. They said nobody's responsible. Somebody's responsible. Like the man said about the cars parked in his backyard. Been right there, I'll bet they've always been there. Same way about the sewers. If they'd a plowed it over, they'd a been there the next day to clean it all up and pay me for it but, we live in the wrong part of town I think. Somebody should be made accountable some place. I appreciate it. Thank you.

CHAIRMAN CASAR: The next speaker is Larry Williams.

MR. WILLIAM: Mr. Vice President, Members of Council, my name is Larry R. Williams. My address is 1024 Bellflower Avenue SW. I am here to speak against the amending of the Fire Department Chapter 133 of Codified Ordinance, regarding the charges of public safety services at the scene of a motor vehicle accidents. Well I'm certain that the Committee Members, Mr. Carbenia, Mr. Bernabei and Mr. Hawk have found, have checked into the legality of these charges. I am not convinced that there's a need nor that it's ethical for them to charge us for these. You currently charge the residents of the City of Canton for the ambulance services and to be certain, I'm against those charges also. Several years ago, I was promised and assured by members of Council and other members of the political parties in the City of Canton, that they would never pursue collections of these charges to people who were unable to pay them. Now, Mr. Hunt has stated on WHBC that he will pursue these by collection agency or however. That seems really deplorable to myself. Other residents and myself feel that these services are being paid for by our taxes and we do not feel that we should be paying again by the insurance companies. While the statement was made to me that the insurance companies will pay these, we are all well aware that whatever you charge the insurance companies, we will end up paying it back. I just implore you to re-examine your position on these, on this particular ordinance that you're trying to put in again. Thank you.

CHAIRMAN CASAR: Thank you, Mr. Williams. That ends Public Speaks portion of Canton City Council.

MISCELLANEOUS BUSINESS

CHAIRMAN CASAR: We are now under Miscellaneous Business. Is there any miscellaneous business?...

MEMBER CARBENIA: Mr. President, I move we adjourn; seconded.

CHAIRMAN CASAR: It's been moved and seconded we adjourn. Roll call vote please.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN ROLL CALL: 12 YEAS, 0 NAYS

CHAIRMAN CASAR: This meeting is adjourned.
