59. COUNCIL AS A WHOLE COMMITTEE: COMMENDING THOMAS M. BERNABEI FOR RECEIVING THE STARK COUNTY 2005 ITALIAN-AMERICAN FESTIVAL DEDICATION AWARD. - ADOPTED BY COUNCIL

MEMBER CASAR: Mr. President, I move we adopt Ord...Resolution #59; seconded

PRESIDENT DENCZAK: Moved and seconded that you adopt Resolution #59. Are there any remarks under this Resolution?

MEMBER CASAR: Mr. President, I request that the Clerk please read this Resolution.

PRESIDENT DENCZAK: Madam Clerk, will you please read the Resolution.

RESOLUTION #59 WAS READ AS FOLLOWS: AN INFORMAL RESOLUTION RESPECTFULLY SUBMITTED BY COUNCIL AS A WHOLE COMMITTEE ON THIS 11TH DAY OF JULY 2005. WHEREAS, JULY 8, 9 AND 10, 2005 MARK THE 19TH ANNUAL ITALIAN-AMERICAN FESTIVAL, A CELEBRATION OF ITALIAN CULTURE, FOOD AND MUSIC. THE ITALIAN-AMERICAN FESTIVAL DOES SO MUCH TO HELP OUR COMMUNITY NOT ONLY BY ATTRACTING MANY OUT OF STATE VISITORS AND APPROVING THE LOCAL ECONOMY, BUT ALSO BY AWARDING SCHOLARSHIPS TO HIGH SCHOOL GRADUATES. TO DATE, THE FESTIVAL HAS AWARDED A TOTAL OF \$140,000 IN SCHOLARSHIP MONIES; AND WHEREAS, EACH YEAR SINCE 1987, THE ITALIAN AMERICAN FESTIVAL FOUNDATION AND BOARD OF TRUSTEES HAS PROUDLY SALUTED AND DEDICATED ITS ANNUAL FESTIVAL TO A STRONG SUPPORTER OF THE ITALIAN AMERICAN COMMUNITY AND THE FESTIVAL. THIS YEAR'S DEDICATEE IS A LIFELONG RESIDENT OF CANTON AND ALSO ONE OF OUR OWN ELECTED MEMBERS OF CITY COUNCIL. THOMAS M. BERNABEI'S FAMILY ORIGINATES FROM THE ITALIAN AREA KNOWN SA ABRUZZI. THE SON OF JOSEPH AND DOROTHY BERNABEI AND GRANDSON OF GIACOMO AND CATHERINE BERNABEI, TOM GRADUATED FROM LEHMAN HIGH SCHOOL IN 1964, BROWN UNIVERSITY IN 1968 AND THE OHIO STATE UNIVERSITY COLLEGE O FLAW IN 1975. A VIETNAM VETERAN, TOM SERVED IN THE US ARMY FROM 1968 TO 1972; AND, WHEREAS, TOM PRACTICED LAW AND PARTNERED WITH HIS FATHER FROM 1975 TO 1989. HE WAS ELECTED TO THE OFFICE OF CITY LAW DIRECTOR IN 1989 AND WAS RE-ELECTED FOR THREE ADDITIONAL TERMS. IN 2004 HE WAS ELECTED TO THE POSITION OF COUNCILMEMBER AT LARGE. TOM HAS ACCEPTED THE ITALIAN AMERICAN FESTIVAL DEDICATION IN HONOR OF HIS FATHER, JOSEPH, A FIRST GENERATION ITALIAN AMERICAN, WHO WAS A FOUNDING MEMBER OF SEVERAL ITALIAN/AMERICAN ORGANIZATIONS IN CANTON AND STARK COUNTY; AND; WHEREAS, TOM BERNABEI HAS BEEN ACTIVE IN MANY COMMUNITY AND CIVIC ACTIVITIES. HE CO-CHAIRED THE STARK COUNTY RTA BOARD IN 2001, CHAIRED THE CANTON CITY SCHOOL DISTRICT LEVY COMMITTEE IN 2004, IS A MEMBER OF THE UNIOUE CLUB OF STARK COUNTY, AND HAS SERVED AS A MEMBER OF THE ITALIAN AMERICAN FOUNDATION SCHOLARSHIP COMMITTEE SINCE 1994; NOW THEREFORE BE IT RESOLVED: THAT WE, THE MEMBERS OF THE COUNCIL OF THE CITY OF CANTON, OHIO DO HEREBY RECOGNIZE, GIVE SPECIAL TRIBUTE TO AND COMMEND MOST HIGHLY AN OUTSTANDING PRODUCT OF OUR CANTON COMMUNITY, THOMAS M. BERNABEI, FOR RECEIVING THE 2005 ITALIAN AMERICAN FESTIVAL DEDICATION AWARD, AND FOR CONVEYING STRONG CHARACTER AND A SINCERE WILLINGNESS TO SERVE ALL OF THE CANTON AND STARK COUNTY RESIDENTS. CONGRATULATIONS, TOM, AND THANK YOU. (AUDIENCE APPLAUSE)

PRESIDENT DENCZAK: Did you write that yourself, Tom?... Are there any remarks?... Okay, if not.....

MEMBER CARBENIA: Yes, I have a remark. I am one Italian on this Council who agrees with this award for Tom Bernabei. He's a fine person. I've known him many, many years and he's always been right and up front and always tried to do what was good for this community and the Italian American community, so, I agree with it.

PRESIDENT DENCZAK: Any further remarks?

SERVICE DIRECTOR CONCATTO: Mr. President, as a fellow Italian, I know Mr. Bernabei is embarrassed with this because he's not that...he doesn't like awards but, on behalf of the Unique Club which I'm also a fellow member, we congratulate you and I know personally, as a friend, that you're well deserving of this award.

PRESIDENT DENCZAK: Are there any more Italians that wanna speak on this? (AUDIENCE LAUGHTER)

LAW DIRECTOR MARTUCCIO: Mr. President, there is. Mr. President, there is. I can't let the other two Joe Italians speak without the final....What other people, many people don't know also about Tom is that, not only has he been an active member and screener on the Italian American Scholarship Committee for students who have exhibited scholarly and athletic super ability, but he's personally donated a great deal of money to that project to make a lot of those scholarships available to a lot of deserving people, thus ensuring the future of our county is in good hands and for that we thank him. Particularly, in my case, my daughter was one of those recipients one year, so, I particularly do want to thank him for that.

MAYOR CREIGHTON: Mr. President....

PRESIDENT DENCZAK: Another Italian? Mayor.

MAYOR CREIGHTON: No, on behalf of the Scotch-Irish delegation, (AUDIENCE LAUGHTER) and on

behalf....

PRESIDENT DENCZAK: Mediterranean Irish?

MAYOR CREIGHTON: Weir is. Thank you. On behalf of the Administration, I too have a proclamation. I had the distinct honor of being in the audience that day that Tom received his, his award and as I shared with the audience, not only does he bring an intelligence and experience, but he also brings balance to Canton City Council and for that I am grateful. Thank you.

SAFETY DIRECTOR HUNT: Mr. President, although I'm not Italian, I grew up with a big Italian family, the Changets from the Canton South area, so I've had my share of homemade bread and homemade wine. But, I want to thank Councilmember Bernabei, when I first started with the City of Canton in the Prosecutor's office, he was my first boss, then I moved over to the Civil side. I found him to be a very tough task master. I learned a lot and he always had the City's best interest, number one, in his heart. So, I, too, congratulate you, 'paisano'.

MEMBER DIAMOND: Mr. President. Well, I am 100% Italian and I didn't realize we had 5 Councilmembers that were 100% Italian, but I will say that Tom Bernabei, he's intelligent and you have to speak to him just a few moments before you realize that he can be impatient, because I think he's impatient with people who don't see the need to get things accomplished in the right way. His intentions are always honorable. He does not judge any one on their political party, he judges them on their hard work, their sincere concern for this city and I will

miss him, I will miss his intelligence, I will miss him as a constituent, should he leave the 8th Ward, and I appreciate all the hard work you did, especially with the finances of the City of Canton during this last term. Thank you.

PRESIDENT DENCZAK: Any other remarks?

AUDITOR MALLONN: Mr. President. Yes, Mr. B, you and my father were great friends over the years and we've become great friends over the past several years and I would just like to thank you personally, everything that you've done for me and my family. It's greatly appreciated and I cannot think of a more deserving person than yourself for this award. So, thank you for everything that you've done for me. Thank you, sir.

PRESIDENT DENCZAK: Any other remarks?

MEMBER CASAR: Mr. President. I'll just present it right here if I may.

PRESIDENT DENCZAK: You want to present it now?

This award is because you've received the Stark County 2005 Italian American Festival Dedication Award that you are truly deserving of, and I appreciate it and it is with a great deal of respect, that all that you have done for this Councilman when you were department, a director, and now that you have been a Councilman and I tried my darndest to get you to run again, but it didn't help. Thomas, I really appreciate it and I really, really, really appreciate that I can call you a friend. So, congratulations and good luck to you. (EXTENDED AUDIENCE APPLAUSE)

MEMBER BERNABEI: Mr. President. (Member Bernabei spoke in Italian to accept his proclamation. The translation is as follows) I say to you, it is an honor to accept this award, this commendation tonight. Many, many thanks, and thanks to everyone for all their very, very nice comments. Did I die? (AUDIENCE LAUGHTER)

PRESIDENT DENCZAK: You didn't mention anything in the Resolution about the Mafia. Congratulations Tom, you deserve it. Next resolution please.

60. HART, RICHARD D, WARD 7 COUNCILMEMBER: COMMENDING ALL THOSE INVOLVED IN

THE ULSTER PROJECT. - ADOPTED BY COUNCIL

MEMBER CASAR: Mr. President, I move we adopt Resolution #60; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adopt Resolution #60. Are there any remarks under this Resolution?.... Member Hart?...

MEMBER HART: (INAUDIBLE)

PRESIDENT DENCZAK: Madam Clerk, would you please read the Resolution.

RESOLUTION #60 WAS READ AS FOLLOWS: AN INFORMAL RESOLUTION SUBMITTED BY RICHARD D. HART, WARD 7 COUNCILMEMBER ON THIS 11TH DAY OF JULY 2005. WHEREAS, FOR CENTURIES. SECTARIAN VIOLENCE HAS RAGED BETWEEN CATHOLICS AND PROTESTANTS IN NORTHERN IRELAND; AND WHEREAS, THE MASSILLON/CANTON ULSTER PROJECT IS AN INTER-DENOMINATIONAL ORGANIZATION THAT WORKS TO PROMOTE PEACE IN STRIFE-TORN NORTHERN IRELAND. EACH YEAR THE ULSTER PROJECT BRINGS TWELVE TEENAGERS FROM THE GREATER BELFAST AREA TO WESTERN STARK COUNTY TO LIVE, WORK AND PLAY WITH THEIR AMERICAN COUNTERPARTS FOR THE MONTH OF JULY. THE NORTHERN IRISH GROUP IS COMPRISED OF SIX GIRLS AND SIX BOYS, BETWEEN 15 & 17 YEARS OF AGE. HALF THE GROUP IS CATHOLIC AND HALF PROTESTANT. THEY STAY WITH LOCAL HOST FAMILIES WHO HAVE A CHILD OF SIMILAR AGE. TOGETHER, THE AMERICAN AND NORTHERN IRISH TEENS SPEND A LIFE-CHANGING MONTH LEARNING TO SEE BEYOND DIFFERENCES IN NATIONALITY AND RELIGIONS; AND WHEREAS, SINCE 1982, THE MASSILLON/CANTON ULSTER PROJECT HAS GIVEN HUNDREDS OF NORTHERN IRISH YOUTH THE OPPORTUNITY TO MAKE FRIENDS FROM OPPOSING SIDES OF THE CONFLICT IN THEIR TROUBLED LAND. THROUGH THE GENEROSITY OF STARK COUNTY CITIZENS, THESE FUTURE LEADERS GET A FIRST-HAND GLIMPSE OF AMERICA, AND THE VALUES OF FREEDOM, EQUALITY, AND BROTHERHOOD THAT WE AS AMERICANS LIVE BY; AND WHEREAS, THE HOPE IS THAT FRIENDSHIPS MADE AND LESSONS LEARNED HERE WILL MAKE THEIR WAY BACK TO NORTHERN IRELAND, AND HELP TO BRING HEALING AND RECONCILIATION TO THEIR PEOPLE. TOGETHER, WE BELIEVE THAT WE TRULY CAN CHANGE HISTORY. ULSTER PROJECT TEENS EXPERIENCE OPPOSITE FAITH PERSONS THROUGH ON-ON-ONE ENCOUNTERS, AND THESE EXPERIENCES HELP THEM UNDERSTAND THAT HATRED IS SO POINTLESS. NOW, THEREFORE, BE IT RESOLVED; THAT WE, THE MEMBERS OF THE COUNCIL OF THE CITY OF CANTON, OHIO DO HEREBY GO ON PUBLIC RECORD AS COMMENDING ALL THOSE INVOLVED IN THE ULSTER PROJECT INCLUDING THE EXECUTIVE COMMITTEE, THEIR AMERICAN HOST FAMILIES, AND THE HOST TEENS FOR THEIR HARD WORK AND DEDICATED EFFORTS IN HELPING TO BUILD UNDERSTANDING AND FRIENDSHIP BETWEEN CATHOLIC AND PROTESTANT TEENAGERS FROM NORTHERN IRELAND. WE FURTHER COMMEND OUR NORTHERN IRISH GUESTS FOR THEIR VISION OF A PEACEFUL, DEMOCRATIC NATION, AND WISH THEM GOD-SPEED IN THE TASK THAT LIES BEFORE THEM.

PRESIDENT DENCZAK: Are there any remarks under this Resolution?... Member Hart?

MEMBER HART: For years, in the world we live in, there seems to be constant acts of terrorism and in those acts, many innocent die. When I hosted a young man from Northern Ireland, one of the young girls on the trip had lost her father during an act of terrorism. On 9/11, our own country experienced the act of terrorism and last week, those English living in London, experienced an act of terrorism, and many areas and communities in this

world are experiencing daily acts of terrorism, and a free world cannot exist if we let the terrorists win. And many times people find many reasons for trying to justify those acts. There was a young lady, who on the back of her shirt had Ulster and the one word at the top for you was understanding, and hopefully, when you go back and with many other youths in the world, we can all do our best to understand one another, to love one another and find a better way of solving our problems and, you know, there's that song we've sung in church, *Let There Be Peace On Earth* and let it begin with me. And we all have that obligation and when we go back to do our very best to make this world a better place and, you know, for many of us, we're getting up in years and some of us, more years than others, but the future is for the youth out there and hopefully you'll do your best when you go back to be makers of peace and love one another, not wars; and again, I'll ask all my members of the City Council to pass this. Thank you.

PRESIDENT DENCZAK: Any other remarks?... The question you're voting on now is Resolution #60. Before you vote, the Chair's gonna ask if each of the young women and men stand individually and give us your name. (All members of the Ulster Project introduced themselves by announcing their names) Is that it?... Thank you. (AUDIENCE APPLAUSE) The question you're voting on now is Resolution #60. By voice vote, all those in favor, signify by saying aye. Those opposed no.

PRESIDENT DENCZAK: Moved and seconded that you adopt Resolution #61. Are there any remarks under this Resolution?

MEMBER HART: Mr. President. Would the Clerk please read that Resolution also?

PRESIDENT DENCZAK: Madam Clerk, would you please read Resolution 61.

RESOLUTION #61 WAS READ AS FOLLOWS: AN INFORMAL RESOLUTION RESPECTFULLY SUBMITTED BY RICHARD D. HART, WARD 7 COUNCILMEMBER, ON THIS 11[™] DAY OF JULY, 2005.

WHEREAS, LINDA VA MOORHOUSE HAS ANNOUNCED HER RETIREMENT AS PRESIDENT AND C.E.O. OF THE CANTON SYMPHONY ORCHESTRA. SHE HAS RECEIVED THE SOROPTIMIST INTERNATIONAL WOMEN OF DISTINCTION AWARD. SHE IS A MEMBER OF THE BOARD OF DIRECTORS OF THE NEOTROPICAL GRASSLAND CONSERVANCY, AND HAS BEEN ACTIVE WITH THE ARTHRITIS FOUNDATION OF STARK COUNTY, LEADERSHIP STARK COUNTY, UNITED WAY OF STARK COUNTY, THE NATIONAL FIRST LADIES' LIBRARY. AND IS A FORMER PRESIDENT AND CHAIRMAN OF THE BOARD OF THE CANTON PALACE THEATRE ASSOCIATION; NOW, THEREFORE, BE IT RESOLVED; THAT WE, THE MEMBERS OF THE COUNCIL OF THE CITY OF CANTON, OHIO ON THIS 11[™] DAY OF JULY, 2005, DO HEREBY GO ON PUBLIC RECORD BY COMMENDING LINDA V. MOORHOUSE, PRESIDENT & C.E.O. PRESIDENT DENCZAK: What Time? 6:15? ... (MEMBER WEST RESPONDS 6:50)6:50.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum - City Business Only. We have three speakers signed up this evening. First speaker is Randy Dyer.

MR. DYER: First of all, my name's Randy Dyer, 616 15th Street NE.

PRESIDENT DENCZAK: Mr. Dyer, Council rules ask that you list the specific subject matter and you wrote down general. Now, general is not limited to or dealing with any one particular class of things, so, what is your specific subject?

MR. DYER: Sir, I guess safety. It would be under safety.

PRESIDENT DENCZAK: Safety?

MR. DYER: Yes. First of all before we even discuss it, I wanted to say to Thomas, I talked with Mr. Hawk and thank you, Mr. Hawk. He got me straightened around on where I misunderstood what was going on and I appreciate that and I apologize for any problem there. In April, we were in here and we discussed the cameras for safety being posted on the streets and I started to talk to you, Mr. Hunt, before the meeting. We didn't get The basic question I have is, at that time we were told approximately a month we would see the first four cameras in place. Obviously, there was a hold up. When can we expect to see those cameras? That would be my first question. The second thing that I wanted to do, my wife was gonna come up here and speak, so I'll just share a little bit about what she wanted to speak on. We wanted to say thank you to the Mayor for her patience with us and her time that she's given us in working with us. We wanted to publicly acknowledge Chief McKimm and his cooperation with us. I wanted to acknowledge Thomas. As amazing as it sounds, I was up, what was it Friday night, I think, Saturday night about 2 or 3 o'clock in the morning out on the front porch, just kinda watching the neighborhood and this guy's driving around the neighborhood at 3:00 in the morning. Just kinda lookin' things over, so, you know, we wanted to say thank you for that. We wanted to say thank you. We've seen the extra patrol cars in the neighborhood. That's a good thing. So, we just wanted to publicly acknowledge some of the good things that have been taking place and then I'll leave it for you to answer the question on the cameras.

SAFETY DIRECTOR HUNT: Mr. Dyer and I spoke prior to speaking here this evening. I told him that a couple months ago that we thought that we'd have the cameras in a couple weeks. We were not able to do that in a timely fashion. I will let you know that we have gotten some money in the budget to purchase the cameras. That was a stumbling block. We've managed to do that. We scheduled a meeting next week with a supplier so

I have five city departments coming in. They're going to determine from the supplier the type of specs that we need, so, I've learned my lesson. I won't say when we're going to have the cameras but I will say that we're working on it, Mr. Dyer.

PRESIDENT DENCZAK: The next speaker is Linda Williams.

MS. WILLIAMS: Hello. I just want to extend thank you....

PRESIDENT DENCZAK: State your name and address please.

MS. WILLIAMS: Pardon?

PRESIDENT DENCZAK: State your name and address please.

MS. WILLIAMS: Linda Williams.

PRESIDENT DENCZAK: Address please?

MS. WILLIAMS: My name is Linda Williams, regarding drugs......

PRESIDENT DENCZAK: Your address too.

MS. WILLIAMS: Pardon?

PRESIDENT DENCZAK: Your address.

MS. WILLIAMS: 610 Marion Avenue SW.

PRESIDENT DENCZAK: Okay.

MS. WILLIAMS: We just, on behalf of the association of the Southwest Neighborhood, we would like to thank the drug enforcement agency for helping us clean up our neighborhood.

PRESIDENT DENCZAK: Okay, thank you. The next speaker is Constance Brown.

MS. BROWN: Constance Brown, 620 Bachert Court SW. It's a great surprise that you can come to Council to request that monies be found somewhere to extend the drug enforcement team that has been so active here in the last several weeks, and, it's been a great job in different parts of Canton, we've benefitted and we appreciate that. The wonderful thing is coming to Council and finding out that you folks have already found money to support this team of professionals that are able to come in under tremendous disguise and have really been able to find some of the most serious areas of drug problems and really bring these people to task. Thank you. (AUDIENCE APPLAUSE)

PRESIDENT DENCZAK: Mayor, I read in the paper where the task force is going to stop operating after 30 or 60 days, something like that?... Who?... (INAUDIBLE) No, I just read an article in the paper recently where somebody had stated that the task force was not operating after 60 days.

MAYOR CREIGHTON: Mr. President. Originally, the first wave of the task force was a 60 day period. That

time has elapsed and now we are going to proceed for, I believe, another 60 days with, with the next wave, so we are going to continue.

PRESIDENT DENCZAK: Okay. I just don't like the idea where you tell these people that violate the law that you're going to stop enforcing the laws after 60 days. (AUDIENCE APPLAUSE)

SAFETY DIRECTOR: Mr. President. This change was necessitated by the Union contract. If we go longer than 60 days, we have to put these jobs out for bid and that's just what we're doing now but, we're going to be back in action here shortly.

PRESIDENT DENCZAK: All right. Good.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under miscellaneous business. Is there any miscellaneous business?...

MEMBER CASAR: Mr. President, I'd like to ask the Service Director a question please....

PRESIDENT DENCZAK: You may.

MEMBER CASAR: Service Director Concatto, I was driving Market Avenue in the area of construction, the sewer lines and the streetscapes and so forth on Sunday and I have a question. Why did we only do the sidewalk on the west side of Cleveland, on Market Avenue and not on the east side between 28th and 29th? After all, it is the gateway to the City. Why did, why wasn't the east side done, or is it going to be done? It should be because the sidewalks are in bad shape and why did we not, you know, do the whole project?

SERVICE DIRECTOR CONCATTO: Mr. President. Member Casar, I apologize I cannot answer that question but it was raised today, this morning, and I have yet to get with the engineer. That was how the project was designed to go from Market Avenue on the west side. It goes all the way up to about 28th Street, 29th Street. I'm not sure why. There was a determination. It was done a couple years ago when this project was put in place. I don't know what made it stop where it did, at 25th Street. You know, the city ends at 28th, between 28th. and 29th. Why it did not extend, I cannot answer that but I will get back to you because it was posed twice by someone today.

MEMBER CASAR: Okay. The reason I said, I drove around the block and after I saw that I thought, gee, we missed the boat here. The construction equipment's all there. I think we should look into that and complete the job. Is that your ward, Joe?

MEMBER CARBENIA: Yes. I could.... Mr. President. On, on that, that was supposed to be the second part of that project. It was supposed to go from 26th to 28th and I don't know, changing Administrations, if that got lost in the shuffle, but, I mean, that's why we're asking about it.

SERVICE DIRECTOR CONCATTO: Mr. President. We are, Member Carbenia and Member Casar, we were reviewing our five-year plan for engineering. Actually, both sides were supposed to be extended. Actually, the west side was to be extended all the way up to 30th Street. I think the east side was to be then extended up to, between 28th and 29th. I'll be glad to get back to you where that project is in our five-year planning, whether it was next year, I don't know, but I'll get back with you.

MEMBER CASAR:(INAUDIBLE)the job because it just, the new street lights and the new sidewalks and everything on one side and then the other side. That's where the residents live anyhow because on the other side, it's just the(INAUDIBLE)

PRESIDENT DENCZAK: Could we have a little decorum here? May I ask a question here about the sidewalks? Is it more expensive to provide the concrete sidewalks with brick inlays? Is that cheaper than the regular concrete sidewalk, or, why is the sidewalks...why do they contain brick inlays?

SERVICE DIRECTOR CONCATTO: Mr. President. The 20th....the Market Avenue Project is part of a streetscape project with the future is, is that that streetscape will go from, will be a corridor and go from at least 30th Street all the way downtown. As we continue to do this project, we extend this streetscape project. Is it more money, yes, but it also includes the lighting you see as part, as part of the streetscape with the brick inserted into the cement. That is the design that the city has incorporated with the streetscape downtown. It's a design that we're looking for the future, not only to extend from Market Avenue but also looking to extend it from Fulton Avenue and it will be extended from West Tusc in 2006 when we do the extended West Tusc Project from Schroyer Avenue to the tracks, to Cherry Avenue on East Tusc, that same type of streetscape will be incorporated into that. That is the design that the city has looked at for the future and yes, it is more money, but it is aesthetically pleasing and we think with the four doors of the city, that that's(INAUDIBLE)

PRESIDENT DENCZAK: Is there any other miscellaneous business?

MEMBER CASAR: Mr. President. Just.....

PRESIDENT DENCZAK: Member Zachary?

MEMBER ZACHARY: Mr. President. If I could just ask the Safety Director a question in reference to the cameras that we're looking to install in the 2nd Ward. How many cameras are you looking at because when we originally talked about this, there were some locations in the 4th Ward that we had discussed putting cameras up as well, and they still would like to have the cameras there, the neighbors would. Also, I have another question for the Service Director. So, are we just looking at this one location right now and is this going to be extended? How many cameras are we purchasing?

SAFETY DIRECTOR HUNT: Mr. President. At this time we are putting in a requisition for 4 cameras.

MEMBER ZACHARY: And where will they be?

SAFETY DIRECTOR HUNT: They will be in high crime zone and my plan is to ask the Councilmembers for their ideas for each one of the wards and then we'll take a look at those.

MEMBER ZACHARY: Okay. Thank you. And if I could ask the Service Director. I had talked to you, I believe, a little over a week ago in reference to Tusc and Belden. They did come and do Penn and Belden, as far as the street was down to the bricks, and you said there was an issue with the Tusc and Belden intersection as to why it could not be done. Did we find out why not?

SERVICE DIRECTOR CONCATTO: Mr. President. Member Zachary. Yes, but I can't remember what the answer is. Can I call you back? (*LAUGHTER*) We did look at that, I know; one of the issues is the trucks and the other issue was, is that we wanted to put the hot blacktop down there, not cold mix because it would come up. Can I get back with you on that?

MEMBER ZACHARY: Yes you can, and perhaps someone can explain to me how it is that we're able to re-pave the parade route or part of it every year but there are certain streets in the City of Canton that are in dire need of repair but have not been touched for years (AUDIENCE APPLAUSE) that can't get re-paved.

SAFETY DIRECTOR HUNT: Councilmember Zachary. In my former life in the Law Department, one thing I did was handle claims, and one claim particularly I remember had to do with a young lady who was in a marching band on the parade route and whose foot got caught in a, in a depression on the roadway surface so, every year, the superintendent from the street department walks the route and we are very careful to make sure that that route is in good shape, whether paving or anything else, because we have a lot of individuals with the balloons and everything else, walking that route and a lot times they are looking at things other than where they're walking. So, we pay lot of attention to that campaign route.

MEMBER ZACHARY: Well, I certainly do understand the safety concern, but I pretty much lost a tire going down Tusc the other day and I'm pretty sure if I filed a claim with the city, they'd turn it down. So, I, it needs to be done soon.

SERVICE DIRECTOR CONCATTO: Mr. President. I know people view us blacktopping the parade route but let us not forget that these are main corridors in the City of Canton, well traveled, probably more than any other street in the City of Canton, that being Cleveland Avenue, and I know that there are some streets in Member Zachary's Ward, specifically Sherrick Road, and we talked again with, with, I talked again with Kevin today about Sherrick Road and that is now in the engineer's office because in order for us to really do Sherrick right, we are going to have to completely tear up the whole road and put in a new base, because there is problems there and the Mayor has talked to me again this morning about Sherrick Road. We have it in the engineer's department right now for design. There are other streets that we're well aware of that comes to our attention consistently. McKinley Avenue, the ripple effect on McKinley Avenue. The ripple effect on 6th Street. All of these projects are projects that we have blacktopped. We continually mill and fill, we say we tear it up and re-fill it without doing the base. We think that McKinley Avenue possibly could be old tracks from years ago that are buried under there. The same with 6th Street, the trolley tracks, and in order for us to really develop and do something with McKinley Avenue, another main corridor, well-traveled, that needs to be taken care of, that is going to be a project that is going to have to go through private, get Federal Grant money because it is a project that's probably going to cost us well into the mill....a million dollars for those projects, which is what we did just for paving this year, so, it's not that we're ignoring them, it's that they are a high-priced item. I'm not talking about East Tusc and Belden, that's a different issue, but Sherrick Road, the McKinley Avenues and the 6th Streets are high-priced items that need to go on a schedule and we are looking to develop the cost for those and get them into Grant Money opportunities.

MEMBER ZACHARY: I do appreciate the information and just, and I'm gonna be quiet after this, just, let's keep in mind that heading east on Tusc is also a main corridor into our City and while they're planning streetscape projects, and I believe I mentioned this too, a few months ago, I'd like to see that streetscape project extended down Tusc because it is also a main artery into and out of the city. Thank you.

PRESIDENT DENCZAK: Member Diamond, as my Councilperson, would you see if you could arrange for the parade to go up 38th Street? (AUDIENCE LAUGHTER) Thirty-eighth Street is a main corridor of traffic since ODOT has everything screwed up on the expressway, so, I think you should take a look at re-paving that.

MEMBER DIAMOND: Would you be the Grand Marshall if I got the parade to go up your street?

PRESIDENT DENCZAK: Not only that but I'll offer iced tea on the route. Is there any other Miscellaneous

Business?

MEMBER DOUGHERTY: Mr. President. Just for the benefit of the people in the audience, we were passing out earlier, to the kids, Canton City flag pins. We have some up here if anybody else would want one before they left, so I just wanted to let you know.

MEMBER CARBENIA: Mr. President. I would like to also tell Mr., our Safety Director, remember who came to you first with those cameras and went out and looked at the cameras and it was agreed that it would go to an area that I had talked about, which I won't say, but it does cover a couple of wards together.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?

MEMBER WEST: Mr. President. Yes. First I'd like to thank the Safety Director, the Mayor and all of her Administration, Bill Allen, Joe Concatto, for coming out to the O'Jays Homecoming Weekend Celebration. It was a very successful event and we were very pleased with the outcome. There was over 5,000 people that came We also had a parade come down Mahoning Road and I think I'm going to have it out to, to honor them. extended onto McKinley Road just for the same purpose. But, the second thing I wanted to also piggyback on, and I spoke this to Safety Director, in terms of those security cameras. It is very important and very vital that we start to, to get those, not only are you hearing it from Mr. Dyer, there are other people also that are saying, asking for the same type of thing. I talked to you guys about my cars getting broke into several times. Actually, Well, now my wife's car got broken into last week, so that makes six. So, that's what it's, that's what we're looking for in those cameras for us, so once you start putting those out there, it is, it's generating safety in our neighborhood and people feel a sense of security knowing full well that when the police, when the crime is going on, and, when anything is going on negatively, then, the individuals call the cops, the cops come out, the perpetrator's gone. So that camera, we're hoping that will capture that, so that it also aides the police officer in finding and tracking down that criminal. That's why I think you keep hearing the cameras is because when people do call the cops, they call the cops, they call the cops, the cops come out, they say there's nothing that they can do because they're not there. There's nothing that they seen, but I think that's why we want these cameras out there so that they can see the actual crime taking place.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded to adjourn. Roll call please.
