PRESIDENT DENCZAK: Ordinance #16 is adopted. #16 ADOPTED AS ORDINANCE NO. 206/2005

ANNOUNCEMENT OF COMMITTEE MEETINGS

PRESIDENT DENCZAK: Announcement of committee meetings, please.

MEMBER HAWK: Mr. President, Finance will meet Monday, October 17th at 6:15. In addition, there will be a Finance Committee meeting October 6th at 8:45 A.M. in the Council Caucus Room. We will be discussing the information we received with Mr. Allen on city cars.

MEMBER DOUGHERTY: Mr. President, Public Property Capital Improvement will also meet the 17th at 6:15.

MEMBER BABCOCK: Mr. President, Public Safety & Thoroughfares will also meet that evening.

MEMBER BERNABEI: The Judiciary will meet at the same time on October 17th.

MEMBER GRIFFIN: Mr. President, Environmental & Public Utilities will meet at 6:15 also.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks, Open Forum. We have five speakers signed up this evening. The first speaker is Mantle Smith.

MS. SMITH: My name is Mantle Smith, and Your Honor...

PRESIDENT DENCZAK: State your residence.

MS. SMITH: My name is Mantle Smith.

PRESIDENT DENCZAK: State your address.

MS. SMITH: 220 Monroe SE, sir.

PRESIDENT DENCZAK: Go ahead.

MS. SMITH: This is an impromptu thing that I am bringing to you, the Council. And especially to the Fourth Ward. It is excessively noisy all day and every day and I am a senior and don't want to go into an apartment.

And the school buses are letting kids off in our area that don't live in the area and we're hearing things everyday, we're tired of it. Boys showing up at the bus stop. When you go to the bus stop, there's a bunch of boys every time you go. This is unnecessary. God didn't give me a son and I don't need one, especially today. To beexcessive noise, playing basketball at night on the street, and Mr. Snow has donated that part of Hartford for those kids to go play basketball. They should be over there. I called the cops, yes I called them, and the first time I let it go because I am getting senile 'cause I'm tired of this mess. And then the cops knocked at my house at twelve o'clock at night saying I called. I did not call, and they went to a house next door and I overheard the voice saying he saw somebody, I don't know what was going on. I just wish they would leave me alone. I'm gonna get grey headed, but my parents weren't grey headed. They left this earth at 57 and 56 years old and they weren't grey headed. And my one aunt lived to be 92 and she just got grey in her 80's. Several residents, including me, are complaining about Kelly Zachary not returning calls. And if she's our Council woman and we got off our butts and went to the polls and voted for her, she should give us enough respect to call back. And, the richer people are splitting our neighborhood. We had a Concerned Citizens over there. There's only two or three people over there, and I think this is all unnecessary. They are wealthy and we are not, and we weren't wealthy when we created that center, and it was created at the Hartford Library and now it's out there in the estates and we're still at that center. And they're asking the poor for \$100.00 which I know they don't have. They should give a fish dinner every weekend, and I'm not gonna do that. And I'm saying to you all these things because you may think that I'm wrong, you may think I'm a little addle minded or whatever, but I got news for you. If you live to get old, you're gonna get addled and beauty is gonna go away from you. I was beautiful at one time, and it does not matter. And when you're supposed to be a Council woman and you got another job, why be way down in Georgia somewhere? You know what I mean? To make money to keep a \$300,000 house. Where's the kids? I thank you.

PRESIDENT DENCZAK: The next speaker is Rod Bizami? Am I pronouncing that correct?...

MR. BIZAMI: My name is Rod Bizami. I live at 1107 11th Street NW. I am in Ward 1. Greg Hawk is our Councilman. Thank you. Greetings, Council President, Mayor, Council Board. When I moved to Canton, Tom Bernabei, who I know, was our Law Director. Kim Perez was my Councilman. We had Barb Dreussi as our neighborhood leader. Since then I've been listening patiently to the dogma promises of our political leaders in hope of a better neighborhood. That was over 15 years ago, and nothing has changed. The cancer still grows in our city, and now the mantra we hear from our leaders and other workers in the city is we do not want to violate the civil rights of the thugs and criminals in our neighborhood, but guess what? The civil rights of my neighbors and myself are being violated. We are unable to sit in our yards, and we feel unsafe in our homes. It is time to eliminate your ancient ways in bringing a nuisance ordinance like many of our sister cities have done. Just recently, the City of Shaker Heights has fined a landlord \$74,000 for the problems her tenants have caused in that neighborhood. Why a nuisance ordinance? A quote from Poor Richard's Almanac, "An once of prevention is worth a pound of cure." This would take pressure off our police department, code enforcement and health department and citizens and put responsibilities on each individual for their actions. And now I will leave you with one more quote. This one hangs in a Canton business establishment called Plant Et Art, "And every day when you awake, say to yourself what are you doing in the City of Canton." Thank you. (APPLAUSE)

PRESIDENT DENCZAK: The next speaker is Rich Cosgrove. Is that correct?...

MR. COSGROVE: Good evening. My name is Rich Cosgrove. I live at 2235 15th Street NE. Dave Dougherty's our Councilman. He does a wonderful job for us. I want to thank Dave. I also want to thank the Safety Director for coming out and walking with our neighborhood association. It was great. Things have already started to clean up, so it's been wonderful. Thank you for your time. The reason for me speaking this evening is our wonderful police department. Last evening I had made a phone call. There were some kids scuffling in the street, they got

into a fist fight and I went out on the porch to break it up, told them to move along and they did thankfully. They respected me. As they're walking down the street they're yelling at each other, they're going to get their guns from underneath their car seat, and the other kid's going to get his father's gun and his crossbow and all this stuff and they were taunting each other. So I called the police department at 7:25 last evening. At 8:00 the police finally drove past. Now when I was on the phone, and I have the names of the officers that I spoke with, when I was on the phone, I made it very clear where these children lived. At least one of them. And I asked them if they would stop and speak to that family. At 8:00 the police officers rolled down the street, they looked at the house, and continued on. So I called the police department back and inquired as to why. I got put on hold and they said okay, I'll give you to a supervisor. I then got another officer by the last name of Reese and told him my long winded story and only for him to say, I'm sorry, I'm not a supervisor, but when one returns from a call I can have him call you. So I mistook him for a supervisor and nonetheless I waited for a supervisor to call me, and I thought that it was a little ridiculous that a police call that I put in for guns was not an emergency, when a supervisor explained to me that I called at 7:25 in the evening, they didn't dispatch it until 7:46 and the police officers didn't get there until 8:00. Now I realize they put this in as a disturbance call, so I asked him then what would constitute an emergency and that would be if I saw a gun or if somebody got shot. So by then it was too late. I think that they should have been out there prior to, when I said there was a gun involved. There are kids on that street. They should have been there. And his answer to me was it was not an emergency. It went out as a disturbance. So, he's correct when he said they responded within a 15 minute time period, that was pretty good which I agree with if it was a disturbance, but it wasn't. It was an emergency. Nothing did come of it thankfully, but I just thought that I would come down here and say that I had spoken to him and I said, you know, I realize that I am not your boss and that you don't have to answer to me, but I said I would appreciate a call back and find out why those officers didn't get out of the car, and he said to me basically if he could get ahold of them by the end of their shift he would give me a call back. That was it. He did call me back however and he said the reason that they did that was because when I called all the information that I specified did not get written down. The gentleman that took my information said that they were standing in front of the address that I gave him, didn't say that they lived there. All the information I gave him, he wrote down about two sentences of the correct information. So the dispatch when it went out, the officers didn't get the correct information, they didn't stop...

PRESIDENT DENCZAK: Sir, your three minutes are up. Bring your remarks to a close.

MR. COSGROVE: That's fine. So I just thought that I would bring that to your attention. Thank you.

PRESIDENT DENCZAK: The next speaker is Chris Ketler.

MR. KETLER: Good evening, Council, Mr. President, Mayor. I'm gonna try to touch on two new subjects tonight. I won't be addressing the gang task force, or neighborhood task force. The first and foremost is...

PRESIDENT DENCZAK: State your name and address.

MR. KETLER: Oh, I'm sorry. 1302 9th St NW. I should know that by now.

PRESIDENT DENCZAK: And your name.

MR. KETLER: Chris Ketler.

PRESIDENT DENCZAK: Okay.

MR. KETLER: Thank you. First and foremost, vacant homes in the community. We do a neighborhood, Summit

Neighborhood Enrichment Team walk, but we get many parts of city government with us, specifically Code, Building Code and Health Department, and on our last walk-- we have some very active members of our community obviously, and on the last walk they decided that they were gonna walk away from us and they went back to their duties, and I think there's a sense of the feeling what's going on with the residents of the community. These are people that take time out of their own schedules, out of their own lives, to walk through, to make a difference, and try to see something happen. We have some homes though that issues are not being addressed, where continued code violations are there time and time again. And I hope that we're gonna see the Building Department and the Health Department come back next month and continue this next walk with us, but one of the things that I'd strongly like to see, and I hope that somebody tonight will approach us and assist us with this, is that we have homes that are in the process of being demolished, there's funds that are not there for the rest of the year, and we're heading into the winter months where I'm not real comfortable if these homes are going to be torn down if the moneys were available, and these homes are called by the police department smoke houses. This is where people go to smoke their marijuana and their crack. This is where the prostitutes go in. We have runaways that are hiding in these homes. We had a runaway that was pulled out just last week from a house that's two houses down from me. These houses need to be boarded up and secured. And I don't see why we can't take some step in order to facilitate that. Even if they're gonna be torn down. And I think that's important for the safety of the city and the community, the children, and also to kinda curb and eliminate some of the crime element that's going on in those places. The other thing that I wanted to address tonight, a good friend of mine, Rod, spoke, and I think it kinda alludes to a lot of things we're hearing from people. And that's a new ordinance that we'd like to encourage people to consider and look at. It's so readily available to find out there, and I'd be happy to share the information with any members of Council to look at this. I'm not a master at this, but it sure looks awfully interesting. And the great thing that I see going on is that Council's still doing their job even though we still are having our problems with the police department. And I think a lot of people realize that's where the problem is, the police department's not doing their job. And it's gonna be a long road either way before we get the patrolman out there to really be an officer of the community and assisting the people, getting them out of that car is incredibly difficult to do. Everybody will attest to it. But, we need to continue to put laws in place that when we get the law enforcement back to where it needs to be in this city, that we have laws that they can work with. And the ordinance that the City of Canton-- the City of Akron has passed, I'll go into a little bit in detail, just a little bit, is a progressive ordinance. I know we already have ordinances for nuisance. We have defined all sort of nuisances.

PRESIDENT DENCZAK: Sir, your three minutes are up. Bring your remarks to a close.

MR. KETLER: I'd like to close if I could. Thank you, sir. But this is a progression where if the police are summoned out to a residence over a period of time, then they are declared a nuisance and then they would issue a fine, and then if they were unable to meet the financial obligation, that then they would be held accountable in court. And this is readily available out there through both Kent and the City of Akron. And I think it's a very empowering tool that we could use again, so I would like to hope that we might look at that and consider that and be progressive and move forward as other cities in the area are. I thank you for your time. (*APPLAUSE*)

PRESIDENT DENCZAK: The final speaker is Deborah Harding.

MS. HARDING: Good evening. I'm Deborah Harding, 702 Clarendon Ave NW. I was here two weeks ago as you know. So far I haven't seen any more police protection in my neighborhood, but I see that Mr. Hunt and Mr. Hawk have been doing a few things to try to see the problems and from what it looks like, Mr. Hunt has got a large file on the problems in the neighborhood. Saturday evening I came home around 9:00. I came home to about 20 juveniles in the street on 7th again. There was a bike being thrown in the air, they were jumping on it, and then there was a fist fight which I have a tape of which you can't see very well cause my camera just doesn't

work really well in the dark, but you can tell that there was a fist fight going on. I did not call the police because every time I call it's like they come out and everybody disappears by the time they get there or whatever, so it's like I've kinda quit calling. Right now it seems like with the rental-- I have all rental properties on 7th Street. I have two empty houses that are up for sale, and I have a couple that has lived there for 50 years that are scared to call the police, and everybody else is the nuisance on that street so I'm not getting any cooperation with anyone else calling because I'm the only one seeing this stuff on 7th Street and the only one it's really affecting because they live on Clarendon and don't have to travel on 7th. If we could do away with some of these rental properties, or if we would make the landlords come and live in that house for an actual week and see actually what happens there. Maybe they would care a little bit more about our city. And we need to resolve the issues in the police department from what I've been reading in the paper, I don't know if they're true, but it seems to be there's a lot of fighting and carrying on with the policemen and everything and the Council people are, I don't know, there seems to be a lot of animosity. If we could get that cleared up, maybe the policemen would care enough to care about our city and to get it cleaned up. And, I just want to see more police protection on 7th Street. I do see more on Clarendon, but we need on 7th. That's where I have fights every Friday night. Every night, you know, there's always something going on. I have a tire mark on 7th Street for about 50 feet from somebody just, you know, playing games, you know. And there's little kids in that neighborhood, and we just really need to clean this neighborhood up. I mean like I said before, we have a brand new school going in and we really need to get it taken care of so, I thank you for your time and thank you for anything you're doing. (APPLAUSE)

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're under miscellaneous business now. Is there any miscellaneous business?...

MEMBER DIAMOND: Mr. President, I have a question for the Mayor or the Safety Director. What's our authorized strength for the police department, and how many officers do we currently have?

SAFETY DIRECTOR HUNT: Mr. President, we presently have 165 officers. Our authorized strength is, I believe it's 185... Our authorized strength is 185.

MEMBER DIAMOND: Okay. I understand the frustration of the people in the audience. We're doing a job now. The police department's doing a job with 20 less officers than it had before, so they are spread thin. I have, as I spoke with you earlier, my zone does not experience-- or my ward does not experience many of the problems that the people are speaking about this evening. It's my understanding, and I will verify that with a review of the log sheets as well as riding around with an officer in Zone 6, that my officer is outside of my ward more than he or she is inside. I certainly understand if there is ever an emergency when officers are needed that they should be pulled out of a ward, but when it becomes the rule as opposed to the exception, which it has become in my ward, I don't feel that my constituents are receiving the police protection that they should be. I don't blame that on the police officers. The officers go where they're dispatched, and I know we have a lot of problems throughout the City, but I think every resident of the City deserves adequate police protection, and I would respectfully request that this Administration hire more officers. We're down 20 right now. As of January, we are going to have several retirements due to the DROP program, and I don't anticipate our crime improving, so I think that everybody in the city deserves police protection, and I'm certainly here to fight for the residents in my ward. They pay taxes just like everyone else. They're responsible homeowners, the majority, and just because our ward is relatively safe does not mean that they should go without police coverage. I had one business broken into three times last week. Once people know that there's not a police car there, then crime will increase. So I am asking that the Zone 6 car remain in Zone 6. Thank you.

MAYOR CREIGHTON: Mr. President, just a reply. We are very cognizant that we need more police officers and the test, the Civil Service test, has been scheduled for November the 30th. That is the first step in the process and I'm pleased that we've been able to go that far because we're starting to see some relief in our finances. So the good news is that anybody who wants to take the police test, November the 30th.

MEMBER HART: Mr. President. Yes, this Saturday afternoon I attended the Mary Church Terrell Club luncheon and I just wanted to thank Member Thomas West for his participation in that they had an all male model revue and I would really like to congratulate Tom for being voted the most outstanding male model of the year. He did an excellent job. (*LAUGHTER AND APPLAUSE*)

PRESIDENT DENCZAK: Member West, would you care to model for us? (LAUGHTER)

MEMBER WEST: Mr. President, Mr. Hart is just jealous 'cause he wanted the suit that I had on. (LAUGHTER)

MEMBER BERNABEI: Mr. President, this is to the Chief of Staff or other member of the Administration. In conjunction with Member Hawk's announcement of a committee meeting to discuss the take home city vehicle issue, do we have -- and to better understand the need for this -- do we have any records of any nature which document the individual use of these cars on a daily or some other basis? And if we do have such records across all departments, can you provide those to us?

CHIEF OF STAFF ALLEN: Mr. President. Councilman Bernabei, I assume you mean what the personal use, the potential personal use of the vehicles are?

MEMBER BERNABEI: Well, my question is directed-- you know, we've received general responses from the Fire Chief, the Police Chief, and, you know, Water and Sanitation indicating general reasons why they are needed, and of course I understand when we cite safety and other concerns, but my question would be often, for example, does the Chief or does the Major or do any of the Captains in the Police Department actually utilize their vehicles, these vehicles, to make, you know, runs into the city or to other sites, and the same is true with the Fire Department and the same would be true with the other departments. Do we have records that document this use?

CHIEF OF STAFF ALLEN: I would tell you I'm doing an individual survey with each one of those 31 people that have vehicles and having them respond to questions like that, and I will have that information for the Finance Committee meeting on Thursday. The only place I haven't been able to get to is the Police Department at this point because the Chief was out of town last week and we intend to get with the Chief hopefully tomorrow and discuss that with the Police Department, but I am gathering that information. I don't know what kind of records in the past—there have been, but I am gathering and having them respond to questions as to how they're using those cars both on a--- during the day type situation and what their needs are to respond to something after hours, after an eight to five day. So I should have that all summarized for our meeting on Thursday.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER ZACHARY: Mr. President, I just want to thank the Mayor for proclaiming October 6th Seniors in Motion Day. It is a day where the Association for Public Transportation has designated nationwide for seniors to ride public transportation free of charge throughout the country, and she was the first to step up and since that time we've had the Mayor from Alliance as well as the Mayor from Massillon proclaim October 6th Seniors in Motion Day. So if you're 55 or older, you can take any of the fixed routes on SARTA free of charge all day that day, and it's an effort to get seniors out of the house.

PRESIDENT DENCZAK: Any other Miscellaneous Business?...

MEMBER WEST: Mr. President, you also qualify for that I believe. (LAUGHTER) I had to.

MEMBER CASAR: Mr. President, move we adjourn; seconded.

PRESIDENT DENCZAK: You weren't recognized yet. I got to figure out how old I am here. Member Casar, now make your motion.

MEMBER CASAR: Move to adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn. Roll call please.
